## **INDEPENDENT AUDITOR'S REPORT**

### **Opinion**

**1. DESCRIPTION OF THE PLAN**

The following description of the F.M. Kuzmeskus, Inc. 401(k) Plan (“The Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

On November 16, 2022 the Plan was merged into the Beacon Mobility Transportation Employee Retirement Plan (“Beacon”). All plan assets were transferred to the Beacon plan on December 30, 2022.

General

The Plan is a defined contribution plan adopted on January 1, 1997, covering all employees of the Company who have one year of service and are age twenty-one and older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year employees may make pretax contributions, as defined in the Plan, up to the maximum permitted by law. The Company contributes 100% of the first six percent of the employees’ pretax annual compensation that a participant contributes to the Plan. The Company may also contribute additional amounts at the discretion of the Board of Directors.

The Plan also provides the participants who are age 50 or older by the end of the calendar year and who are making deferral contributions to make catch-up contributions as permitted by the IRS.

Additionally, the Plan provides for rollover contributions from eligible rollover distributions that participants receive from prior employer’s eligible retirement plan.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company contribution and (b) plan earnings (losses), and charged with an allocation of administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based upon years of continuous service. A participant is 100% vested after six years of credited service.

Forfeitures

If an employee terminates employment, the nonvested portion of contributions are treated as forfeitures and are retained by the Plan and will first be used to pay expenses and then any remaining amounts will be used to reduce future Company contributions. For the years ended December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0 and \$4,985, respectively.

Investment Options

Upon enrollment in the Plan, each participant may direct their contributions into several investment options provided by the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 6.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On separation of service due to voluntary or involuntary termination, death, disability or retirement, a participant is entitled to receive a lump sum amount equal to the vested portion of the participant's account.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Date of Management Review

Subsequent events were evaluated through January 26, 2024, which is the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that effect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statement of the plan are prepared on the accrual basis of accounting and are prepared in conformity with U.S. generally accepted accounting principles ("GAAP") as promulgated by the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC").

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2022 and 2021, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

All expenses of maintaining the Plan are paid by the Company.

**3. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 1 or Level 3 inputs were available to the Plan.

Level 2 Fair Value Measurements

The annuities are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate, and mutual funds. The net assets value of the annuities are based on the market value of its underlying investments, but they are not publicly quoted in an active market.

**4. RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of annuities managed by Great-West Financial, which are managed through Empower Retirement, the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**5. ADMINISTRATIVE EXPENSES**

Plan administrative expenses consisted of services and assert charges of approximately \$600 for both the years ended 2022 and 2021, respectively. Remaining operating and administrative expenses were paid by the Plan sponsor.

**6. PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective December 30, 2022, the Plan has been terminated. Under the terms of the Plan, all participants were fully vested in their contributions and the actual earnings thereon. The Plan participants have received a distribution from the Plan equal to their vested account balance, and hence, all Plan assets have been distributed as of the Plan's last day, December 30, 2022.

**7. TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by letter dated March 31, 2008, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified as tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
