Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform the audits of the financial statements of Sanford Health 403(b) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 5, 2024 (in liquidation) and December 31, 2023 (in liquidation), and the related statement of changes in net assets available for benefits for the period ended April 5, 2024, (in liquidation) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of April 5, 2024 and December 31, 2023, and for the period ended April 5, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 and 8 to the financial statements, the Sanford Health Board of Trustees Plan approved a plan of liquidation on March 29, 2023, and management determined liquidation is imminent. The Plan termination was effective April 30, 2023. As a result, the Plan changed its basis of accounting from the ongoing basis of accounting to the liquidation basis of accounting used in presenting the 2023 and 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Note 1 - Description of Plan

The following brief description of the Sanford Health 403(b) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering eligible employees of Sanford Health (the System) including its controlled organizations who are employed by the System as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Pension Committee determined the appropriateness of the Plan's investment offerings and monitored investment performance.

By April 5, 2024, all of the Plan's assets were distributed. The 2024 period will be considered the final 5500 filing year.

Eligibility

Employees were eligible to participate in the Plan immediately upon hire and may have continued participation until they became eligible to participate in any 401(k) plan of the System. Once the eligibility requirements of any 401(k) plan of the System were met, they were no longer considered an eligible employee. Any employee employed by FM Ambulance Service, Inc. was not an eligible employee.

Entry Date

Employees entered the Plan immediately following when the eligibility requirements were met.

Contributions

Each year, participants may have contributed an amount up to 100% of their pretax annual compensation, as defined in the Plan. Contributions were subject to certain Internal Revenue Code (IRC) limitations. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan allowed participants to designate contributions as Roth contributions. Participants may have also contributed amounts representing distributions from other qualified plans (rollover).

Participant Accounts

Each participant's account was credited with the participant's contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that was paid by the Plan. Allocations were based on participant's compensation, account balances, or specific transactions, as defined by the Plan document. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Investment Options

Upon enrollment to the Plan, a participant may have directed deferrals in any of the funds offered by the Plan. Participants could change their investment options daily.

Vesting

Participants were vested immediately in their contributions, plus actual earnings thereon.

Payment of Benefits

Participants may have elected to receive either a lump-sum amount equal to the value of their vested interest, annuities, or annual installments as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated employee with a balance of less than \$1,000 may have been automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 could still be automatically paid out if their balance was rolled into a qualified Individual Retirement Account. Distributions may have been made at the participant's election prior to termination upon attainment of age 59½, hardship, or the birth or adoption of child, as defined in the Plan document.

Plan Termination

The System had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. As further discussed in Note 8, the System elected to terminate the Plan effective April 30, 2023. The Plan made all final distribution payments in 2024.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan as of April 5, 2024 and December 31, 2023 and for the period ended April 5, 2024, were prepared under the liquidation basis of accounting.

Excluded Contracts and Accounts

The Plan Administrator had elected to exclude certain contracts and accounts from Plan assets in accordance with Department of Labor Field Assistance Bulletin 2009-02 due to the following:

- The contract of account was issued to a current or former employee before January 1, 2009;
- The employer ceased to have any obligation to make contributions (including employee salary reduction contributions), and, in fact, stopped making contributions to the contract or account before January 1, 2009;
- All the rights under the contract or account are legally enforceable against the insurer or custodian by the individual owner of the contract or account without any involvement by the employer; and
- The individual owner of the contract is fully vested in the contract or account.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation included the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payments of Benefits

Benefit payments to participants were recorded upon distribution.

Expenses

The Plan's expenses were paid by either the Plan or the Plan sponsor as provided in the Plan document. Expenses that were paid directly by the System were excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan were recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses were included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan sponsor has evaluated subsequent events through February 11, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 5, 2024 and December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Annuity contracts: The fair value of annuity contracts is measured using an income approach and discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

The Sanford Retirement Committee determined the Plan's valuation policies utilizing information provided by the investment advisors, custodians and other third parties.

Note 4 - Certified Information

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments from participants held at April 5, 2024 and December 31, 2023 and net appreciation in fair value of investments and interest and dividends for the year ended April 5, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal), Lincoln National Life Insurance Company (Lincoln), American United Life Insurance Company (AUL), and Equitable Life Insurance Company (EQ) (the custodians of the Plan).

Note 5 - Tax Status

The Plan used a pre-approved plan document sponsored by Principal Life Insurance Company, which received an advisory letter from the Internal Revenue Service (IRS), dated March 31, 2017, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments were managed by Principal, Lincoln, AUL, and EQ, the custodians, respectively, as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 7 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Plan Liquidation

On March 29, 2023, the Sanford Health's Board of Trustees approved a plan of liquidation for the Plan. The Plan termination was effective April 30, 2023, when the Plan sponsor announced the termination of the Plan and a formal plan to liquidate. Individuals could elect to take a distribution paid direct to them or in a direct rollover. If individuals had a balance of less than \$1,000 the funds were paid directly to that individual. If the individuals balance was greater than \$1,000 the funds were rolled directly to an individual retirement plan designated by the Plan Administrator. Plan funds were fully distributed by April 5, 2024. There were no liquidation costs and the adoption of the liquidation basis of accounting did not have a material effect on values of the Plan's assets.
