Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of National Auto Care 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 1, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through May 1, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of May 1, 2024 and December 31, 2023, and for the period from January 1, 2024 through May 1, 2024, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note A to the financial statements, the Plan merged with the APCO Holdings 401(k) Plan (the "APCO Plan") effective May 1, 2024. The Plan transferred control of its net assets to the APCO Plan and ceased operations on the effective date. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the National Auto Care 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a

material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A--DESCRIPTION OF PLAN

The following description of the National Auto Care 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan covering substantially all employees of National Auto Care Corp. (the "Employer" and the "Plan Administrator"). Eligibility requirements included a minimum age of eighteen years and a minimum service period of three months. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

On January 1, 2024, management approved an action to merge the Plan with the APCO Holdings 401(k) Plan ("the APCO Plan"), which is sponsored by an affiliate of the Employer. The effective date of the merger was May 1, 2024. In connection with the merger, the Employer became a participating employer in the APCO Plan effective January 1, 2024. The net assets of the Plan were transferred to the APCO Plan on May 1, 2024.

Contributions: The Plan provided for employee elective pre-tax and Roth contributions, not to exceed total compensation. Employees were automatically enrolled at a 3% deferral rate of pre-tax contributions upon becoming eligible to participate in the Plan, and they could elect to change or discontinue deferrals at any time. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Plan provided for a discretionary, matching contribution and non-elective employer profit-sharing contribution. The Employer matching contribution was 25% of the first \$10,000 of each participant's contributions to the Plan. The Employer matching contribution was paid annually in arrears to the Plan. No non-elective profit sharing contribution was made for the period from January 1, 2024 through May 1, 2024.

Participant Accounts: Each participant's account was credited with their contributions, their account's earnings or losses, the Employer's matching contributions, and the Employer discretionary profit sharing contribution, if any. All investments were participant directed. Participants could change their investment options daily.

Investments: Participants could allocate their contributions and employer contributions among a selection of pooled separate accounts and a guaranteed return account.

NOTES TO FINANCIAL STATEMENTS--Continued

NOTE A--DESCRIPTION OF PLAN--Continued

Vesting: Generally, participants were immediately vested in their contributions, employer matching contributions, and any earnings on these contributions. Certain participant accounts included employer matching contributions from a previous participating employer, Coffeen Management Company. These employer contributions vested on a graded 5-year schedule (20% each year). A participant became fully vested in these contributions in the event of death, disability, or normal retirement.

Forfeitures: Forfeited amounts could be used to pay administrative expenses of the Plan and to reduce future Employer contributions to the Plan.

Administration: The Plan was administered by the Employer. All funds in the Plan were held in trust by Massachusetts Fidelity Trust Company ("the Trustee"), an affiliate of Transamerica Financial Life Insurance Company ("TFLIC"). Collectively, these entities are "Transamerica". The Trustee held the Plan's assets and invested participants' account balances as directed by the participants.

Withdrawals: A participant could withdraw his vested account balance plus earnings thereon in the case of a financial hardship. Withdrawals were taxable in the year received by the participant and may be subject to a penalty tax. Additionally, after reaching the age of 59½, a participant could request an in-service distribution from vested accounts.

Payment of Benefits: Upon termination of service, a participant was eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$5,000 were automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) could elect to receive their vested account balances as a lump sum or installments. Active participants could also take in-service distributions from the Plan upon attainment of age 59½ or disability.

Participant Notes Receivable: Generally, participants could borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Participants could only have one loan outstanding at any given time. Loans were repaid through payroll deductions over periods of up to 60 months, except in circumstances when the loan proceeds were used to purchase the primary residence of the participant. The loans were secured by the balance in the participant's account and bear interest at a rate commensurate with market rates for similar loans.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan followed the Financial Accounting Standards Board Accounting Standards Codification as its sole source of authoritative guidance. The financial statements for the Plan are prepared using the accrual basis of accounting.

The Plan's investments were stated at fair value or contract value. The Plan's investment options included a fully benefit responsive investment contract which was carried at contract value as more fully described in Note D. All other investments were carried at fair value as more fully described in Note C. Investment securities, in general, were exposed to various risks, including credit, interest, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it was possible that changes in values of investment securities could occur and that such changes could materially affect the amount reported in the statements of net assets available for plan benefits.

Purchases and sales of securities were recorded on a trade-date basis (the date the order to buy or sell is executed). Realized gains and losses on the sale of investments were calculated based on the difference between the selling price and cost on an average cost basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as the change in unrealized gains/losses for securities held at the end of the year.

Contributions were recorded on the accrual basis, which recognizes participants' contributions and the related Employer matching contributions at the time the participants' contributions were withheld from their wages. Employer discretionary profit sharing contributions were recorded in the period recognized in the Employer's financial statements.

Benefits were recorded when paid with the exception of amounts refundable by the Plan to Participants for contributions made in excess of amounts allowed by the Internal Revenue Service. At May 1, 2024, and December 31, 2023, there were no such excess contributions refundable to Participants.

The Plan was responsible for the payment of administrative expenses. Certain administration and custodial expenses were paid by the Employer.

Loans to participants were reported separately from Plan investments as notes receivable. These loans were recorded at their unpaid balance.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affected the reported amounts of assets and liabilities, and the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Subsequent events have been evaluated through February 14, 2025, which is the date the financial statements were available to be issued. The Plan had no activity after the merger effective May 1, 2024.

NOTE C--FAIR VALUE MEASUREMENTS

Current accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs into valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts: Valued based on quoted market prices of the securities underlying the pooled separate accounts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at May 1, 2024 and December 31, 2023.

There were no Plan assets held at fair value at May 1, 2024. For the year ended December 31, 2023, all of the Plan's investments that are carried at fair value as presented in the statements of net assets available for benefits were categorized within level 2 of the fair value hierarchy.

NOTE D--FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan held a fully benefit-responsive traditional investment contract with Transamerica Financial Life Insurance Company ("TFLIC"). This contract was a fully benefit responsive traditional investment contract that was reported at contract value as of December 31, 2023. There were no Plan assets reported at contract value at May 1, 2024. Amounts deposited under this traditional group annuity contract were held within a stable value fund of TFLIC.

As described in Note B, because the guaranteed fixed annuity account was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by TFLIC, represents the accumulation of contributions, plus interest, less funds used to pay benefits and expenses. The contract value of the account was \$-0- and \$265,141 as of May 1, 2024 and December 31, 2023, respectively.

Participants could withdraw their balances at contract value without restriction or charge on account of any of the following events: death, disability, retirement, terminations of employment, hardship, loans, attainment of age 59½, the purchase of an annuity from TFLIC, or transfers to a non-competing fund. Benefit responsive withdrawals from this contract during any twelve-month period that were made on account of employer initiated events and in aggregate in excess of 15% of the contract balance at the beginning of such twelve-month period were subject to a withdrawal adjustment.

TFLIC would pay participant-elected withdrawals of all or a portion of the participant account that do not constitute benefit responsive withdrawals, to the extent permitted by the Plan and authorized by the contract holder, but such payments would be subject to a withdrawal adjustment with respect to the requested withdrawal amount. The repayment of principal and interest credited to participants was a financial obligation of TFLIC. Guarantees were based on the claims-paying ability of the issuer. As of May 1, 2024 and December 31, 2023, there were no reserves against contract value for credit risk of the contract issuer or otherwise.

The contract contained a minimum guaranteed interest rate, which would not be less than 1%. At the beginning of each calendar year, TFLIC determined the declared interest rate, which will be credited to all monies invested in the guaranteed separate account during such calendar year. In no event would the declared rate of interest be less than the contracts minimum guaranteed interest rates. As of December 31, 2023, the declared interest rate was 1.25% .

Certain events limited the Plan's ability to transact at contract value with TFLIC. Such events included the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. As disclosed in Note A, the Plan merged into the APCO Plan effective May 1, 2024. This event did not limit the Plan's ability to transact at contract value with TFLIC in order to liquidate the investment in connection with the merger.

NOTE E--TRANSACTIONS WITH PARTIES IN INTEREST

The Plan had an agreement with the Trustee to maintain the investments of the Plan. For the period from January 1, 2024 through May 1, 2024, contributions to the Plan of \$409,924 were deposited with the Trustee for investment, and participants of the Plan received distributions of \$1,396,131 from funds held by the Trustee. At May 1, 2024 and December 31, 2023 the Plan had \$-0- and \$11,621,211, respectively, of assets held by the Trustee.

NOTE F--TAX STATUS

The Plan was intended to satisfy the tax qualification requirements under Section 401 (a) of the Internal Revenue Code; therefore, the trust funds of the Plan were intended to be exempt from federal income taxes. The amended Plan has not requested a favorable determination letter from the IRS since the prototype on which the Plan is based has been determined to be qualified under Section 401 (a) of the Internal Revenue Code.

NOTE G--FORFEITED NON-VESTED ACCOUNTS

At May 1, 2024 and December 31, 2023, investments included forfeited accounts of \$-0- and \$29,620 respectively, in unused forfeitures, which were available to pay for administrative expenses or reduce future Employer contributions. During the period from January 1, 2024 through May 1, 2024, the forfeiture account was utilized to pay administrative expenses totaling \$23.

NOTE H--SUMMARY OF INFORMATION CERTIFIED BY PLAN TRUSTEE

The total value of the Plan's net assets available for benefits was \$-0- and \$11,621,211, at May 1, 2024 and December 31, 2023, respectively. With the exception of employer's contributions receivable and participant notes receivable, TFLIC (a qualified institution) has supplied the Plan Administrator with a certification as to the completeness and accuracy of all information presented in the accompanying statements of net assets available for benefits as of May 1, 2024 and December 31, 2023, and in the statement of changes in net assets available for benefits for the period from January 1, 2024 to May 1, 2024, in regards to investment activity.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

NOTE I--RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For the period from January 1, 2024 through May 1, 2024, there were no significant differences between the financial statements and Internal Revenue Service Form 5500.
