INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of
Maryland University of Integrative Health 403(b) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Maryland University of Integrative Health 403(b) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits (in liquidation) as of July 12, 2024 and December 31, 2023, and the related Statement of Changes in Net Assets Available for Benefits (in liquidation) for the period from January 1, 2024 to July 12, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of July 12, 2024 and December 31, 2023, and for the period January 1, 2024 to July 12, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As described in Note 1 to the financial statements, the plan sponsor entered into an Asset Purchase Agreement (Agreement), effective October 26, 2023, with Notre Dame of Maryland University, Inc (NDMU). As a result of the Agreement, NDMU acquired all assets of the University and assumed a portion of its liabilities. The plan sponsor executed a Plan Termination Authorization and Election effective February 1, 2024, and all assets were distributed from the Plan between February and July 12, 2024. As a result, the financial statements are presented on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTE 1 - PLAN TERMINATION

The plan sponsor entered into an Asset Purchase Agreement (Agreement), effective October 26, 2023, with NDMU. As a result of the Agreement, NDMU acquired all assets of the University and assumed a portion of its liabilities. Effective February 1, 2024, employees of the plan sponsor were hired by NDMU. The plan sponsor executed a Plan Termination Authorization and Election effective February 1, 2024 and an Automatic Rollover IRA Plan Sponsor Agreement with Empower Trust Company, LLC (Empower Trust) (Rollover Agreement) effective February 4, 2024. Participant account balances were paid out in accordance with participant distribution elections beginning in February 2024 through June 3, 2024 and all remaining assets of unresponsive or missing participants were rolled into individual retirement accounts with Empower Trust per the Rollover Agreement.

NOTE 2 - DESCRIPTION OF PLAN

The following description of the Maryland University of Integrative Health 403(b) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan of Maryland University of Integrative Health, Inc. and Private Practices of the Natural Care Center, LLC (collectively, University) and was established on January 1, 2009. The Plan is subject to the provisions of ERISA.

Eligibility - The Plan covers substantially all employees of the University, excluding leased employees and student employees. Employees may enter the Plan on the first day of the first regularly scheduled payroll period beginning on or after their hire date.

Contributions - Each year, participants may elect to make pre-tax deferral contributions of their eligible compensation (as defined), up to the maximum allowable contribution under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans permitted by the IRC, as defined.

The University may make Qualified Nonelective Contributions (QNECs), per IRS regulations. For 2024, the University's QNECs totaled \$0.

Participant Accounts - Each participant's account is credited with the participant's contributions, previous University contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Participants direct the investment of their contributions and previous University contributions into various registered investment companies (mutual funds) offered by the Plan. For those participants who do not make an investment selection, their contributions, and previous University contributions, are automatically invested in the Plan's default investment account.

Vesting - Participants are immediately vested in all contributions plus earnings thereon.

NOTE 2 - DESCRIPTION OF PLAN - CONTINUED

Notes Receivable from Participants - Participants, as defined, may borrow from eligible investments held in their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, bear interest at a rate based on commercially reasonable interest rates as determined by the plan administrator and can only exceed a repayment period of five years for the purchase of a principal residence. Borrower may take a loan from the Plan only once each plan year. Only one note may be outstanding at a time. Principal and interest is paid ratably through payroll deductions. The loan is not deemed payable upon termination; therefore, the participant may continue repayments after termination of employment, until plan termination. Upon plan termination, remaining loan balances are reported as taxable distributions to participants.

Payment of Benefits - Benefit payments may be in the form of lump sums and are payable upon termination of employment, upon incurring total and permanent disability, death or attainment of normal retirement age. The Plan shall make automatic distributions of vested account balances that are less than \$5,000 in accordance with plan provisions. Distributions from a participant's rollover account may be made at any time. Hardship withdrawals and in-service withdrawals at age 59½ are also permitted, subject to provisions defined in the plan document.

NOTE 3 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting - Due to the plan termination effective July 12, 2024, the Plan's financial statements as of July 12, 2024 and December 31, 2023, and for the period January 1, 2024 to July 12, 2024, have been prepared on the liquidation basis of accounting.

Investment Valuation and Income Recognition - Investments are reported at liquidation value which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's custodian and investment advisor. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses was recorded as of December 31, 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document.

Contributions - Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation.

NOTE 3 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the University. Expenses that are paid by the University are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment. An annual asset charge, fees related to the administration of notes receivable from participants and participant distributions, and investment advisor fees are charged directly to the participants' accounts and are included in administrative expenses. Revenue sharing income is deposited to the Plan's ERISA Budget Account to pay other plan expenses. The remaining balance in the ERISA Budget Account of \$13,563 was paid to NDMU to reduce final audit and administrative expenses of the Plan for the 2023 and 2024 plan years.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2023. There are no assets held as of July 12, 2024.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement. As of December 31, 2023, the Plan's assets at fair value were invested in registered investment companies and were classified as Level 1 within the fair value hierarchy.

NOTE 5 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements including investments and notes receivable from participants held at July 12, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and dividend income for the period January 1, 2024 to July 12, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust, a qualified institution.

NOTE 6 - TAX STATUS

The Plan has adopted the Maryland University of Integrative Health 403(b) Plan. The Plan is an individually designed plan designed to qualify under Section 403(b) of the IRC and has complied with IRS required amendments. The Plan has been amended since its inception. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Empower Retirement, LLC (Empower) provides certain administrative services to the Plan pursuant to the Administrative Services Agreement (the Empower Agreement) between the University and Empower. In conjunction with the Empower Agreement, plan participants pay Empower an annual asset charge and fees related to the administration of notes receivable from participants and participant distributions. In addition, Empower receives certain fees from mutual fund families or other investment option sponsors or their affiliates in exchange for providing administrative and other services. These fees reduce the amount of expenses that would otherwise be payable pursuant to the Empower Agreement.

Empower also receives compensation in the form of interest or similar income (float) on assets awaiting investment or pending distribution. Fees paid by the Plan to Empower amounted to \$12,627 for 2024.

Fees to be used to offset audit and third-party administrative fees were paid by the Plan during 2024 to NDMU and totaled \$13,563.

Fees paid by the Plan during 2024 to Coastal Pension Services for distribution fees totaled \$9,891.

Fees paid by the Plan during 2024 to Creative Planning LLC for investment advisory services totaled \$5,927.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through February 17, 2025, the date the financial statements were available to be issued.
