Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Capital Region Medical Center 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of April 30, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits in liquidation for the period January 1, 2024 to April 30, 2024, and the related notes to the financial statements.

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Plan Termination and Liquidation Basis of Accounting

As discussed in Note 2 to the financial statements, the governing body of the Plan decided to terminate the plan effective December 31, 2023, and management determined liquidation is imminent. As a result, the liquidation basis is used in presenting the financial statements. As of April 30, 2024, all assets of the Plan had been liquidated and the Plan ceased to exist. Our opinion is not modified in respect to this matter.

Supplemental Schedules Required by ERISA

The supplemental schedule of assets held at year end as of April 30, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Capital Region Medical Center 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions. The Plan was terminated effective December 31, 2023, and all assets of the Plan were fully distributed as of April 30, 2024. The description of the Plan below is qualified in its entirety by the termination of the Plan.

General: The Plan is a defined contribution plan covering employees of Capital Region Medical Center (the Hospital). The Plan was established January 1, 1995, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees who have completed two months of service are eligible to contribute to the Plan. Employees who have completed one year of service in which they have 1,000 or more hours of service are eligible for Hospital contributions.

Contributions: Participants may contribute a portion of pre-tax or post-tax annual compensation, as defined in the Plan, not to exceed maximum amounts specified by the Internal Revenue Service (IRS), in accordance with a participant salary deferral agreement. Participants who are at least 50 years of age may make an additional contribution to the Plan not to exceed \$7,500 in 2023, under certain conditions. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Hospital is required to make a safe harbor matching contribution equal to 100% of participant salary deferrals up to 3% of eligible compensation, plus 50% of participant salary deferrals exceeding 3% and up to 5% of eligible compensation. The Hospital made the required contributions, which totaled \$2,540,358 in 2023.

Additional profit sharing amounts may be contributed at the discretion of the Hospital's Board of Directors. Participants must be employed on the last day of the Plan year to receive an allocation. No discretionary profit sharing contribution was made in 2024 or 2023.

Participants direct the investment of contributions into various investment options offered by the Plan.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Hospital's contributions, (b) Plan earnings, and (c) the participant's rollover contributions from other qualified benefit plans, if any, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are automatically 100% vested in the portion of their accounts resulting from participant salary deferrals, rollovers, and employer safe harbor matching contributions. Participants vest in discretionary employer contributions at a rate of 25% after two years of service and in 25% increments each subsequent year with full vesting in employer discretionary contributions occurring after five years of service. A participant is considered to have one year of service for each one-year period in which he or she has worked 1,000 hours or more.

Participants become automatically 100% vested in employer discretionary contributions upon attaining age 62, death, or disability.

Forfeitures: If a participant's employment terminates prior to normal retirement, the unvested portion of his/her account balance is forfeited. Forfeitures of employer discretionary contributions are applied to pay plan administrative expenses or reduce the contributions of the Hospital. For the period January 1, 2024 to April 30, 2024 there was no forfeiture activity. For the year ended December 31, 2023, the Hospital's contributions were reduced by \$177,551 from forfeited nonvested accounts. At both April 30, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0.

Distribution of benefits: Upon termination of service, a participant or his/her beneficiary may receive benefit distributions as a single lump sum payment (required for vested balances less than \$1,000), which may be in the form of a cash payout or rolled over into another qualified pension plan. In addition, the Plan allows hardship and in-service distributions.

Administration: Reliance Trust Company (Reliance) serves as the Plan's trustee and ADP Retirement Services (ADP) serves as the Plan's third-party administrator. Reliance holds the Plan's assets and administers investment activity in accordance with an investment policy determined by the Hospital. ADP maintains the individual participant accounts and provides records of balances and transactions to the Plan administrator and participants. In addition, ADP provides professional and administrative services to the Plan. Certain administrative and record-keeping costs are being absorbed by the Hospital. The Hospital's Board of Directors is responsible for oversight of the Plan. The Plan's Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Hospital's Board of Directors.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: As discussed in Note 1, the Hospital's Board of Directors adopted a resolution to terminate the Plan effective December 31, 2023, subject to the provision set forth in ERISA. As a result, the financial statements of the Plan are prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

As of April 30, 2024, under the liquidation basis of accounting the Plan remeasured the expected earnings and expenses to be incurred in liquidation. As a result of the remeasurement, the Plan removed the previous year's liquidation estimates resulting in a decrease to net assets of \$1,096,433 for the period ended April 30, 2024.

Valuation of investments: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the declaration date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Investment securities of the Plan are exposed to various risks, such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions: Contributions from plan participants and the matching contributions from the Hospital are recorded in the year which the employee contributions are withheld from compensation.

Payment of benefits: Benefits are recorded when paid. Benefit checks not cashed after six months are voided against benefits paid to participants. The Plan holds these in a separate account in the participant accounting system so that the appropriate amounts can be paid in the future when the participant is located.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Hospital. No officer or employee receives compensation from the Plan for these services. Investment related expenses are included in net appreciation in fair value of investments.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent events: Events that have occurred subsequent to April 30, 2024, have been evaluated through February 12, 2025, which represents the date the Plan's financial statements were approved by management and, therefore, available to be issued.

3. TERMINATED PARTICIPANTS

Net assets available for benefits at April 30, 2024 and December 31, 2023, included \$0 and \$19,975,491, respectively, in vested benefits allocated to the accounts of individuals who, as of or prior to that date, had withdrawn from actively participating in the operations of the Plan, generally as a result of terminating employment. These amounts may be paid within the next year, at the request of the participant. These participants receive no further contributions but do receive allocations of investment income and Plan expenses.

4. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed ADP by a letter dated July 16, 2014, that the non-standardized prototype profit sharing plan as amended through April 2, 2012, is in a form acceptable under section 401 of the Internal Revenue Code (IRC). Effective November 1, 2015, the Hospital adopted this prototype plan as an amendment and restatement of its existing plan to comply with the Pension Protection Act of 2006 and other legal requirements. There were no significant changes to the Plan as a result of this amendment and restatement. Effective March 1, 2018, the Plan was amended to allow post-tax (Roth) deferral contributions. Effective January 1, 2020, the Plan was amended to add an automatic deferral provision and remove the age 21 eligibility requirement.

Effective January 1, 2021, the Plan was amended to reinstate safe harbor matching contributions, decrease the normal retirement age to age 62, and allow certain annuity distributions. The amendment also added recognition of prior service for acquired entities and merged the Central Missouri Cardiology PC 401(k) Profit Sharing Plan with the Plan effective January 1, 2021.

The Plan adopted a Cycle 3 Restatement effective July 1, 2022, as an amendment and restatement of the existing plan to bring the Plan into compliance with legislative and regulatory changes. There were no significant changes to plan provisions as a result of the restatement. The IRS has determined and informed ADP by a letter dated October 6, 2020, that this non-standardized pre-approved profit sharing plan as amended through December 31, 2018, is in a form acceptable under section 401 of the IRC.

The Hospital may rely on the opinion letters issued by the IRS for these pre-approved plans as evidence that the Plan is qualified under the applicable sections of the IRC. The Plan is relying on the opinion letters. Although the Plan has been amended since receiving the opinion letters, the Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. PLAN TERMINATION

The Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. As discussed in Note 2, the Plan was terminated effective December 31, 2023. Effective December 31, 2023, no additional contributions were made to the Plan and participants became 100% vested in their account balances. As a result of the plan termination, participants were permitted to take distributions of their account balances during 2024. All assets of the Plan were distributed by April 30, 2024.

6. CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, the Plan's trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments at fair value as shown in the statements of net assets available for benefits.
- Investment income as shown in the statement of changes in net assets available for benefits.
- Schedule of assets held at year end.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. FAIR VALUE OF INVESTMENTS

Plan investments are held in a trust and managed by the Reliance, the Plan's trustee, and are unsecured. All investments are participant-directed and held by parties-in-interest.

A fair value hierarchy is used that prioritizes the inputs to valuation techniques used to measure fair value of balances that are required or permitted to be measured at fair value for reporting in financial statements. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to the unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets recorded at fair value.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund on an active market, which is based on the underlying net asset value (NAV) of the shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of the units of a bank or trust company collective trust held by the Plan at year-end. Stable value collective trusts are composed primarily of fully benefit-responsive investment contracts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of its underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments. There are generally no restrictions as to the redemption of these investments nor does the Plan have any contractual obligations to further invest in any of these funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
