## Independent Auditor's Report

To the Board of Trustees  
**Lashbrook Jewelry Designs 401(k) Plan**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements***

We have performed an audit of the financial statements of **Lashbrook Jewelry Designs 401(k) Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 31, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the year ended January 31, 2024 (in liquidation), and the related notes to the financial statements (financial statements).

Management has obtained a certification from a qualified institution as of January 31, 2024 and December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

### ***Basis for Opinion on the Financial Statements***

As a result, the Plan is using the liquidation basis of accounting in presenting the financial statements as of January 31, 2024. Our opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The Lashbrook Jewelry Designs 401(k) Plan's (the "Plan") financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") using the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Revenue Recognition

The Plan's investments are stated at fair value. Pooled separate accounts are stated at unit value, which is based on the current fair values of the underlying assets of the funds. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividend income is accrued on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

In general, these securities are exposed to various risks and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits.

### Unit Values

Individual participant accounts for pooled separate accounts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

### Contributions Receivable and Allowance for Doubtful Accounts

Employee contributions that are withheld through payroll deductions and have not been credited to the participant accounts as of the end of the fiscal year are recorded as contributions receivable. There were no amounts receivable as of January 31, 2024 and December 31, 2023. Accordingly, an allowance for doubtful accounts is not considered necessary and is not provided as of January 31, 2024 and December 31, 2023.

### Benefit Payments

Benefit payments to participants are recorded upon distribution.

#### **Forfeitures**

The non-vested portion of employer contributions and earnings thereon forfeited by participants are used to reduce future employer contributions or to pay plan expenses. As of the years ended January 31, 2024 and 2023, there were **\$0** and \$20,716 of forfeitures available for use by the Plan. Forfeitures used by the Plan were **\$0** during the year ended January 31, 2024.

#### **Administrative Expenses**

Expenses related to investment advisory services, management fees, and maintenance of participant accounts are paid by the Plan. Expenses related to Plan administration are paid directly by the Company and are excluded from these financial statements. Plan expenses for the year ended January 31, 2024 were **\$168**. Expenses are presented with the net appreciation (depreciation) of investments line item of the Statement of Changes in Net Assets Available for Benefits.

### 2. **DESCRIPTION OF THE PLAN**

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering eligible employees of Lashbrook Jewelry Designs (the "Company" or the "Employer"). The Plan excludes union, nonresident alien, and leased employees from participation in the Plan. Employees are eligible to participate in the Plan once they have completed six months of service and are twenty one years of age or older. Eligible employees are able to participate in the plan on the first day of the month following the date the employee meets the eligibility requirements. If the employee becomes eligible on the first day of the month, the employee begins participation in the Plan on that date. The Plan is designed to qualify under sections 401(a) and 401(k) of the Internal Revenue Code (the "Code") as amended and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The plan administrator is responsible for oversight of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan has arranged for Voya Retirement Insurance and Annuity Company (the "Custodian") to serve as custodian and provide record keeping services to the Plan.

## 2. DESCRIPTION OF THE PLAN (Continued)

### Contributions

Each year, participants may contribute any amount of pretax annual compensation, as defined in the Plan, subject to the maximum amount allowable by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan allows for a discretionary matching contribution up to 4% of participant compensation deferred as an elective deferral. During the year ended January 31, 2024, the Company contributed \$0 in matching contributions.

### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and allocations of Plan earnings or losses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in employee contributions, rollover contributions, and actual earnings thereon. Participants are vested in the employer contribution portion of their accounts based on years of continuing service. Prior to January 1, 2021 a participant vests 20% per year and becomes 100% vested after five years of service. Effective January 1, 2021, a participant vests 0% the first year and becomes 100% vested after two years of service.

### Investment Options

Upon enrollment in the Plan, a participant may direct their contributions in any of the investments offered by the Plan. Unless limited by restrictions imposed by individual investment options and subject to redemption fees, participants may change their investment options on a daily basis.

### Benefit Payments

Participants may receive the vested portion of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Under certain circumstances, including financial hardship, participants may withdraw the vested portion of their account balance. Benefit payments are made in a lump sum distribution or rollover contributions to another plan as defined in the plan document.

### Plan Termination

As of January 31, 2024, the Plan was merged into a pooled employer plan.

### 3. **TAX STATUS**

The Plan adopted a prototype plan document which obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code"). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 31, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan's form 5500 remains open to examination for three years from the date filed.

### 4. **UNAUDITED INFORMATION PREPARED AND CERTIFIED BY THE PLAN TRUSTEE**

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedules. The January 31, 2024 and December 31, 2023 Statement of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Voya Retirement Insurance and Annuity Company, the trustee. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments:

- Investments at fair value
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

### 5. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value methods used by the Plan may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. **EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Company contributions and investments were held and managed by Voya Retirement Insurance and Annuity Company, the Plan's custodian, which invests cash received, interest and dividend income, and makes distributions to participants. Therefore, these transactions are considered exempt party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses paid to the Plan's third party administrator qualify as exempt party-in-interest transactions and totaled \$0 for the year ended January 31, 2024. All other administrative expenses, including audit fees, are paid by the Company, a party-in-interest, for the year ended January 31, 2024.

## 7. **NONEXEMPT TRANSACTIONS**

During the years ended December 31, 2022 and 2021, it was noted for certain pay-periods there was a delay in remitting employee contributions to the plan. This resulted in \$90 and \$6,736, respectively, of delinquent participant contributions. Management contributed lost earnings to the Plan on the delinquent contributions in November 2024.

## 8. **MANAGEMENT'S EVALUATION OF SUBSEQUENT EVENTS**

Subsequent events have been considered by management through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

As of January 31, 2024, the Plan was merged into a pooled employer plan.
