**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Lisle Corporation Employees' Profit Sharing Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Lisle Corporation Employees' Profit Sharing Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended October 31, 2024 and 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.



**(1) Description of Plan**

The following description of the Lisle Corporation (Company) Employees' Profit Sharing Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**(a) General:** The Plan is a defined contribution plan, covering employees of the Company who have one year of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective November 1, 1999 in conjunction with the change of trustee and custodian.

**(b) Contributions:** The Company is to make salary reduction contributions on behalf of each participant who has elected to reduce his or her compensation under a salary reduction agreement. The salary reduction contribution is not to exceed 50% of their total eligible compensation or limitations set by the Internal Revenue Service.

In addition to the salary reduction contributions, the Plan calls for the Company to make a non-elective contribution to the Plan equal to 3% of the participant's compensation. Additional discretionary Company contributions may be made up to limits allowable under the Internal Revenue Code. For both the Plan years ended October 31, 2024 and 2023, the Company contributed 15.0% of eligible employee compensation. Employees may elect to receive one-third of their discretionary contribution in cash.

**(c) Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**(d) Participant Notes Receivable:** Participants may borrow from their fund accounts a minimum of \$300 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant notes receivable fund. Loan terms range up to five years. The loans are secured by the balance in the participant's account and bear interest at fixed rates set by the plan administrator. The interest rates were between 3.25% and 8.5% for the years ended October 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are measured at their outstanding balance plus any accrued but unpaid interest.

**(e) Vesting and Benefits:** Participant accounts are all 100% vested. Upon termination, the trustee pays the amount of the participant's account to the participant in accordance with various options defined in the Plan.

**(2) Summary of Significant Accounting Policies**

**(a) Basis of Presentation:** The accompanying financial statements have been prepared on the accrual basis and present the net assets available for retirement benefits and changes in those net assets.

**(b) Payment of Benefits:** Benefits are recorded when paid.

- (c) Trust Funds Management:** Beginning with the year ended October 31, 2000, under the terms of the trust agreement, the trustee manages trust funds on behalf of the Plan. For the years ended October 31, 2024 and 2023, Vanguard Fiduciary Trust Company served as trustee for the Plan. The trustee has reported the investment and changes therein of the trust funds to the Plan for the years ended October 31, 2024 and 2023, respectively, as having been determined through the use of current values of all assets and liabilities of the trust funds.
- (d) Investment Valuation and Income Recognition:** The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of investments are recorded on a trade-date basis. Capital gain distributions are included in dividend income. The investments have an aggregate cost of \$42,804,710 and \$41,677,916 at October 31, 2024 and 2023, respectively.
- (e) Estimates:** The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting periods. Actual results may differ from those estimates.
- (f) Subsequent Events:** The Company has evaluated subsequent events through the report date, the date the financial statements were available to be issued, and it was determined that no events occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

**(3) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**(4) Transactions with Parties in Interest**

At October 31, 2024 and 2023, Plan assets as reported by the trustee of the trust fund included loans to participants totaling \$183,069 and \$177,506, respectively. In accordance with the Plan, such loans were secured by the respective participant's vested Plan interest.

The Plan provides that loans may be made to participants for the specific purpose of purchasing or constructing a home, tuition and other educational expenses, medical and dental expenses, and funeral expenses.

**(5) Related Party Transactions**

The Plan invests in shares of mutual funds managed by an affiliate of Vanguard Fiduciary Trust Company ("VFTC"). VFTC acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

**(6) Plan Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

**(7) Life Insurance Contracts**

The Plan previously allowed participants to elect to use a portion of the employer's annual contribution to purchase life insurance contracts. That option is no longer offered to participants. However, participants who have active policies continue to have the annual premiums paid from their account funds. Premiums, net of related dividends are shown under deductions in the Statements of Changes in Net Assets Available for Retirement Benefits. Related cash values are not included in the Statements of Net Assets Available for Retirement Benefits as the obligation to pay the benefits and related risks are that of the insurance company.

**(8) Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

All investments in the plan are held in mutual funds, which are stated at fair value based on the quoted market value of the shares held by the Plan at year-end, and are all considered Level 1.

The value of these investments was \$62,390,712 and \$49,572,447 for the years ended October 31, 2024 and 2023, respectively. There have been no changes in the methodologies used at October 31, 2024 and 2023.

**(9) Investments**

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by the trustee for the years ended October 31, 2024 and 2023.

Except for investment in insurance contracts, the Plan's investments are held in a trust fund administered by Vanguard Fiduciary Trust Company. During the Plan years ended October 31, 2024 and 2023, the Plan's investments appreciated in value by \$11,727,108 and \$1,796,297, respectively, as follows:

**(10) Tax Status**

The Plan obtained its latest determination letter in March 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Company believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan continues to qualify under Section 401(a) and the related trust continues to be tax-exempt as of October 31, 2024. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior to 2021.

**(11) SECURE Act 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriation Act of 2023, which included the SECURE Act 2.0 ("the Act"). The Act contains over 90 new retirement provisions, with varying effective dates through 2027. As the Act provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend in the Plan Document accordingly. There was no material impact to the Plan's 2024 or 2023 financial statements.
