Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of Sanders Brothers Construction Co., Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan 401(k) and profit-sharing plan covering employees of Sanders Brothers Construction Co., Inc., except for union and non-resident alien employees, who are at least age 18 and have worked 3 consecutive calendar months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Each year, participants may contribute a percentage or amount of their pretax or after-tax compensation, as defined by the Plan, not to exceed the annual limits as defined by the Internal Revenue Code. Participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. Participants may contribute amounts representing rollover distributions from other qualified plans. Participants direct the investment of their contributions into various investment options and participants may change their allocations among the various investment options at any time.

The employer has the discretion to make a year-end match and/or profit-sharing employer contribution each year. During fiscal year ended June 30, 2024, the employer match contribution is dollar for dollar up to 7% of the compensation. Total employer match contributions for the fiscal year ended June 30, 2024 was \$1,278,942. The profit-sharing contribution is based on the percentage of the employee compensation to total compensation. The contribution is provided and calculated at year end only. Total profit-sharing contribution for the fiscal year ended June 30, 2024 was \$507,759. The employee must be employed, except for normal retirement, death or disability, at the end of the year to receive the match and profit-sharing contributions.

Vesting - Plan participants are always 100% vested in rollover contributions, employee contributions, and any earnings thereon. Employer matching contributions are 100% vested after three (3) years of service and profit-sharing contributions and any earnings thereon will be vested in accordance with the following schedule:

Participant Accounts - Each participant's account is credited with the participant's contributions, Company discretionary contributions, rollover contributions and earnings, and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers money market funds, mutual funds and a common collective trust as investment options for participants.

Forfeitures - The plan permits forfeitures to be used to reduce future Company contributions, restore forfeitures, reallocate as company contributions, or pay Plan fees. During the year ended June 30, 2024, forfeitures in the amount of \$15,442 were added to the forfeiture account, the account earned \$1,882 and the employer offset contributions of \$0 to the plan. The balance of the forfeiture account as of June 30, 2024 was \$49,492. During the year ended June 30, 2023, forfeitures in the amount of \$47,688 were added to the forfeiture account, the account earned \$800 and the employer offset contributions of \$11,879 to the plan. The balance of the forfeiture account as of June 30, 2023 was \$32,168.

Payment of Benefits - Payment of benefits from a participant's account may be made only for the following reasons: termination of employment, financial hardship, retirement, in service at 59^{1/2}, death or disability. Upon occurrence of one of these events and upon election of the participant, the Plan will distribute to the participant 100% of the participant's vested account balance. A participant may receive a lump sum amount equal to the value to the participant's vested interest in his or her account. The Plan Sponsor may elect to distribute funds to terminated participants through the automatic mandatory involuntary cash-out provision, for any balances less than \$5,000 as an individual retirement account rollover and amounts less than \$1,000 directly to the participant.

Recordkeeping and Investment Expenses - The Plan's fees and expenses are paid either by the Plan or the Plan Sponsor as provided by the Plan document.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States.

Payment of Benefits - Benefits paid to participants are recorded when paid.

Use of Estimates - The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States requires that the Plan administrator make estimates and use assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates. The Plan administrator is not aware of any condition or event that is likely to severely affect its estimates in the near-term.

Investment, Valuation, and Income Recognition - The Plan's investments are stated at fair value. Investments are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation (depreciation) in fair market value of investments for such investments.

Subsequent Events - The Plan has evaluated subsequent events through the report date, the date the financial statements were available to be issued.

NOTE 3. INFORMATION PREPARED BY AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Matrix Trust Company, the custodian, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule. Accordingly, the custodian has certified the Plan's assets to completeness and accuracy of the common collective trust, mutual funds, money market funds, and cash for the statements of net assets available for benefits as of June 30, 2024 and 2023, the statement of changes in net assets available for benefits, the supplemental schedule of assets (held at end of year) as of June 30, 2024. The following is a summary of the investments from participants certified by the custodian as of June 30, 2024 and 2023.

NOTE 4. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at June 30, 2024 and 2023.

Money market funds: Valued at the reported amount on deposit held by the Plan at year end.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. Mutual funds are required to publish their daily NAV and transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Common collective trust: Net asset value (NAV) is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount differing from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a common trust fund, the investment adviser reserves the right to temporarily delay the withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(b) Withdrawals initiated by Plan participants are honored at any time without penalty. If the Plan sponsor were to initiate the withdrawal from the fund, a 12-month written notice of intent to withdraw assets from the fund would be required.

NOTE 5. INCOME TAX STATUS

The Plan has timely adopted a restated, via a non-standardized adoption agreement, pre-approved profit-sharing plan. The pre-approved profit-sharing plan has received an opinion letter from the IRS dated June 30, 2020, whereby the IRS stated that the pre-approved profit sharing plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). While the Plan cannot rely on the pre-approved's opinion letter, the Plan administrator believes that the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment instruments such as mutual funds and investment contracts. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility. Market risks include global events which could impact the value of investment securities, such as international conflict. Due to level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and such changes could materially affect the amounts reported in the financial statements.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

NOTE 8. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

For the years ended June 30, 2024 and 2023, certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements and investment related expenses are included in net appreciation of fair value of investments.

The Plan pays certain fees for the recordkeeper, South State Bank Retirement Services; and custodian, Matrix Trust Company. These transactions qualify as party-in-interest transactions.
