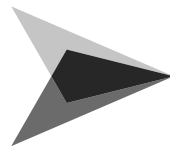

Note 1 - Description of Plan

The following description of the Weiler, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all employees of the Company who have six months of service, five hundred hours of service, and are age eighteen or older. Employees will become eligible for deferrals and matching and profit-sharing contributions when they meet the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Merger – During 2024, the Board of Directors of Weiler, Inc. approved the merger of this Plan into the Architect Pooled Employer Plan effective May 15, 2024. As a result, all investments were transferred from the Plan into the Pooled Employer Plan on that date.

Contributions - Each year, participants may contribute an amount not to exceed a specific dollar amount determined by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund and will increase by 1% each year until a maximum established by the administrator is met. The Company may make profit-sharing contributions at the discretion of the Company’s shareholders. The Company will match contributions up to 3% of each participant’s eligible income. The matching and profit-sharing contributions are invested into the same investment options offered by the Plan for the salary deferral.

Participant Accounts - Each participant’s account is credited with the participant’s contributions and Company discretionary matching contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contribution and profit-sharing portion of their accounts is based on a continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants - Plan loans will be available only if the participant meets one of the 401(k) Safe Harbor Hardship provisions described in the applicable federal Treasury regulations. Participants may borrow from their fund account to a maximum of the lesser of (a) \$50,000, reduced by the excess of the participant’s highest outstanding loan balance during the prior year over the participant’s current outstanding loan balance, and (b) 50% of their vested account balance. The maximum term of any loan is five years, unless the participant is using the loan to purchase a principal residence, and then the term can be up to 15 years.

Note 1 - Description of Plan (Continued)

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period not to exceed the life expectancy of the participant or survivor. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts - Forfeited accounts are used to reduce Company contributions, offset qualified nonelective and qualified matching contributions. There were \$13,963 and \$24,110 in forfeitures of nonvested accounts during the period ended May 15, 2024 and December 31, 2023, respectively. There were \$-0- and \$17,956 forfeitures used to reduce Company contributions for the period ended May 15, 2025 and the year ended December 31, 2023, respectively.

Note 2 - Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date (the exit price). The Plan's management determines the Plan's valuation policies utilizing information provided by the investment adviser, Empower Retirement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of May 15, 2024 and December 31, 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits - Benefits are recorded when paid.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participant contributions. The Plan distributes any excess contributions to the applicable participants prior to March 15 of the following year.

Note 2 - Summary of Accounting Policies (Continued)

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to each participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Date of Management Review - Management has evaluated subsequent events through February 7, 2025, the date that the financial statements were available to be issued.

Note 3 - Fair Value Measurement

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value, as of May 15, 2024 and December 31, 2023.

Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

Mutual funds: Valued at the net asset value (NAV) of units of the fund held by the Plan based on the fair value of the underlying investments of the fund. NAV is a readily determinable fair value and is the basis for current transactions.

Fixed annuities: The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

Note 4 - Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Note 6 - Party in Interest Transactions

Certain plan assets are held in investment options managed by Empower. Empower is the current custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions as of and for the period ended May 15, 2024 and as of the year ended December 31, 2023.

Note 7 - Information Certified by the Trustee

The following is a summary of the Plan's asset information as of and for the period ended May 15, 2024 and the year ended December 31, 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the custodian, Empower Retirement, LLC, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information, which appears throughout the financial statements and supplemental schedule, related to the following assets:

Note 8 - Plan Termination

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions. On April 15, 2024, the Plan's sponsor approved a resolution to merge the Plan into a new Pooled Employer Plan (PEP) named The Architect Retirement PEP, sponsored by Weiler Inc. As part of this merger, all plan assets were transferred from the existing Plan into the PEP on May 15, 2024.

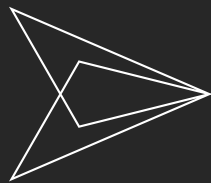
