Management, having determined it is permissible in the circumstances, has elected to have the audits of Interim, Incorporated 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Interim, Incorporated 403(b) Plan (the Plan) is for general information purposes only. Participants should refer to the Plan document for more complete information of the Plan's provisions.

General

The Plan is a defined contribution 403(b) plan that was established in 1987 and amended and restated effective July 1, 2021. The Plan is sponsored by Interim, Incorporated (the Organization), a California nonprofit corporation. The Plan was established to provide benefits to eligible employees as defined in the Plan document. The Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code (IRC) and the provisions of ERISA, as amended.

Eligibility

All employees are eligible to make an elective deferral contribution to the Plan. All employees must complete one year of service to be eligible to receive the employer matching and nonelective contribution. One year of service is defined as working at least 1,000 hours at the end of the 12-month period beginning on the date of hire. If the hour requirement is not met by the end of this period, then the year of service eligibility shifts to the next Plan year.

Contributions

Participants' contributions may not exceed certain dollar limits, as defined by the Plan, not to exceed the maximum allowed by Sections 415, 402(g) and 403(b) of the IRC. Participants who have attained age 50 before the end of the Plan fiscal year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to limitations under current income tax regulations.

Employer nonelective contributions and matching contributions are discretionary and are determined each year by the Organization's Board of Directors. To be eligible for the employer matching contribution, the employee must have attained one year of service. In addition, the employee must be employed on the last day of the Plan year and have worked 1,000 hours of service during the plan year in order to be eligible for the employer nonelective contribution. For the years ended June 30, 2024 and 2023, the Organization made a matching contribution equal to 100% of an eligible participant's contributions up to 3% of eligible compensation. For the years ended June 30, 2024 and 2023, the Organization made matching contributions of employee deferrals in the amounts of \$151,416 and \$263,062, respectively. The Organization also made nonelective contributions of \$354,575 and \$976,670, respectively, for total employer contributions of \$505,991 and \$1,239,732 for the years ended June 30, 2024 and 2023.

Participant Accounts

Each participant's account is credited or debited with the participant's contribution, together with any matching and nonelective employer contribution, any loans made to or repaid by participants, and an allocated portion of the Plan's earnings, gains or losses, and expenses. Plan earnings and gains or losses are allocated to each participant's account based on the ratio of each participant's account in each investment fund to the total of all participants' accounts in each investment fund.

Vesting

Participants are immediately vested in their voluntary contributions and employer matching contributions plus actual earnings thereon. Vesting in employer nonelective contributions is based on years of continuous service. The vesting schedule is as follows:

Payments of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Participant Investment Options

Participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature. Participants may change their allocation on a daily basis.

Notes Receivable from Participants

Participants may apply to borrow from the Plan a minimum amount of \$1,000 and a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Loan transactions are treated as a transfer from the investment fund to the notes receivable from participants' fund. Notes receivable from participants may be repaid over any reasonable period, not to exceed the fifth anniversary of the date the funds were borrowed, with the exception of loans used for the purchase of a principal residence, which can be repaid over a period of up to 10 years.

Notes Receivable from Participants (Continued)

The loans are secured by the balance in the participant's account and bear interest at the Prime rate plus 1%. The interest rates in effect for the years ended June 30, 2024 and 2023 range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Any portion of such forfeitures not used to pay Plan administrative expenses shall be applied to reduce employer contributions. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$15 and \$88,432, respectively. Forfeited nonvested amounts used to pay Plan expenses totaled \$-0- for the years ended June 30, 2024 and 2023. Forfeited nonvested amounts used to reduce the employer's contributions totaled \$110,960 and \$-0- for the years ended June 30, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, which is in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized as it is earned, and dividends are recorded on the ex-dividend date.

Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits payments are recorded when paid.

Plan Expenses

Expenses to administer the Plan, if not paid by the sponsor, may be paid by the Plan as provided by the Plan document. Certain fees are allocated to the individual participant accounts.

Subsequent Events

The Plan has evaluated subsequent events through January 30, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFIED INFORMATION

Voya Retirement Insurance and Annuity Company (insurance company) and Voya Institutional Trust Company (custodian), the qualified institutions of the Plan, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023 and the related investment activity reflected in the statement of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of June 30, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 INVESTMENT CONTRACT WITH INSURANCE COMPANY

At June 30, 2024 and 2023, the Plan held an investment contract, the Voya Fixed Account, with Voya Retirement Insurance and Annuity Company (VRIAC). This investment contract met the fully benefit-responsive criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate may change at any time and is based on a formula agreed upon with the issuer. Restrictions may apply to transfers of funds from the Fixed Account to other contract investment options. The contract cannot be terminated before the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants are probable of occurring.

In addition, certain events allow the contract issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the contract issuer.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Plan investments are managed by Voya Retirement Insurance and Annuity Company (insurance company) and Voya Institutional Trust Company (custodian). Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

As described in Note 2, the Plan pays for certain administrative expenses related to Plan operations and investment transactions. Fees paid by the Plan for certain administrative expenses are paid to the following service providers:

- Voya Retirement Insurance and Annuity Company – Plan recordkeeper and insurance company
- Voya Institutional Trust Company – Plan custodian
- Quintes Administrative and Insurance – Plan third-party administrator
- Quintes Financial Services, LLC – Plan financial advisor

These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right to discontinue its contributions and to terminate this Plan subject to the provisions of ERISA. In the event of termination, the participants would become 100% vested in their Organization contributions.

NOTE 8 INCOME TAX STATUS

403(b) plans are not required to receive a favorable determination letter from the Internal Revenue Service (IRS) indicating that the Plan is tax-exempt under present income tax law. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan Sponsor adopted a volume submitter document effective July 1, 2021 with a favorable opinion letter dated November 30, 2020 in which the IRS stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not, would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks.
