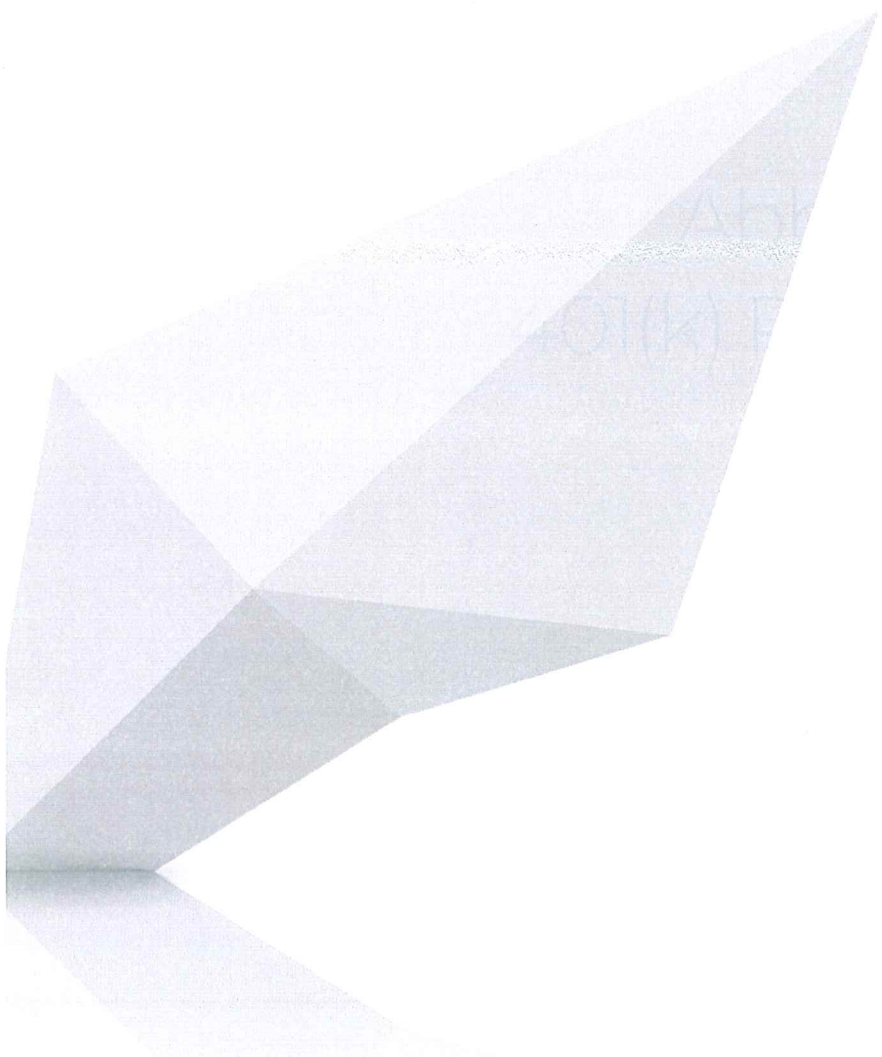

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Abbyland Foods, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Abbyland Foods, Inc., Abbyland Pork Pack, Inc., Abbyland Trucking, Inc., Abbyland Truck Stop, LLC, and El Norteno Restaurant, LLC (collectively the "Company"). An employee becomes eligible to participate in the Plan on the first entry date (March 1, June 1, September 1, or December 1) coinciding with or next following the completion of one year of service and attainment of age 21. A year of service is a 12-month eligibility service period in which an employee works at least 1,000 hours for the employer. The first eligibility service period starts on the employee's first day of employment with the employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants are allowed to contribute up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also allows for Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

The Company currently matches an amount equal to 50% of the first 4% of eligible compensation deferred, including catch-up contributions, up to a maximum amount equal to 2% of eligible compensation. Rollovers are not matched. For the year ended August 31, 2024, the matching contribution was \$238,445.

The Company may also contribute a discretionary nonelective contribution. This contribution is allocated to participants based upon each participant's compensation in proportion to the compensation of all participants. There were no discretionary nonelective contributions for the year ended August 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and allocations of the Company's discretionary nonelective contributions and plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary contributions, QMAC, and QNEC plus actual earnings (losses) thereon. Vesting in the Company's matching and nonelective contributions plus actual earnings (losses) thereon is based on years of continuous service. Participants vest at a rate of 10% after each of the first two years of service, 20% after each of the next two years of service, and 40% after the fifth year of service at which time they are fully vested. To complete a year of service for purposes of vesting, 1,000 hours of service must be completed during the plan year.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Note terms shall not exceed five years unless the note proceeds are used to purchase a primary residence, in which case the term shall not exceed 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Interest rates on existing loans are between 3.25% and 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum or installments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000 but is greater than \$1,000, the plan administrator will pay an involuntary cashout distribution as a direct rollover to an individual retirement plan. Vested balances less than \$1,000 can be distributed only in a single lump-sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's matching and nonelective contributions. Forfeitures of the Company's matching and nonelective contributions are used to reduce future Company contributions. Unallocated forfeitures at August 31, 2024 and 2023, were \$3,686 and \$274, respectively. There were no forfeitures used during the year ended August 31, 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Director's determines the Plan's valuation policies utilizing information provided by the investment advisors and John Hancock Life Insurance Company ("John Hancock"). See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

No allowance for credit losses has been recorded as of August 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

At August 31, 2024 and 2023, amounts payable to participants totaling \$39,135 and \$39,718, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to November 15, 2024 and 2023, respectively.

Note 2: Summary of Significant Accounting Policies (Continued)

Early Contributions Payable

As of August 31, 2023, amounts payable to participant accounts totaled \$14,948 for employee and employer contributions which were deposited into the Plan on August 31, 2023. These contributions related to the first payroll period that was paid to employees subsequent to the Plan's year end. There was no payable as of August 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment advisory and management fees are allocated proportionately to plan participants based on their respective account balances and are offset against net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through January 24, 2025, which is the date the financial statements were available to be issued.

On November 5, 2024, the Plan transferred all of its funds from John Hancock to The Standard.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2024 and 2023.

John Hancock Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3: Fair Value Measurements (Continued)

John Hancock Stable Value Fund: Fair value is calculated as the number of units of the sub-account held on a particular date multiplied by the unit value on that date, and generally is the value that would be paid out for the participant-initiated or benefit withdrawals.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, and non-interest-bearing cash held at August 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended August 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock, the Custodian of the Plan.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company matching and nonelective contributions.

Note 6: Tax Status

The Company adopted a nonstandardized pre-approved plan document with an IRS notification letter dated June 30, 2023, which states the nonstandardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Related-Party Transactions

Plan investments are managed by John Hancock, and as the Custodian as defined by the Plan, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan during the plan year ended August 31, 2024, were \$74,586. Specific detail for management fees is not available from the Custodian.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
