Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Providence College Non-Professional Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, the statement of accumulated plan benefits as of June 30, 2023, and the related statement of changes in accumulated plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of the Plan

The following brief description of the Providence College Non-Professional Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

(a) General

The Plan is a defined benefit pension plan covering substantially all employees of Providence College before the plan freeze in 1989, excluding administrative personnel and teachers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's assets are held in a group annuity contract with the Teachers Insurance and Annuity Association – College Retirement Equities Fund (TIAA-CREF). Costs of plan administration are borne by Providence College (the Plan Sponsor). As discussed in note 3, effective May 31, 1989, the accrual of retirement benefits ceased for all participants. All participants retained their interest in the Plan as of that date.

(b) Pension Benefits

Under the terms of the Plan, non-professional employees who completed one year of service and had reached twenty-one years of age prior to May 31, 1989 (see note 3) are entitled to monthly pension benefits beginning at normal retirement age of 65, equal to 8 1/2% of their career average earnings not in excess of covered compensation, plus 1/2% of career average earnings not in excess of covered compensation multiplied by years of credited service, up to a maximum of 15 years, plus 46% of career average earnings in excess of covered compensation, reduced proportionately for less than 15 years of credited service. Compensation earned after June 1, 1989 is not taken into consideration in the calculation of career average earnings. Covered compensation ranges from \$450 to \$750 per month, depending upon the calendar year of a participant's sixty-fifth birthday. The Plan permits early retirement at ages 55-64 with completion of ten years of credited service. Employees may elect to receive their pension benefits in the form of 50%-100% contingent annuities, if married, or a life annuity, if single, or in an optional form of a five-or ten-year certain annuity. If employees terminate before rendering five years of service, they lose all credit for benefits accumulated under the Plan. All of the participants are fully vested as of June 30, 2024 and 2023.

(2) Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

(a) Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires estimates and assumptions by the Plan administrator that affect the reported amounts in the statements of net assets available for plan benefits, actuarial present value of accumulated plan benefits, and disclosure of contingent assets and liabilities, as of the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

(b) Valuation of Investments

On September 1, 1994, the Plan entered into an investment contract with TIAA-CREF (see note 5) pursuant to which all Plan assets are held in the TIAA Traditional Annuity. The TIAA Traditional Annuity includes the TIAA Group Annuity account which is part of TIAA's general assets. Interest on the account balance is based on a guaranteed interest rate of 3% plus dividends based on earnings from TIAA's diversified portfolio of investments. For the years ended June 30, 2024 and 2023, the effective yield was 4.89% and 4.66%, respectively. The account is also charged for Plan withdrawals and credited for contributions.

Investments in TIAA Traditional Annuity contracts are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (level 3). Contract value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA Traditional Annuity's historical crediting rates. The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract.

(c) Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on the employees' career average earnings, calculated as of May 31, 1989, which equal the average of basic monthly earnings from participation date to normal retirement date or termination of service, if earlier. The accumulated plan benefits for active employees are based on career average earnings calculated as of May 31, 1989. Benefits payable under all circumstances –retirement, death, disability, and termination of employment – are included to the extent they are deemed attributable to employee service rendered to May 31, 1989.

The actuarial present value of accumulated plan benefits as of June 30, 2023 is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuation as of June 30, 2023 include (a) the life expectancy of participants (the Pri-2012 blue collar mortality table and MP-2021 projection scale) (b) retirement age assumptions (the assumed retirement age was 65), and (c) the discount rate for the accumulated plan benefits of 4.75% in 2023. The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

(d) Administrative Expenses

Administrative expenses, which include trustee fees, may be paid out of Plan assets or be paid directly by Providence College.

(e) Payment of Benefits

Benefits are recorded upon distribution.

(f) Risks and Uncertainties

Plan contributions and the actuarial present value of accumulated plan benefits are prepared based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Investments are exposed to various risks, such as interest rate, market and credit. Due to uncertainties inherent in the estimation and assumption processes and the level of uncertainty related to changes in the required contributions, the accumulated plan benefits, and the fair value of investments, it is at least reasonably possible that changes in these estimates and assumptions in the near term would materially affect the amounts reported in the financial statements.

(3) Funding Policy

Providence College has voluntarily agreed to make contributions to the Plan sufficient to provide the Plan with assets with which to pay pension benefits to Plan participants. Providence College made no contributions to the Plan for the years ended June 30, 2024 and 2023. No minimum funding was required for the years ended June 30, 2024 and 2023.

It is Providence College's intention to eventually terminate the Plan subject to the provisions set forth in ERISA and to have all employees covered under their defined contribution plan administered by TIAA-CREF. Benefit accruals under this plan were suspended as of May 31, 1989 when Providence College and the Non-Professional labor union approved an amendment to the Plan to cease the accrual of retirement benefits for all participants. All participants retained their interest in the Plan as of May 31, 1989 and became participants in Providence College's defined contribution plan. All accrued benefits have been fully funded.

(4) Plan Termination

When the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits for former employees or their beneficiaries that have been receiving for at least three years or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- b. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. governmental agency) up to the applicable limitations (discussed below).

- c. All other vested benefits (that is, vested benefits not insured by the PBGC).
- d. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal-age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling on the amount of an individual's monthly benefit that the PBGC guarantees. For Plan terminations occurring during 2024, that ceiling, which is adjusted periodically, was \$7,107 per month. That ceiling applies to those participants who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or Plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits and may also depend on the level of benefits guaranteed by the PBGC.

(5) Contract with Insurance Company

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, TIAA-CREF, the custodian of the Plan, has certified as being complete and accurate the investments on the statements of net assets available for benefits as of June 30, 2024 and 2023, the investment activity reflected in the statements of changes in net assets available for benefits, for the years ended June 30, 2024 and 2023, and the investment information included in the supplemental schedule of the financial statements as of June 30, 2024. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's custodian for their respective periods.

All investments are held by TIAA-CREF. The average effective interest rate for the period July 1, 2023 through June 30, 2024 was 4.89% and July 1, 2022 through June 30, 2023 was 4.66%. Under the terms of the benefits payment contract, TIAA-CREF pays benefits directly from the deposit fund at the direction of the Plan administrator.

(6) Fair Value Measurements

Accounting Standards Codification 820, *Fair Value Measurements* (FASB ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no transfers between Level 1, 2 and 3 during the Plan year.

The Plan's assets are deemed to be Level 3 investments. The following table sets forth a summary of changes in the fair value of the Plan's Level 3 investments for the years ended June 30, 2024 and 2023:

(7) Income Tax

The Plan sponsor has adopted a volume submitter plan. The Internal Revenue Service (IRS) informed the volume submitter plan sponsor, in an opinion letter dated February 28, 2023, that the form of the plan is acceptable under the requirements of the Internal Revenue Code. An employer may rely on a favorable opinion letter issued to a volume submitter plan sponsor as evidence that the plan is qualified under Code Section 401(a) as provided in Revenue Procedure 2015-36. Although the plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and being operated in compliance with applicable requirements of the IRC so that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator believes that there are no uncertain tax positions that would have a material impact on the financial statements of the Plan. Therefore, no provision for income taxes has been recorded in these financial statements.

(8) Subsequent Events

The Plan administrator considers events or transactions that occur after the balance sheet date, but before the financial statements are available to be issued, to provide additional evidence relative to certain estimates or to identify matters that require additional disclosure. These financial statements were available to be issued on January 8, 2025, and subsequent events have been evaluated through that date.

The minimum monthly benefit payable is equal to \$7 times the number of years of credited service up to a maximum of \$175 with 25 or more years.

Effective May 31, 1989, all benefit accruals have ceased.

Early: The benefit payable at early retirement is equal to the accrued benefit payable at the normal retirement date reduced by 5/12 of 1% per month for each of the first 60 months and 4/12 of 1% per month for each of the next 60 months between the benefit commencement date and the normal retirement date.

Late: The benefit payable on a late retirement date is the actuarial equivalent of the benefit accrued at normal retirement date.

Vesting:

The accrued benefit is fully vested after five years of service.

Payment of Retirement Benefits:

For single participants, the normal form of pension is a monthly benefit payable for the lifetime of the participant. For a married participant, the normal form is an actuarially reduced monthly benefit payable under a joint and survivor option with one-half of the benefit payable to the spouse upon the death of the participant. Optional forms of payment are available on an actuarially reduced basis. Upon retirement or termination, a lump sum benefit may be paid to any participant whose accrued benefit has a present value not in excess of \$5,000 (\$3,500 prior to July 1, 2002).

Actuarial Equivalence:

Actuarial equivalence is determined on the basis of an interest rate of 8% and the 1984 Unisex Pension Mortality Table, set back one year for the participant, and set back two years for any second annuitant.

If a married participant dies after attaining eligibility for early retirement, the surviving spouse will receive a monthly life annuity benefit equal to 50% of the monthly benefit that would have been paid to the deceased participant, had the participant retired on the day before death with an immediate joint and 50% survivor annuity.

If a married participant dies with a vested benefit prior to attaining eligibility for early retirement, the spouse will be entitled to a life annuity, payable as though the participant:

- (a) separated from service on the date of death;
- (b) survived to the earliest possible retirement date;
- (c) retired on that day with an immediate joint and 50% survivor annuity; and
- (d) died the following day.
