

Your plan is a single-employer defined contribution plan.

### **Basic Financial Statement**

Benefits under the plan are provided by a Group Annuity Contract with Sentry Life Insurance Company. Plan expenses were \$44. These expenses included \$44 in administrative expenses. A total of 9 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons may have earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,708,059 as of September 30, 2024, compared to \$1,275,164 as of October 1, 2023. During the plan year the plan experienced an increase in its net assets of \$432,895. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$432,939, including employer contributions of \$26,589, employee contributions of \$73,449, and earnings from investments of \$332,901.
