#### 1. Plan Description

The following description of the Torrent Photonics Holdco 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all non-union and non-resident alien employees of Torrent Photonics Holdco, LLC (the "Company") who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan has a beginning effective date of January 1, 2022.

The Plan was amended effective January 1, 2024 to change the employer name to Torrent Photonics Holdco, LLC and the Plan name to Torrent Photonics Holdco 401(k) Plan. The amendment also included participating employers Salvo Technologies, LLC and Torrent Photonics, LLC.

- b) *Eligibility* – The Plan substantially covers all employees of the Company who have completed three months of service. Plan entry dates are on the 1<sup>st</sup> of each month. The participants must have satisfied all the eligibility prior to the entry to be allowed to enroll.
- c) *Employee Contributions* – Each year participants may contribute to the Plan subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Unless elected otherwise, participants will automatically contribute 3% of eligible compensation, with an automatic increase of 1% annually, up to a maximum of 6% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans.
- d) *Employer Contributions* – The Company makes a Safe Harbor matching contribution each pay period equal to 100% of participant deferrals up to 3% of compensation, and 50% between 3%-5% of compensation. The Company made Safe Harbor matching contributions in the amount of \$387,457 for the year ended December 31, 2023.

- e) *Investment Options* – Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time online at the record keeper’s website.
- f) *Participants Accounts* – Each participant’s account is credited with the participant’s contributions and allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- g) *Vesting* – Participants are vested immediately in their contributions and Safe Harbor contributions, as well as all other employer contributions, plus actual earnings thereon.
- h) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution payment.
- i) *Forfeited accounts* – Any non-vested portion of matching contributions credited to the accounts of participants who withdraw prior to becoming fully vested is forfeited and used by the Company to reduce future matching contributions and/or payment of eligible administrative expenses. Forfeited non-vested amounts totaled \$1,201 and \$1,028 at December 31, 2023 and 2022, respectively.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to

make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Participant Accounts Payable

Amounts payable to participants for deposit errors made during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **3. Subsequent Events**

The Plan has evaluated events and transactions occurring subsequent to December 31, 2023 through November 11, 2024, the date the financial statements were issued.

**5. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 6. Guaranteed investment contract (GIC)

The Plan holds a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya), the Voya Fixed Account. The contract underlying this investment option is considered to be fully benefit responsive. Because the GIC is fully benefit responsive, the investment is reported at contract value. Contract value approximated fair value for the year ended December 31, 2023.

Voya maintains the contributions in a general account. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. In most cases, participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

The methodology for calculating the interest crediting rate is based on a number of factors including the earnings of the underlying assets compared to the minimum interest crediting rate, as stated in the contract, mortality risks and prevailing market conditions. Interest crediting rate is reset at least monthly.

#### **7. Risks and Uncertainties**

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### **8. Related Party Transactions**

Voya Institutional Plan Services, LLC and Voya Retirement Insurance and Annuity Company are subsidiaries of Voya Financial, Inc. The Plan invests in mutual funds that are administered by Voya. The Company provides limited administrative services to the Plan without charge. These transactions qualify as party-in-interest transactions.

#### **9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### 10. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Prototype Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
