### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hood Packaging Corporation Hourly Employees 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of January 17, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period ended January 17, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of January 17, 2023 and December 31, 2022, and for the period ended January 17, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter-Plan Merger**

As discussed in Note 1 to the financial statements, the Board of Directors of Hood Packaging Corporation, the Plan's sponsor, voted on September 23, 2022, to merge the Plan into the Hood Packaging Corporation Savings Plan effective January 1, 2023. All plan assets were transferred to the Hood Packaging Corporation Savings Plan on January 17, 2023. Our opinion has not been modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. **Note 1. Description of the Plan**

The following description of the Hood Packaging Corporation Hourly Employees 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established April 1, 2014, is a defined contribution plan covering hourly bargaining unit employees who have completed six months of service in the following Hood Packaging Corporation (the "Company") locations: Vancouver, Washington, Crossett, Arkansas, and Minneapolis, Minnesota. An employee may begin participation in the Plan on the first day of the quarter following the date on which the employee meets the requirements for eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Merger

The Board of Directors of Hood Packaging Corporation, the Plan's sponsor, merged the Plan into the Hood Packaging Corporation Savings Plan (the "HPC Plan") effective January 1, 2023. All Plan assets were transferred into the HPC Plan on January 17, 2023. Participant accounts retained their vested interest in their account balances from the Plan with participants continuing to vest according to the vesting provisions of the Plan for any previous contributions made prior to the Plan merger on January 17, 2023.

Contributions

The Plan allows for participants to make pretax contributions to the Plan subject to the limitations set forth in the Internal Revenue Code (the "Code"), including catch-up contributions, but not more than 75 percent of their pretax eligible annual compensation. The Company makes matching contributions for each location in an amount as stated in the applicable collective bargaining agreement.

The Company matches 100 percent of deferrals up to 3 percent of the participant's eligible compensation and 50 percent of the next 2 percent of the participant's eligible compensation.

The Company may elect to contribute a discretionary amount to each participant's account. There were no discretionary contributions for 2023 or 2022. Participants direct the investment of their contributions into various investments options offered by the Plan.

Participants may also transfer to the Plan certain vested account balances from other qualified plans, subject to regulatory requirements. Transfers from the Plan represent distributions to other qualified plans within the controlled group. Rollovers represent distributions from qualified plans not sponsored by entities within the controlled group.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary contributions, Plan earnings and losses and is charged with an allocation of administrative expenses to the extent such expenses are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

All participants are immediately vested in their voluntary contributions and allocated earnings or losses thereon.

Participants' interests in the Company's matching contributions, additional contributions, discretionary contributions, and allocated earnings or losses thereon are vested as follows:

One year	20%
Two years	40%
Three years	60%
Four years	80%
Five or more years	100%

Payment of Benefits

Benefits are generally payable on termination, retirement, death or disability. Benefits may be paid by either lump-sum payment, monthly installments over a period of time ranging from 5 to 15 years, as elected by the participant or rolled over into a qualified plan subject to regulatory requirements. After age 59 ½, a participant may elect to receive an in-service distribution for all or a portion of their vested balance. Hardship distributions are also available from participants' elective deferral accounts, excluding earnings on such deferrals, subject to regulatory requirements.

Forfeitures

Forfeitures, which result from participants withdrawing from the Plan prior to fully vesting in employer contributions, are used to offset employer matching contributions and pay Plan expenses. There were unallocated forfeitures of \$0 and \$22,794 as of January 17, 2023 and December 31, 2022, respectively. Additionally, forfeited amounts applied to reduce matching contributions or plan expenses were \$0 and \$40,523 in 2023 and 2022, respectively.

**Note 2. Summary of Significant Accounting Policies**

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized and unrealized gains and losses in the Plan's investments are included in net appreciation (depreciation) of investments in the statements of changes in net assets available for benefits.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Administrative expenses of the Plan, to the extent that the Company does not pay such expenses, are paid by the Plan. Expenses that relate to a specific participant may be allocated to such participant.

#### Participant Loans

Participant loans are not permitted by the Plan.

### Note 3. Information Certified and Provided by Principal

Certain information related to investments disclosed in the accompanying financial statements, including investments held at January 17, 2023 and December 31, 2022, and net appreciation (depreciation) of investments for the period ended January 17, 2023, and year ended December 31, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company (collectively, "Principal"), the custodians of the Plan.

### Note 4. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares or units of collective investment trusts and pooled separate accounts managed by Principal. The Plan paid Principal \$228 and \$30,933 for the period ended January 17, 2023 and year ended December 31, 2022, respectively, for certain administrative expenses. Principal is the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

### Note 5. Income Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service ("IRS") regarding the Plan's qualification under Section 401(a) and the related trust's tax-exempt status under the provisions of Section 501(a) of the Code. However, the Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code.

The Plan administrator will make any changes deemed necessary to ensure that the Plan is granted tax-exempt status. The plan has been set up as a volume submitter since 2018, the IRS stopped issuing letters of Determination for plan sponsors who were on the volume submitter plan document as these were all pre-approved by the IRS.

### Note 6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at January 17, 2023 and December 31, 2022:

*Mutual fund:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

*Pooled separate accounts:* Pooled separate accounts held by the Plan are invested in domestic and international stocks, mutual funds or fixed securities. These are primarily valued at NAV per share based on quoted market prices of underlying investments (Level 2).

*Collective investment trusts:* The collective investments trusts include the Principal Stable Value Preferred Fund ("Fund") and Principal LifeTime Hybrid Collective Investment Trusts ("CITs") (Level 2).

The Fund invests in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions. The objective of the Fund is to provide preservation of capital and relatively stable returns. The Fund is valued at NAV, as reported by the investment managers of the Fund and are supported by unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date resulting in a readily determinable fair value. Participant transactions and redemptions (purchases and sales) may occur daily. Withdrawals, other than for benefit payments and participant transfers to noncompeting options, require twelve months advance written notice. As of January 17, 2023 and December 31, 2022, there were no unfunded commitments.

CITs invest in a collective trust fund as well as a variety of separate accounts and mutual funds that seek total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor with a specific target retirement date. These are valued at NAV per unit held by the Plan at year-end as reported by the custodians, which is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As a result of the Plan merger discussed in Note 1 to the financial statements, there were no Plan assets as of January 17, 2023.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Late Filing of Form 5500**

The Plan failed to file Form 5500 for the period ended January 17, 2023, by the required deadline. The Plan has taken steps to file the delinquent Form 5500 and will be subject to penalties as imposed by the Department of Labor. The penalty is expected to be paid by the Plan Sponsor on behalf of the Plan; thus no expense has been recorded in the accompanying financial statements of the Plan.

**Note 9. Subsequent Events**

The Plan has evaluated subsequent events through February 13, 2025, the date these financial statements were available to be issued.
