Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Star Protection 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits in liquidation as of September 18, 2024 and December 31, 2023 and the related statement of changes in net assets available for benefits in liquidation for the period ended September 18, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Star Protection 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 18, 2024 and December 31, 2023 and for the period ended September 18, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Star Protection 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Basis of Accounting

As discussed in Note A to the financial statements, the governing body of Star Protection 401(k) Plan approved a plan of liquidation on December 8, 2023, effective January 31, 2024 and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going concern basis to the liquidation basis in 2023. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Star Protection 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE A.--DESCRIPTION OF PLAN

The following description of Star Protection Agency, LLC (Company or Sponsor) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution 401(k) profit sharing plan originally effective January 1, 2019. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee was any person employed by the Company. Employees were eligible to participate in deferring a portion of their pay to the Plan, in employer match contributions and profit sharing contributions upon reaching age 21 and after completing one year of service. Effective January 1, 2019, the Plan was amended to comply with the provisions of the Bipartisan Budget Act of 2018 to allow for the removal of suspension of deferrals after hardships and remove loan requirements before a hardship. Effective October 15, 2021, the plan was restated due to a change in custodians and adopted the Cycle 3 restatement. Effective July 1, 2023, the Plan was amended to change the service requirements to 6 months of service.

Plan Termination: On December 8, 2023, the governing body of the Company resolved to terminate the Plan, effective January 31, 2024 (the "Plan Termination Date"). As of December 8, 2023 all participants became 100% vested in their accounts. In accordance with accounting principles generally accepted in the United States of America ("GAAP"), the Plan changed its basis of accounting used to value Plan assets and liabilities from the ongoing basis to the liquidation basis. See Note G for further details regarding the Plan termination. As of September 18, 2024 all assets have been distributed from the plan.

Contributions: The Plan was funded by eligible participant elective deferrals which may have been up to 100% of pre-tax annual compensation, discretionary matching contributions and discretionary profit-sharing contributions. Discretionary match contributions were based on a percentage of deferrals. Profit-sharing contributions were allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. Participants were required to be employed on the last day of the Plan year, unless the participant dies, becomes disabled or reaches the normal retirement age to participate in any employer contributions. No profit sharing contributions were made in 2024 or 2023.

Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified retirement plans. Also, all participants who were eligible to make elective deferral contributions may have designated all or any portion of their deferrals as Roth elective deferral contributions. Contributions were subject to certain limitations.

Participant Accounts: Each participant's account was credited with the participant's contribution, an allocation of the Company's contributions, an allocation of plan earnings (losses), and charged with an allocation of certain administrative expenses. Allocations were based on participant compensation, account balances, or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant was entitled is the benefit that could have been provided from the vested portion of the participant's account.

Vesting: Participants were immediately vested in their rollover contributions and elective deferrals plus actual earnings thereon. Vesting in any Company discretionary matching and profit sharing contributions was based on years of continuous service. A participant is 20% vested after two years of credited service, 40% vested after three years, 60% vested after four years, 80% vested after five years, with full vesting at six years, or upon death, disability, or retirement age. See also above Plan Termination.

Retirement: The normal retirement date was the date the participant turns 65. There was no early retirement.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may have elected to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a partial payment. For terminated participants, if the balance of the vested accounts is \$1,000 or less, excluding rollover contributions, payment may be made in a lump-sum without the participant's consent. If such balance is less than \$5,000 but greater than \$1,000, without consent or other direction, it will automatically be rolled over into an IRA established by the Company. Hardship distributions were allowed in accordance with the provisions of the Plan. In-Service distributions were allowed at age 59½. Qualified reservist distributions were also allowed. Distributions can be taken from rollover contributions at any time.

Investment Options: Participants were allowed to direct their contributions and account balances in a variety of investment options which included mutual funds. The Plan Sponsor periodically reviewed the investment options available to participants and changed them as warranted. Participants may have changed their investments at any time.

Forfeitures: Forfeitures were the non-vested portion of a participant's account that were lost upon termination of employment. Forfeitures were retained in the Plan and at the discretion of the Company, were used to reduce future Company contributions. As of September 18, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$2, respectively.

Plan Expenses: Expenses of maintaining the Plan were paid by the Company or the Plan. Certain expenses of maintaining the Plan were paid for directly by the Company and were excluded from these financial statements. Fees relating to certain withdrawals were charged directly to the participant's account and are included in administrative expenses. Investment related expenses, including 12b-1 fees, were deducted from each funds' earnings and included in net appreciation (depreciation) in fair value of investments.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the liquidation basis of accounting, consistent with terminated plans, as of September 18, 2024, and December 31, 2023, and for the period ended September 18, 2024, in accordance with GAAP.

Accrued expenses reported in the accompanying statement of net assets available for benefits, as of December 31, 2023, reflected management's best estimate of the costs to be incurred and paid from assets of the Plan in connection with the Plan termination.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by investment advisors and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.--CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements, including investments held at September 18, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of investments, interest and dividend income, for the period ended September 18, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, the record keeper of the Plan as agent for Ascensus Trust Company, the trustee of the Plan.

NOTE D.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 18, 2024 and December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE F.--TAX STATUS

The Plan was amended and restated effective October 15, 2021 and adopted a non-standardized pre-approved profit sharing plan with cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

The Plan has not applied for a determination letter associated with the termination of the Plan (See Note G) as permitted by the IRC. However, the Plan administrator believes that the Plan was designed, and was currently being operated, in compliance with the applicable requirements of the IRC and, that the termination of the Plan did not affect its qualification for federal tax purposes. Therefore, no provision for income taxes was included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of September 18, 2024 (in liquidation) and December 31, 2023 (in liquidation), there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G.--PLAN TERMINATION

As described in Note A, the Company elected to terminate the Plan December 8, 2023 effective January 31, 2024. Accordingly, the net assets of the Plan were allocated for payment of plan benefits to the participants, as prescribed by ERISA, applicable regulations thereunder, and the plan document.

As of December 31, 2023, approximately \$169,258 had been distributed out of the Plan related to the termination. As of September 18, 2024, all Plan assets have been distributed out of the Plan related to the termination.

NOTE H.--RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks prior to full liquidation. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities would have occurred in the near term and that such changes could have materially affect participants' account balances and the amounts reported in the financial statements.

NOTE I.--OPERATIONAL ERRORS AND NONEXEMPT TRANSACTIONS

Late Remittances: As reported on the supplemental schedule, Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain Plan contributions of \$18,862 for plan year December 31, 2023 were not remitted to the trust within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and Company for the year ended December 31, 2023.

NOTE J.--EXCESS CONTRIBUTIONS

Contributions received from participants for 2023 of \$38,285, were made subsequent to year end to certain active participants to return them excess deferral and related match contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. Those amounts were included in the Plan's statement of net assets available for benefits as excess contributions payable at December 31, 2023.
