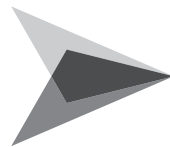

Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed an audit of the financial statements of Christian Opportunity Center Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Christian Opportunity Center Profit Sharing Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(c), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended August 31, 2024 and 2023, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Note 1 - Description of Plan

The following description of the Christian Opportunity Center (the “Company”) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan was established January 1, 1988 and is a defined contribution plan. Employees are eligible to participate in the Plan after one year of service, which is defined as a consecutive 12-month period in which an employee is credited with at least 1,000 hours of service and are at least age 21. Participants may enter the Plan on March 1 and September 1. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute pre-tax elective deferrals up to the maximum allowed by Internal Revenue Service regulations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Such contributions are subject to the provisions of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or deferred contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary contributions to the Plan in amounts determined by the Company’s board of directors. To receive discretionary contributions, participants must be employed on the last day of the plan year. Any such contributions are allocated to the participants’ accounts, as provided by the Plan. There were discretionary contributions of \$152,293 and \$181,654 for the years ended August 31, 2024 and 2023, respectively.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary contribution and, (b) plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Forfeitures - Forfeitures may first be used to pay employer contributions and administrative fees of the Plan. For the year ended August 31, 2024 and 2023, the amount of forfeitures used to reduce employer contributions and administrative expenses was \$19,429 and \$1,641, respectively. The balance of unapplied forfeitures was \$-0- and \$-0- as of August 31, 2024 and 2023, respectively.

Payment of Benefits - Active participants may take a withdrawal from the Plan in the event of a financial hardship. A hardship withdrawal will result in a six-month suspension of contributions to the Plan. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Note 2 - Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan sponsor determines the Plan’s valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits – Benefit payments to participants are recorded upon distribution

Expenses – The Plan’s expenses are paid by either the Plan or the Organization, as provided by the Plan document. Expenses that are paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Reclassification of Investments - Certain prior year amounts have been reclassified for consistency with the current year presentation. These reclassifications had no effect on the reported results of operations.

Date of Management’s Review - Management has evaluated subsequent events through February 4, 2025, the date which the financial statements were available to be issued.

Note 3 – Fair Value Measurement

The Plan holds investments in pooled separate accounts which are held in segregated investment accounts established by Lincoln Financial Group, which includes The Lincoln National Life Insurance Company and Lincoln Life & Annuity Company of New York. The value of the Plan’s investment in the pooled separate accounts is valued at the net asset value which approximates fair value. Net asset value (NAV) is calculated by Lincoln based on the value of the underlying assets owned by the fund, less the fund’s liabilities, divided by the number of participation units outstanding.

Pooled separate accounts that are measured at fair value using the NAV practical expedient have not been categorized in the fair value hierarchy.

The following table summarizes Plan investments whose fair value is estimated using NAV per share (or its equivalent) as of August 31, 2024, and 2023.

Note 4 - Contract with Insurance Company

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Lincoln Financial Group. Lincoln Financial Group maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

Contract value, as reported to the Plan by Lincoln Financial Group, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at August 31, 2024 and 2023 was \$26,077 and \$2,241, respectively. A composite crediting rate contractually guaranteed by Lincoln Financial Group is credited to account balances. The net crediting rate is after the deduction for fees for administrative and recordkeeping services provided to the Plan. Currently, this net crediting rate is a 2.54% effective quarterly rate.

Note 4 - Contract with Insurance Company (Continued)

Certain events might limit the Plan's ability to transact at contract value with Lincoln Financial Group. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5 - Related Party and Party-in-Interest Transactions

Certain plan assets are held in investment options managed by Lincoln Financial Group, the custodian as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Note 7 - Tax Status

The Internal Revenue Service has determined and informed the Company by the letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The plan sponsor believes that the Plan, as amended, continues to qualify and to operate as designed. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

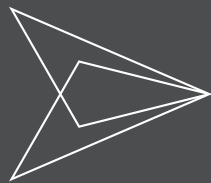
