### **Opinion on the Financial Statements**

We have audited the financial statements of Southern California Health & Rehabilitation Program Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

### NOTE 1. DESCRIPTION OF THE PLAN

The following description of Southern California Health & Rehabilitation Program Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan, as restated on July 1, 2021, is a defined contribution plan that covers substantially all employees of Southern California Health & Rehabilitation Program (the Company or Plan Sponsor), who have attained age 21 and have completed twelve consecutive months of service with 1,000 hours. If employees do not complete 1,000 hours of service within their first twelve consecutive months of employment, the employees will have satisfied the service requirement when they are credited with 1,000 hours of service at the end of any following plan year. Eligible employees enter the Plan on July 1 or January 1 coinciding with or following the date they satisfy the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** The Company may make annual discretionary profit-sharing contributions to eligible participants who are employed on the last day of the Plan year. Elective deferral contributions are not allowed. During the year ended June 30, 2024, the Company contributed maximum contributions allowable under the Internal Revenue Code (IRC) Section 415 for its executive employees and 5% of eligible compensation for non-executive employees, subject to the compensation limit imposed by the IRC.

**Participant Accounts:** Each participant's account is credited or allocated with (a) the Company's contribution and (b) the Plan earnings. Allocations of the Plan earnings for investments are based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested in the Company's discretionary profit-sharing contributions according to the following schedule:

Notwithstanding the above, if a participant is employed on or after Normal Retirement Age, dies or becomes disabled, his or her Company's discretionary profit sharing contributions become 100% vested regardless the years of service.

### NOTE 1. DESCRIPTION OF THE PLAN (Continued)

**Benefit Payments:** Upon retirement, termination of service, death or disability, a participant or beneficiary may receive partial payments or a lump-sum amount equal to the value of the participant's vested interest in his or her account.

In-service distributions, which has a minimum amount of \$1,000, are permitted from all accounts which are 100% vested. In service distributions can also be made to participants who have attained age 59-1/2 and the amount being withdrawn has accumulated in the Plan for at least two years.

If a terminated participant's vested account is less than \$5,000, his or her total vested benefit may be made to the participant regardless of whether the participant consents to receive it. Financial hardship distributions are not permitted.

**Forfeitures:** Forfeited Company discretionary profit-sharing contributions may be used to pay Plan expenses or to reduce Company's future contributions to the Plan. No forfeitures were utilized during the year ended June 30, 2024. Additionally, no forfeitures were available for future use as of June 30, 2024.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America, requires the Plan Administrator to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair market value. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

Realized and unrealized appreciation is based on the market value of the assets at the end of the Plan year compared to the market value of the assets at the beginning of the Plan year, or at the time of assets purchased or exchanged during the Plan year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Benefit Payments:** Benefits are recorded as expenses when paid.

**Administrative Expenses:** The Company incurs certain expenses in administering the Plan, which are not passed on as expenses of the Plan.

### **NOTE 3. TAX EXEMPT STATUS**

The Plan has adopted non-standardized pre-approved profit sharing plan that has received a favorable determination letter dated June 30, 2020 from the Internal Revenue Service, which stated that the form of the Plan is acceptable under the applicable sections of the IRC. The Plan has been amended since receiving the determination letter and the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and concluded that, as of June 30, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to June 30, 2021.

### **NOTE 4. PARTY-IN-INTEREST TRANSACTIONS**

Plan's investments are in mutual funds which are managed by American Funds and National Pension Service is the third-party administrator of the Plan. Therefore, transactions with American Funds and National Pension Services qualify as party-in-interest transactions as defined by Section 3(14) of ERISA.

### **NOTE 5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contributions.

### **NOTE 6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market performance and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 7. FAIR VALUE MEASUREMENTS

In accordance with accounting principles generally accepted in the United States of America, the Plan establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in active markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means market participants would use in pricing the asset or liability.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The valuation method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
