Opinion

Opinion

We have audited the accompanying financial statements of Rhode Island Shipping Association – International Longshoremen's Association Annuity Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Rhode Island Shipping Association - International Longshoremen’s Association Annuity Fund (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan was established in 1997 and is operated under collective bargaining agreements between the employers and the International Longshoremen’s Association (ILA) for the Port of Providence and vicinity to provide benefits upon retirement, total and permanent disability, termination of service, or death. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

Contributions

Contributions are made by employers in accordance with the working agreement and are at a fixed rate per hour worked.

Participants' Accounts

Each participant's account is credited with the employer's contribution and an allocation of the Plan earnings. All Plan investments are professionally managed under the direction of the Plan trustees.

Vesting

A participant is fully vested after three years of credited service.

Forfeiture of Nonvested Balance

The nonvested portion of a participant’s account shall be forfeited as of the earlier of the date on which the participant receives a complete distribution of his vested account or the last day of the plan year in which the participant incurs five (5) consecutive breaks in service. The amount forfeited shall be: (1) used to pay administrative expenses, (2) used to reduce employer contributions for the current plan year, and/or (3) allocated as an employer contribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Plan Amendment

In 2023, the Plan was amended to include provisions for in-service distributions and to allow for more frequent valuation dates for participant balances. The amendment was effective July 1, 2023, and subject to a one-year sunset provision. The amendment became permanent with no action taken by the Board of Trustees related to the sunset provision of the amendment.

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s valuation policies utilize information provided by the investment advisers and custodians. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Contributions Receivable

Contributions receivable represent employer contributions related to employees’ hours worked on or prior to September 30th received after year end. No allowance for doubtful accounts is required.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through February 12, 2025, which is the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the year ended September 30, 2024.

3. TAX STATUS

The Internal Revenue Service has ruled by letter dated August 13, 2012, that the Plan is qualified and continues to be tax exempt under the appropriate sections of the Internal Revenue Code. The Plan has been amended and restated since receiving the determination letter. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. At September 30, 2024, management believes no such provision for uncertain tax positions is necessary.

The Plan is subject to routine audits by regulatory agencies and taxing jurisdictions; however, there are currently no audits in progress.

4. PLAN TERMINATION

The Board of Trustees has the right under the Plan to amend or terminate the Plan at any time. In the event of Plan termination, the balance of each participant’s account will be paid to the participant or their beneficiary, in accordance with the Plan’s distribution provisions.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

7. RELATED-PARTY TRANSACTIONS

As commented in Note 1, the Plan is maintained pursuant to collective bargaining agreements which include other employee benefit plans. The Plan is related to these other benefit plans through common membership and common members on their Board of Trustees. Certain shared insurance costs are allocated based on the Plan’s respective assets. Allocated insurance costs amounted to \$6,249 and \$6,105 for the years ended September 30, 2024 and 2023, respectively. International Longshoremen’s Association Local 1329 makes contributions for hours worked while performing dispatcher operations. The contribution is capped at 2,000 hours with Local 1329 contributing the shortfall between 2,000 hours and other reported hours. Amounts contributed for the year ended September 30, 2024 and 2023 were \$438 and \$302, respectively. The amounts due from Local 1329 at September 30, 2024 and 2023 were \$302 and \$740, respectively.

8. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Cash Equivalent – valued at the daily closing price as reported by the fund. The fund provides income on cash reserves while preserving capital and maintaining liquidity. The fund seeks to preserve the value at \$1.00 per share.

Mutual Funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended, mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables present, by level within the fair value hierarchy, the Plan investment assets at fair value as of September 30, 2024 and 2023. Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.
