We have performed audits of the accompanying financial statements of Old Hickory Smokehouse, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 9, 2023 (in liquidation) and December 31, 2022 (on going), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to June 9, 2023 (in liquidation) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Old Hickory Smokehouse, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting Disclosure under ERISA. As described in Note 1 to the financial statements, the governing body of Old Hickory Smokehouse, LLC 401(k) Plan approved the Plan to be terminated effective on June 9, 2023. As a result, the financial statements have been prepared using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

June 9, 2023 (Liquidation Basis) and December 31, 2022 (Ongoing Basis)

Note 1 - Description of Plan

The following description of the Old Hickory Smokehouse, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement and amendments for a more complete description of the Plan's provisions.

General

The Plan, as amended, was a defined contribution plan maintained for substantially all eligible employees of Old Hickory Smokehouse, LLC (the Plan Sponsor). The Plan covered substantially all full-time employees who were age twenty-one or older and had completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective June 9, 2023, the Plan Sponsor terminated the Plan and all assets were distributed from the Plan.

Contributions

Until February 25, 2023, participants could elect to make pre-tax contributions, subject to the annual additions limitations per the Internal Revenue Code (IRC) or could be made after-tax in the form of a Roth 401(k) contribution. Participants could direct the investment of their contributions into various investment options offered by the Plan. Participants who had attained age fifty before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Unless otherwise elected by the participant, a participant was automatically enrolled in a pre-tax salary deferral election of 4% of compensation eligible for deferrals upon enrollment. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions were permitted up to 75% of compensation subject to certain Internal Revenue Service (IRS) limitations.

The Plan Sponsor contributed and allocated a matching contribution equal to a discretionary percentage of each eligible participant's salary deferrals. During 2023 and 2022, the employer match was 25% of participant deferrals up to a maximum matching amount of 6% of participant compensation, which totaled \$4,163 and \$21,491 respectively.

Participant Accounts

Each participant's account was credited (charged) with the participant's contributions and Plan Sponsor employer matching and profit sharing contributions, as well as allocations of investment earnings (losses), and administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's discretionary contributions were based on years of continuous service. Participants vested 100% after three years of service. Upon Plan termination participants became 100% vested in the Plan Sponsor's discretionary contributions.

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant was entitled to receive only the vested interest in his or her account as a lump-sum distribution. If the participant's vested account balance was less than \$5,000, the account was distributed to the participant as a lump-sum distribution.

Forfeited Accounts

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures reduced the Plan Sponsor's contributions and administrative expenses to the Plan. At December 31, 2022, forfeited nonvested accounts totaled \$791. There were no forfeitures at June 9, 2023 due to the termination of the Plan.

Hardship Withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the Plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and were excluded from these financial statements. Fees related to the processing of distributions were included in administrative expenses and charged directly to the participant's account. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

As described in Note 1 of the financial statements, the Plan Sponsor terminated the Plan effective June 9, 2023. In accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), the June 9, 2023 financial statements of the Plan have been prepared under the liquidation basis of accounting. Amounts related to 2022 have been prepared on the ongoing basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were valued at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Events Occurring After Reporting Date

The Plan Sponsor has evaluated events and transactions that occurred between June 10, 2023 and February 20, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

Note 3 - Certified Information

Certain information related to investments from participants disclosed in the accompanying financial statements, including the fair value of investments from participants held at June 9, 2023 and December 31, 2022, and net appreciation in fair value of investments for the period from January 1, 2023 to June 9, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (John Hancock).

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022.

- (i) **Pooled Separate Accounts:** Valued at net asset value, which is based on the market value of the underlying investments held by the pooled separate account at year end. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the pooled separate accounts, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following table summarizes investments for which the fair value is measured using the NAV per share practical expedient as of December 31, 2022. There were no participant redemption restrictions for these investments; the redemption notice period was applicable only to the Plan.

Note 5 - Income Tax Status

The Plan Sponsor adopted a pre-approved 401(k) plan, as amended, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the pre-approved Plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the Plan administrator believes that the adopted pre-approved Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 9, 2023 and December 31, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments were shares of pooled separate accounts managed by John Hancock and, John Hancock received a fee for their services. As described in Note 1, the Plan paid expenses to various service providers which also qualify as party-in-interest transactions. During the period from January 1, 2023 to June 9, 2023 and the year ended December 31, 2022, the Plan Sponsor incurred administrative service fees from, Ascensus Holdings, and investment advisory services from Edward Jones, Co. and Willshire Associates, Inc., and audit services from Puryear & Noonan, CPAs, which are deemed to be parties-in-interest.

Note 7 - Reconciliation of Financial Statements to Form 5500

There were no significant differences between net assets available for benefits per the financial statements to the Form 5500 as of June 9, 2023 and December 31, 2022. Also there were no significant differences between the change in net assets available for benefits per the financial statements to the Form 5500 for the period from January 1, 2023 to June 9, 2023.



