Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Pathway School Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Pathway School Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1: Description of Plan

The following description of The Pathway School Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established as of April 1, 1995 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

General

The Plan, sponsored by The Pathway School (the "School" or "Employer"), is a tax deferred annuity plan covering all employees of the School upon employment. Employees scheduled to work more than 20 hours per week and who contribute a minimum of \$10 per pay period become eligible for a School contribution after six months of employment. The School's contribution ranges from 2% to 5% of compensation, based on years of service.

Effective April 1, 2019, the Plan was amended and restated and a portion of assets were transferred from Teachers Insurance and Annuity Association of America and College Retirement Equities Fund (TIAA-CREF) to American United Life Insurance Company (AUL). Under the restatement, the eligibility service requirement for the School's non-elective employer contribution was changed to six months, and a participant loan provision was implemented.

Contributions

The Plan allows each participant to contribute up to 100% of the participant's annual compensation to the Plan. However, a participant's total deferrals in any taxable year may not exceed the dollar limit stated in the Internal Revenue Code. Participants are also able to contribute money from a previous qualified plan, subject to certain Plan restrictions.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions and plan income, less any plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested 100% in their voluntary contributions, any rollover contributions, employer contributions and earnings thereon.

Note 1: Description of Plan (Continued)

Investment Options

Upon enrolling in the Plan, participants may direct their contributions and any related employer contributions into a range of investment options, including registered investment companies, a real estate pooled separate account, and a fixed-annuity contract. All investments are participant directed.

Payment of Benefits

Participants' benefits under the Plan are payable to participants, their beneficiaries or their estates upon termination of employment, normal retirement (age 65), disability, financial hardship, death, or upon the attainment of age 59-1/2. Benefits are payable in the forms offered by the various funding vehicles of the Plan and include single life annuity contracts, joint and survivor annuity contracts, fixed period annuity contracts, cash withdrawals and other annuity and withdrawal options as provided by the respective investments.

Plan Loans and Notes Receivable from Participants

Prior to April 1, 2019, plan loans were only issued as separate contracts by TIAA as contemplated under IRC section 72(p)(5). These loans do not represent plan assets. The loans are collateralized using a participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. Principal and interest are paid ratably by the participant to TIAA and each payment reduces amounts collateralized by the borrowing participant's TIAA Traditional account balance. Plan participant loan balances outstanding were \$0 and \$17,099 at June 30, 2024 and 2023, respectively, and are not included in these financial statements.

Effective April 1, 2019, the Plan loan policy was amended and restated under OneAmerica to permit loans as withdrawals from the participant's accounts with OneAmerica. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Participants are limited to two outstanding loan balances at a time. Notes receivable from participants amounted to \$37,785 and \$44,372 at June 30, 2024 and 2023, respectively.

Note 2: Summary of Significant Accounting Policies

General

The summary of significant accounting policies of the Plan is presented to assist in the understanding of the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America (GAAP) and have been consistently applied in the preparation of the financial statements.

Note 2: Summary of Significant Accounting Policies (Continued)

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with GAAP.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest are recorded when earned, based on the terms of the investments and the periods during which the investments are owned. Net realized and unrealized gains and losses are reported as net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Plan's administrative expenses are generally paid by the School. Certain administrative expenses incurred by the Custodians may be paid from the Plan's assets. Certain expenses incurred on loans and distributions for participants are paid by the participant. In addition, certain investment related expenses are included in investment income in the accompanying statement of changes in net assets available for benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Note 3: Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule of assets, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation (depreciation) of investments and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by TIAA-CREF and AUL, the Plan's Custodians.

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2024 and 2023.

Pooled Separate Account: The TIAA Real Estate Account is an insurance company separate account of TIAA investing mainly in real estate and real estate-related investments. Unit values are calculated daily and published on the New York Stock Exchange.

Registered Investment Companies:

CREF Accounts: CREF is registered with the SEC under the Investment Company Act of 1940 as an open-end management investment company. It consists of eight investment portfolios (accounts). The accounts invest principally in equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives. The accounts are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods. Each account determines its unit value daily.

TIAA-CREF Funds: TIAA-CREF Funds is registered with the SEC under the Investment Company Act of 1940 as an open-end management investment company. Current offerings include domestic and international equities, fixed income, real estate securities, asset allocation and money market funds. The funds invest principally in equity securities, fixed-income instruments, other mutual funds, and short-term instruments in accordance with each fund's investment objectives. Fund holdings are generally valued using market quotations or prices obtained from independent pricing sources. Each fund determines its unit value daily.

OneAmerica Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Insurance Contract: This represents the non-benefit-responsive portion of the TIAA Traditional Annuity investment, which is a fixed rate annuity contract. The investment is valued at contract value, which approximates fair value. Contract value equals the accumulated cash contributions, interest credited, and transfers, if any, less any withdrawals and transfers, if any. Quantitative information about significant unobservable inputs for this level 3 investment, were not developed by the Plan and accordingly, have not been included in the financial statements.

Note 5: Investment Contracts with Insurance Companies

TIAA Traditional Annuity (TIAA Traditional) is an unallocated fixed-annuity contract that is fully and unconditionally guaranteed by TIAA. TIAA Traditional provides a guarantee of principal, a guaranteed 3% minimum rate of interest, and the potential for additional interest, if declared by TIAA. Additional interest, when declared, remains in effect for the "declaration year," which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant's account purchase a guaranteed amount of lifetime annuity income. When a participant's account in the TIAA Traditional is converted to an annuity, based on life expectancy, the present value of the stream of payments is equal to the account balance. The subsequent stream of annuity payments occurs outside of the plan and does not represent an obligation of the plan. Terms may apply which impose liquidity restrictions on redemptions of the accumulations account which could impact the value realized upon exiting the contract. TIAA Traditional annuity accumulations are credited with interest based on when contributions and transfers are received, and a participant's performance will vary based upon amounts and timing of funds received. The interest rate applied to contributions for the year ended June 30, 2024 ranged from 4.00% to 5.85%.

Note 5: Investment Contracts with Insurance Companies (Continued)

TIAA Traditional Annuity is valued at contract value which equals the accumulated cash contributions, interest credited, and transfers, if any, less any withdrawals and transfers.

AUL Fixed Interest Account (AUL Stable Value Fund) is an unallocated fixed-annuity contract that is fully and unconditionally guaranteed by AUL. AUL guarantees that interest will be credited at the higher of the rate guaranteed in the group annuity contract and the current rate declared by it. AUL may change the initial interest rate for future contributions that will become effective on January 1 of each calendar year. New contributions are guaranteed to earn the applicable initial interest rate for at least a one-year time period from the date contributions are made. Changes in the initial interest rate or in the interest rate for prior contributions will also be effective for at least one year. In no event will the interest rate ever be below the rate guaranteed in the group annuity contract. The interest rate applied to contributions for the year ended June 30, 2024 was 1.75%.

The TIAA Traditional Annuity and the AUL Fixed Interest Account contracts, both meet the criteria for fully benefit-responsive investment contracts. FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. Certain events limit the Plan's ability to transact at contract value with the issuers, including plan termination and other events as specified in the contracts. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuers are probable of occurring. The contracts do not permit the issuers to terminate the agreements prior to the scheduled maturity dates.

Note 6: Tax Status

The Plan is exempt from federal and state income tax under Section 403(b) of the Internal Revenue Code (IRC). The School adopted a nonstandard prototype document with an IRS notification letter dated March 31, 2017, which states the prototype plan document is in compliance with applicable sections of the IRC.

Income tax filings are subject to audit by the IRS. Open periods subject to audit are generally the previous three years of tax returns filed.

Note 7: Party-in-Interest Transactions

The Plan's assets include investments managed by TIAA-CREF and OneAmerica, the Plan custodians. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes of net assets available for benefits.

Users of these financial statements should be aware that the financial markets' volatility may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments may not necessarily be indicative of amounts that could be realized in a current market exchange.

At June 30, 2024 and 2023, three investment securities represented 50% and 52% of plan net assets, respectively.

Note 9: Plan Termination

Although the School has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate its participation in the Plan subject to the provisions of ERISA.

Note 10: Subsequent Events

The Plan has evaluated subsequent events through January 7, 2025, which is the date the financial statements were available to be issued.
