To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Watkinson School 403(b) Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

In performing an audit in accordance with generally accepted auditing standards, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

June 30, 2024 and 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Watkinson School 403(b) Retirement Plan (the “Plan”) is provided for general information purposes only and is not intended to be a complete description of the Plan. Participants should refer to the Plan document and related amendments for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan, which was formed effective October 1, 1958, and is sponsored by Watkinson School (the “School/Employer”) and available to employees of the Employer. Employees are eligible to participate in the Plan effective on the employee’s first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), Teachers Insurance and Annuity Association of America (“TIAA”) and College Retirement Equities Fund (“CREF”) (the “Trustee”) are third-party administrators for the Plan.

During February 2024, the trustees of the Plan approved a plan merger with the CAIS Multiple Employer Plan, with the CAIS Multiple Employer Plan being the surviving plan. The merger occurred in July 2024. See Note 6 for further information.

Contributions – Participants may elect to tax defer amounts as allowed under the Plan and Internal Revenue Code (the “IRC”). Participants over 50 years old may elect to defer additional amounts as allowed under the Plan and IRC.

For each Plan year, the Employer shall contribute to the Plan a matching contribution equal to a percentage of the participant’s includable compensation according to the following schedules:

For the year ended June 30, 2024, the Employer made matching contributions equal to \$321,520.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, Employer matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants – Participants may borrow against their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The interest rates on the loans range from 4.25% to 9.50%. Principal and interest are paid directly by participants to TIAA and CREF through monthly or quarterly contributions.

For loans initiated before June 30, 2020, TIAA and CREF provided loans directly to participants which are secured by the participant’s vested account balance that is segregated in the participant’s general account but are not distributed from the account. The participant’s vested balance is used to collateralize the participant loan and the funds are transferred, within the Plan assets, to the general account. The amount of Plan assets used to collateralize the loans was \$6,725 and \$13,287 at June 30, 2024 and 2023, respectively. For loans initiated on or after July 1, 2020, the Plan provides for participant loans distributed directly from the participant’s account.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Vesting – Participants are vested immediately in their contributions, Employer matching contributions plus actual earnings thereon.

Payments of Benefits – Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, periodic installments or an annuity distribution available under the applicable funding vehicle. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Withdrawals prior to termination are allowed if participants have reached 59 ½ as described in the Plan document or for hardships subject to Internal Revenue Service regulations.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for certain guaranteed investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan’s valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date-basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – For loans initiated prior to June 30, 2020, the Plan collateralizes loans provided directly to participants by TIAA and CREF. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

Expenses – The Plan is sponsored by the Employer. Certain expenses of maintaining the Plan are paid by the Employer. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards board (“FASB”) *Accounting Standards Codification* (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Insurance Company General Contracts: The value is the accumulated cash contributions, interest credited to the Plan’s contracts, and transfers in (if any) less any withdrawals and transfers out (if any).

Pooled separate account: The value is principally derived from the market value of the underlying real estate holdings and other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values. Securities are generally priced using values obtained from independent pricing sources. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

NOTE 4 – BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan offers three insurance company general contracts, TIAA Traditional Benefit Responsive, TIAA Traditional Benefit Responsive 2, and TIAA Stable Value, which carry a benefit-responsiveness feature that allows Plan participants to make exchanges or request benefit payments at contract value. TIAA and CREF maintains the contributions to the investment in a pooled fund. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals. The guaranteed income account users are contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

These contracts meet the benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA and CREF, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due depends on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including partial or complete Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974 (5) premature termination of the contract. The Plan administrator does not believe that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 5 – RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by TIAA and CREF. TIAA and CREF are the trustees of the Plan therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments as the fees are paid through revenue sharing, rather than a direct payment. TIAA and CREF perform certain administrative, advisory and recordkeeping services for the Plan. As described in Note 2, the Employer pays directly any other fees related to the Plan's operations.

The Plan provides for loans to participants. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

NOTE 6 – PLAN TERMINATION

Effective July 1, 2024, the Plan merged with the CAIS Multiple Employer Plan, and the Employer terminated the Plan subject to the provisions of ERISA. The CAIS Multiple Employer Plan is the surviving plan, and all participant balances were transferred to the CAIS Multiple Employer Plan on July 1, 2024. The Plan has recorded a \$24,770,390 payable to the CAIS Multiple Employer Plan as of June 30, 2024.

NOTE 7 – TAX STATUS

The Plan is designed to constitute a qualified tax-exempt plan under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with sample language provided by the Internal Revenue Service (the “IRS”) in Revenue Procedures 2007-71. The Plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including total investments, at fair value, investments, at contract value, and notes receivable from participants at June 30, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options, in any combination, of specified registered investment companies and other investments. The underlying investments held by the registered investment companies may include stocks, bonds, fixed income securities, registered investment companies and other investment securities. Such investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 10 – SUBSEQUENT EVENTS

The Plan sponsor monitored and evaluated any subsequent events for footnote disclosures or adjustments required in its financial statements for the year ended June 30, 2024 through February 21, 2025, the date on which financial statements were available to be issued.

See Note 6 for a subsequent event related to the merger of the Plan into another plan.
