INDEPENDENT AUDITORS' REPORT

To the Participants and Administrator of

Opinion

We have audited the financial statements of Republic Mortgage Insurance Company and Affiliated Companies Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of August 1, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended August 1, 2024, and the related notes to the financial statements.

Basis for Opinion

Emphasis of Matter – Plan Merger

As discussed in Note 1, the Plan was merged into a successor plan effective August 1, 2024.
