

The financial statements comprise the statements of net assets available for benefits as of October 31, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period of January 1, 2023 through October 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of United Steelworkers of America (USWA) Savings Program – UPI 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control–related matters that we identified during the audit.

Emphasis of Matter

As discussed in Note 1 to the financial statements, United Steelworkers of America (USWA) Savings Program – UPI 401(k) Plan was merged into the USS 401(k) Plan for USW-Represented Employees effective November 1, 2023. In connection with the merger, Plan assets of \$26,758,698 were transferred on October 31, 2023. Our opinion is not modified with respect to this matter.

NOTE 1 – DESCRIPTION OF PLAN

The following description of United Steelworkers of America (USWA) Savings Program – UPI 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, as amended, for a more complete description of Plan provisions.

General – The Plan was a defined contribution plan covering union employees of USS-UPI, LLC (the Company), and was subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company was the Plan's sponsor and served as plan administrator.

In 2020, the Company was acquired by United States Steel Corporation. Effective November 1, 2023, the Plan was merged into the USS 401(k) Plan for USW-Represented Employees. In connection with the merger, Plan assets of \$26,758,698 were transferred out on October 31, 2023.

Administration – The Company had contracted with Empower Annuity Insurance Company (Empower) to act as the custodian for the guaranteed income account and pooled separate accounts held by the Plan, and Prudential Bank & Trust, FSB (Prudential), or its successor, Empower Trust Company, LLC (Empower Trust), to act as the custodians for all other investments.

Eligibility – All union employees covered by a collective bargaining agreement, except leased employees, who had completed six months of service were eligible to make tax-deferred contributions to the Plan.

Contributions

Participant contributions – Each year, participants could contribute up to \$1,000, but no more than 75% of his or her compensation per biweekly payroll, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing pre-tax distributions from other qualified defined benefit or defined contribution plans.

Contributions are subject to regulatory limitations.

Employer contributions – Employees who were hired on or after January 1, 2017, and certain rehires, and were not eligible for retiree health care coverage received a nonelective employer contribution. Each eligible employee received a contribution equal to \$0.70 for each hour worked for the Company during the period of January 1, 2023 through October 31, 2023.

Participant accounts – Each participant's account was credited with the participant's contributions and plan earnings. Administrative expenses charged to participant accounts related to specific participant transactions including distribution and notes receivable fees. The benefit to which a participant was entitled was the benefit that can be provided from the participant's account. Participants directed the investment of their contributions into various investment options offered by the Plan.

A participant's nonelective employer contribution were held in a separate Retiree Health Care Account. Amounts in a participant's Retiree Health Care Account were not available for loans or in-service withdrawals. Upon termination of employment, a participant's Retiree Health Care Account was distributed in accordance with the participant's other accounts.

Vesting – Participants were vested immediately in their contributions and nonelective employer contributions plus actual earnings thereon.

Notes receivable from participants – Participants could borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The maximum of \$50,000 was reduced by the highest outstanding loan balance for a one-year period ending on the day before a new loan was made minus the outstanding balance of existing loans on the date of the new loan. The loans were issued by the Plan and secured by the balance in the participant's account. All loans must have been repaid within a period of five years, unless the loan was used to purchase a principal residence, in which case the loan must have been repaid within a reasonable period of time. Under the terms of the Plan document, plan loans bore a reasonable rate of interest determined by the plan administrator. Principal and interest was paid ratably through payroll deductions.

Payment of benefits – On termination of service due to death, disability, retirement, or other reasons, a participant could have elected to receive a lump-sum amount equal to the value of the participant's interest in his or her account, roll over the balance to another qualified plan, or take a partial distribution. The Plan allowed for the automatic distribution of participant account balances that did not exceed \$1,000.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair and contract value. The Plan's custodians, Empower, Prudential, and Empower Trust, certify the contract value of the guaranteed income account and the fair market value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan document. No allowance for credit losses had been recorded as of December 31, 2022.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events – The Plan has evaluated subsequent events through February 14, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the plan has the ability to access.
- Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Pooled separate accounts: Units held in pooled separate accounts (PSAs) are valued using the NAV practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. PSAs are redeemable daily at NAV.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – GUARANTEED INCOME ACCOUNT

The Plan had a fully benefit-responsive guaranteed income account with Empower. Empower maintains the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer was contractually obligated to repay the principal and specified interest rate that was guaranteed to the Plan. Interest was credited on contract balances using a “single portfolio rate” approach. Under this methodology, a single interest rate was applied to all contributions made to the fund, regardless of the timing of those contributions. The guaranteed minimum interest rate under the contract was 1.50%.

Interest-crediting rates were reviewed on a semiannual basis for resetting. Key factors that could influence future average interest-crediting rates include, but are not limited to: participant-directed cash flows; changes in interest rates; total return performance of the securities underlying the contract; or default or credit failure of any of the securities held by the fund.

Because the guaranteed income account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed income account. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Generally, there were not any events that could limit the ability of a plan participant to transact at contract value. In addition, there were not any events that allow the issuer to terminate the contract or that required the plan administrator to settle at an amount different than contract value.

NOTE 5 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 18, 2015, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – INFORMATION CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, Prudential, and Empower Trust, the custodians of the Plan, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2022.
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the period of January 1, 2023 through October 31, 2023.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by an affiliate of Empower and Empower Trust, custodians of the Plan, and, therefore, transactions with these entities qualified as exempt party-in-interest transactions.
