**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the ITS Technologies & Logistics, LLC Employees Pension Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. If any part of this plan description conflicts with the terms of the plan document, the terms of the plan document will be followed.

General: Established May 20, 2008, the Plan is a defined benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Effective July 31, 2015, benefit accruals under the Plan were frozen for collectively bargained participants whose bargaining agreement does not provide for continued benefit accrual in the Plan. Effective June 30, 2016, the Plan was closed to new participants. Prior to this closure, substantially all full-time, non-union ITS Technologies & Logistics, LLC (Company) employees who met the eligibility requirements of one year of continuous service and 19 years of age were covered by the Plan. Effective June 30, 2021, the Plan was frozen, and accrued benefits no longer increased for service or earnings.

Plan Termination: On December 14, 2023, the Company authorized the termination of the Plan effective December 31, 2023. Pursuant to the Plan's termination, the net assets of the Plan were fully distributed as of August 9, 2024, resulting in the elimination of the Plan's accumulated plan benefits (Note 3).

After paying benefits of \$361,554 through July 2024, by lump-sums and annuities, the Company executed an application for an annuity contract with United of Omaha Life Insurance Company ("United") in July 2024, for United to assume the obligation for remaining annuity benefits due to participants under the Plan. The value of that contract (the net premium paid to United) was \$9,734,619. Additional lump sum payments of benefits directly to participants of \$17,909,978 continued until residual activity and transfer of remaining funds was concluded on August 9, 2024. This residual activity included payment of \$478,864 to the Pension Benefit Guaranty Corporation (PBGC). During 2024, the Plan earned \$102,670 in dividends and interest and paid \$644,934 in administrative and other expenses during liquidation (which includes the aforementioned PBGC payment), which are accrued in the Statement of Net Assets in Liquidation as of December 31, 2023.

Contributions: The Company's funding policy is to make contributions to the Plan to meet minimum funding requirements, as determined by the Plan's independent actuary. Participant contributions are not permitted under the Plan. The minimum funding requirements of ERISA were met for 2024.

Pension Benefits: Participants are entitled to receive normal retirement benefits from the Plan upon attaining the normal retirement age (65) and five years of service. Benefits to be received under the Plan are based on an employee's years of credited service multiplied by a percentage of the employee's average monthly earnings as of the date of retirement. If employees terminate before rendering five years of service, they forfeit the right to receive benefits under the Plan. If employees terminate after rendering five or more years of service but have not attained the normal retirement age (65), they are eligible to receive benefits from the Plan at a reduced level when compared to the normal retirement benefit.

A participant who is not married upon commencement of benefits will receive such benefits in the form of a ten-year certain and life annuity, unless an optional form of payment is elected. A participant who is married upon commencement of benefits will receive such benefits in the form of a 50% qualified joint and survivor annuity, unless an optional form of payment is elected with spousal consent. Optional forms of payment include: single life annuity, five-, ten- or 15-year certain and life annuity, a joint and survivor annuity with varying survivor benefits, or a single lump-sum payment. If an active employee dies after completing five years of service, the surviving spouse is entitled to a death benefit as defined by the Plan. Active employees who have become totally disabled are entitled to receive monthly disability benefits as defined by the Plan.

## NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: Via amendment on December 14, 2023, Company management determined that the Plan would be terminated effective December 31, 2023. As Plan management determined that liquidation would be imminent, the basis of accounting for the Plan was changed from accrual basis of accounting for an ongoing plan as of and for the year ended December 31, 2022, to the liquidation basis of accounting for subsequent periods. These methods of accounting are in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”). There was no material impact to the Plan’s net assets as a result of the application of the liquidation basis of accounting. Note 3 describes the impact to the accumulated plan benefits, in liquidation as a result of the change due to the plan termination.

Investment Valuation and Income Recognition: The Plan’s investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from those estimates. It is reasonably possible that a significant change may occur in the near term for the estimate of actuarial present value of accumulated plan benefits.

Risks and Uncertainties: The Plan invests in various mutual funds and pooled separate accounts. The underlying investments of these mutual funds and pooled separate accounts are exposed to various risks, such as interest rate, market, liquidity and credit risks and global events.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates and employee demographics, all of which are subject to change.

Benefit Payments: Benefit payments are recorded when paid.

Administrative and Investment Management Expenses: The Plan’s actuarial, administrative and consulting fees, as well as Pension Benefit Guaranty Corporation (PBGC) premiums, are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

**NOTE 3 – ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, attributable under the Plan’s provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries; (b) beneficiaries of employees who have died; and, (c) present employees or their beneficiaries. Benefits under the Plan are based on the participant’s years of credited service and fractions thereof multiplied by the percentage of the participant’s average monthly earnings as defined by the Plan. Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

Actuarial present value of accumulated plan benefits is determined by an actuary from Principal and results from applying actuarial assumptions to adjust accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. It is at least reasonably possible that the actuarial assumptions used to calculate accumulated plan benefits will change in the near term, and that the effect of such change could be significant.

The significant assumptions used in the valuation as of December 31, 2023, were on a plan termination basis. Interest rate assumptions for participants taking lump sum payments were based on the IRS 417(e) lump sum segment rates (segment 1 = 5.50%, segment 2 = 5.76%, segment 3 = 5.83%), and for those participants assumed to take annuity payments, the settlement interest rate of 4.45% was used. The mortality table continued to be the Pri-2012 table with Scale MP-2021 for those taking annuities, and the IRS 417(e) mandated table for those taking lump sums. It was assumed that 80% of participants would take a lump sum, and 20% would take an annuity. There were no changes to assumptions for the 2024 valuation.

The actuary performed valuations as of August 9, 2024 and December 31, 2023. The actuarial present value of accumulated plan benefits as of these valuation dates is as follows:

#### **NOTE 4 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the period from January 1, 2024 to August 9, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”), the trustee of the Plan.

#### **NOTE 5 - FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan’s principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2:* Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3:* Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit. Each of the pooled separate accounts, other than the Liquid Assets separate account, invests in a single, open-ended mutual fund which is generally identified in the name of the pooled separate account. The investment strategies of these pooled separate accounts are consistent with each of the mutual funds identified in the name of the fund. The Liquid Assets separate account invests mainly in short-term securities such as commercial paper that provides for liquidity and short-term income.

**NOTE 5 - FAIR VALUE MEASUREMENTS (Continued)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no investments held as of August 9, 2024. Investments measured at fair value as of December 31, 2023 on a recurring basis are summarized below:

**NOTE 6 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated March 30, 2018 indicating that the volume submitter document adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan has been amended, however, Plan management believes the Plan, as amended, is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, Plan management believes that the Plan has been and is qualified and the related trust has been and is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 9, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Other expenses, including fees paid to the plan recordkeepers, auditors, and plan consultant, are paid by the Plan and are considered party-in-interest transactions. The Plan holds units of pooled separate accounts managed by the Plan's recordkeepers or affiliates thereof. These investments and transactions therein qualify as party-in-interest transactions.

**NOTE 8 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through February 14, 2025, which is the date the financial statements were available to be issued.
