### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of CHS Therapy, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits in liquidation as of August 14, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits in liquidation for the period January 1, 2023 through August 14, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 14, 2023 and for the period January 1, 2023 through August 14, 2023 and as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

As further discussed in Note 1 to the financial statements, the Plan Sponsor (“CHS Therapy, LLC and affiliated entities”) of the CHS Therapy, LLC 401(k) Plan approved a plan of liquidation on October 28, 2022 and determined that liquidation was imminent. As a result, CHS Therapy, LLC 401(k) Plan changed its basis of accounting to the liquidation basis. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. ### 1. Description of the Plan:

The following brief description of the CHS Therapy, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan was a defined contribution 401(k) profit sharing plan that began January 1, 2020, with the latest adoption agreement executed August 10, 2020. The Plan covers all eligible employees of CHS Therapy, LLC and affiliated entities (collectively the "Company" and "Plan Sponsor"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan year was January 1 through December 31. The Company's Board of Trustees was responsible for oversight of the Plan including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

#### Plan termination and liquidation:

On October 28, 2022, the Company elected to terminate the Plan effective February 1, 2023, the termination date (see Note 10). As directed by participants, from February 1, 2023 through August 14, 2023 the Plan's assets totaling \$16,039,831 were rolled over into other plans, rolled over into individual retirement accounts or distributed directly to participants. These liquidating distributions were included in benefits paid to participants on the period January 1, 2023 through August 14, 2023 statement of changes in net assets available for benefits in liquidation.

#### Contributions:

Participants could elect to contribute up to 100% of their compensation (which may not have exceeded annual dollar limits established by the Internal Revenue Service) into the Plan on a pre-tax or post-tax (Roth) basis. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Discretionary employer matching contributions could be made at the discretion of the Company. The Company made discretionary employer matching contributions equal to 50% of the first 3% of compensation deferred by participants for the period January 1, 2023 through February 1, 2023 (termination of Plan) and for the year ended December 31, 2022.

Additional discretionary employer contributions could be made at the discretion of the Company. There were no additional discretionary employer contributions made in 2023 and 2022.

#### Participant accounts:

Each participant's account was credited with employer and participant contributions. Plan earnings were allocated based upon account balances.

## 1. Description of the Plan (continued):

### Participant accounts (continued):

Separate accounts for each participant were maintained by Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC ("Great-West"), the trustee of the Plan. Income was allocated to participant accounts based on participant account balances and the earnings of the investments. Participants could direct their contributions, including the employer portion, into a number of investment options.

### Vesting:

Participants were immediately vested in the value of their account attributable to the participant contributions. Participants vested in discretionary employer matching and discretionary employer contributions in accordance with the following schedule:

Effective February 1, 2023, upon termination of the plan all participants became 100% vested in all employer contributions.

Forfeitures of nonvested accounts could be used to pay administrative expenses of the Plan and to reduce future employer contributions. Forfeitures totaling \$88 and \$5,671 were used to pay administrative expenses and to offset discretionary employer matching contributions during 2023 and 2022, respectively. Unallocated forfeitures amounted to \$259,196 at December 31, 2022. During 2023, unallocated forfeitures totaling \$271,443 were allocated to participants prior to liquidation of the Plan.

### Payment of benefits:

Participants could elect to withdraw all or a specified portion of their contributions prior to their termination of employment subject to certain restrictions under the Plan. Participants who suffered serious financial hardship, as defined by the Plan, could withdraw a portion of their vested account in order to meet their financial needs. Once participants attained age 59 ½, they could also elect to withdraw from their account, any amount not to have exceeded their vested portion. All accounts were subject to distribution upon the participant's termination, retirement or death and would be distributed in a single lump sum.

Benefits were recorded when paid.

### 2. Summary of significant accounting policies:

#### **Basis of accounting:**

As a result of the Company's decision on October 28, 2022 to terminate the Plan effective February 1, 2023, the liquidation basis of accounting was used in presenting the statement of net assets available for benefits in liquidation and the statement of changes in net assets available for benefits in liquidation as of and for the period January 1, 2023 through August 14, 2023 and the year ended December 31, 2022.

#### **Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates and assumptions.

#### **Notes receivable from participants:**

Participants considered active employees with a minimum vested account balance of \$2,000 could borrow from their accounts. The minimum note was \$1,000 to a maximum equal to the lesser of \$50,000 or 50 percent of the vested account balance. Repayment of a note must have been made over a period not to have exceeded five years, unless the note was used to purchase a principal residence, in which case the note must have been repaid over a period not to have exceeded thirty years. The notes were secured by the balance in the participant's account and bore interest at the prime rate published in the Wall Street Journal on the first business day of the month the note was originated. The interest rate was fixed for the life of the note. The notes bore interest between 3.25% and 7.00% at December 31, 2022.

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on an accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of December 31, 2022. If a participant ceased to make note payments and the plan administrator deemed the note receivable to be in default, the note receivable balance was reduced, and a benefit payment was recorded.

#### **Investment valuation and income recognition:**

At December 31, 2022, the Plan maintained investments with Great-West for the guaranteed investment contract and the mutual funds. The guaranteed investment contract was the insurance company's guarantee backed by the underwriting insurance company's general asset account.

The mutual funds were recorded at fair value, which was determined by quoted market prices, as provided by Great-West at December 31, 2022. The guaranteed investment contract was recorded at contract value. The contract value was determined by Great-West which was the value of the fund as of the last business day in the plan year plus any accrued interest through the last day of the plan year.

#### Investment valuation and income recognition (continued):

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis and dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments included the Plan's gains and losses on investment bought and sold as well as held during the year.

#### Plan expenses:

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Investment related expenses were included in net appreciation (depreciation) in fair value of investments on the statements of changes in net assets available for benefits in liquidation. These transactions qualified as party-in-interest transactions.

### 3. Investments:

There were no participant directed investments at August 14, 2023. The following table represents the value of participant directed investments at December 31, 2022:

### 4. Fair value:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- The fair value of the mutual funds was based on the daily closing price as reported by the fund. Mutual funds held by the Plan were open-ended mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Plan net assets at fair value as of August 14, 2023. The following table sets forth, by level, within the fair value hierarchy, the Plan's net assets at fair value as of December 31, 2022:

### 5. Investment contract with insurance company:

The Plan participates in a fully benefit-responsive investment contract with the Great-West Key Guaranteed Portfolio Fund. Great-West maintains the contributions in a separate account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

Contract value, as reported to the Plan by Great-West represented contributions made under contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### 5. Investment contract with insurance company (continued):

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates were reviewed on a quarterly basis for resetting.

Certain events limited the Plan's ability to transact at contract value with Great-West. Such events included the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan was terminated in February 2023 and the guaranteed investment contract has been presented at its liquidation value.

The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The following were average yields on the guaranteed investment contract for the period January 1, 2023 through August 14, 2023 and the year ended December 31, 2022:

### 6. Plan administrative expenses:

Certain administrative expenses were paid by the Plan Sponsor. Certain administrative functions were performed by employees of the Company. No such employee, nor the Company, receives compensation from the Plan for these functions. These transactions qualified as party-in-interest transactions. In addition, the Plan received revenue sharing amounts from certain mutual funds used to pay Plan expenses. These revenue sharing amounts were netted against administrative expenses totaling \$24,471 in 2023 and \$32,103 in 2022.

### 7. Certified investments:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2022, and net appreciation (depreciation) in fair value of investments and interest and dividends for the period January 1, 2023 through August 14, 2023 and the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Great-West (trustee of the Plan).

**8. Income tax status:**

The Internal Revenue Service has determined that the prototype plan under which the CHS Therapy, LLC 401(k) Plan was organized and was designed in accordance with applicable sections of the Internal Revenue Code (Code). The Plan was required to operate in conformity with the Code to maintain its qualification and the prototype plan received a favorable determination letter from the Internal Revenue Service dated June 30, 2020.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.

**9. Party-in-interest transactions:**

The guaranteed investment contract was managed by Great-West, who was the trustee of the Plan as of December 31, 2022, and, therefore, these transactions qualify as party-in-interest. Direct fees paid by the Plan to Great-West for record keeping services amounted to \$269,426 in 2023 and \$95,414 in 2022. The plan issued notes to participants, which were secured by the vested balance in the participant's account, and certain of the Plan's investments were managed directly by Great-West, the trustee. These transactions qualify as party-in-interest transactions.

**10. Plan termination:**

The Plan Sponsor had the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. On October 28, 2022, CHS Therapy, LLC elected to terminate the Plan effective February 1, 2023. Final distributions were determined on all participants being 100% vested upon the termination date. In accordance with U.S. GAAP, the Plan changed its basis of accounting from the ongoing plan basis to the liquidation basis in 2023 and 2022.

**11. Prohibited transactions:**

During 2022, there were employee contributions totaling \$276 that were not remitted within the time limit prescribed by the Department of Labor. The Plan Sponsor is responsible for correcting the delinquent contributions, including any related lost earnings.

Additionally, during 2023 and 2022, the vesting percentage for certain individuals were incorrect resulting in discretionary matching contributions for participants being improperly forfeited. The Plan Sponsor calculated \$401 and \$214 of improper forfeitures and will process distributions to the impacted employee during 2023 and 2022, respectively. The Plan Sponsor is responsible for correcting the improper forfeitures.

**12. Subsequent events:**

In preparing these financial statements, the Plan's management has evaluated events and transactions for potential recognition or disclosure through January 27, 2025, the date the Plan's financial statements were available to be issued.
