#### **Note 1 – Plan Description**

The following is a brief description of the Access Rehab Centers, LLC 401(k) Plan (the Plan”). Participants should refer to the Plan Agreement for more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering employees of Access Rehab Centers, LLC (the “Company”). Employees become eligible to make elective deferrals on the first day of the calendar month, coincident with or next following the date upon attaining age 21 and after completing three months of service, provided that they are an eligible employee at the end of that period. The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### **Contributions**

Each year, participants may make voluntary, pre-tax savings contributions and after-tax Roth contributions, as defined in the Plan. Participants may elect to defer up to 100% of any bonus paid during the year. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans at the discretion of the administrator. The maximum voluntary, combination pre-tax contribution and after-tax Roth contribution permitted by law was \$23,000 and \$22,500 for 2024 and 2023, respectively, per participant. Participants who are at least age 50 by the end of the year, were allowed to contribute an additional \$7,500 for 2024 and 2023. The Plan includes various tests required under ERISA, which could have the effect of limiting contributions of highly paid employees.

The Company has the option to make a discretionary matching contribution. Currently, this match is equal to fifty percent of the amount of the salary reduction that employees defer, up to a maximum of six percent. Participants are eligible to receive the matching contributions if they have worked 1,000 hours in the respective plan year, or any preceding year.

The Company may make a discretionary profit sharing contribution for all participants, except per diem employees. Participants must complete a year of service during the Plan year and be actively employed on the last day of the year in order to share in the discretionary profit sharing contribution. To date, no discretionary profit-sharing contributions have been made to the Plan.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contribution and rollover contribution, the allocation of the Company’s contribution and Plan earnings, and charged with certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contribution, plus actual earnings, at all times and shall not be subject to forfeiture for any reason. Participants who were hired prior to July 1, 2005, are also 100% vested in the employer matching and discretionary profit-sharing contribution.

Vesting in employer matching and discretionary profit-sharing contributions and the earnings thereon for employees hired after July 1, 2005 is based upon years of service according to the following schedule:

Less than two years	0%
Two years, but less than three years	25%
Three years, but less than four years	50%
Four years, but less than five years	75%
Five years or more	100%

Effective October 1, 2010, for participants that are credited with at least one hour of service, the vesting schedule for employer contributions has been revised to:

Less than one year	0%
One year, but less than two years	25%
Two years, but less than three years	50%
Three years, but less than four years	75%
Four years or more	100%

The interest of each participant in his/her matching contribution account is 100% vested upon attainment of normal retirement age while an employee, death while an employee, or disability while an employee.

**Notes Receivable From Participants**

Subject to terms and conditions imposed by applicable tax regulations, participants may borrow from their fund accounts a minimum of \$1,000, and up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. However, loans may not be made from the portion of a member's account that is derived from Roth contributions. Loan terms range from one to five years, or up to fifteen years, if used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest ranging from 3.299% to 8.5%. Principal and interest is paid ratably through a payroll deduction. A loan default resulting in a taxable distribution (and early withdrawal penalties) will occur if payment is not made by the end of the calendar quarter following the calendar quarter in which the payment was missed.

**Retirement**

Normal retirement is defined as age 65. The participant may elect to receive the retirement benefits in a lump sum, or alternate form of payment, as permitted in the Plan.

**Payment of Benefit**

Upon retirement, hardship or termination, or for termination of service for other reasons, vested benefits can be distributed in either a lump sum benefit or an alternative form of payment, as permitted under the Plan. If the participant’s vested benefit does not exceed \$1,000, the Plan Administrator may direct the custodian to distribute, in a lump sum payment, the participant’s vested benefits.

**Forfeited Accounts**

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$1,748 and \$62, respectively, and employer contributions paid were reduced by \$944 and \$1,628 in 2024 and 2023, respectively. Nonvested amounts treated as forfeitures are to be used to reduce future Company contributions.

**Investment Options**

Contributions are invested according to the options elected by the participants among the then available investment options. The investment options include various mutual funds, pooled separate accounts, and a stable value option, which provide participants the opportunity to select from various returns on investment alternatives.

At Reliance Trust Company, transfers out of an account are allowed at any time, and transfers into a pooled separate account may be restricted only if a participant engages in trading patterns which are detrimental to the pooled separate account.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to report at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount that they would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan’s investments are reported at fair value (except for fully benefit-responsive investment contracts, which are recorded at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 and Note 5 for discussion on value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year. Interest and dividend income is included with net appreciation in fair value of pooled separate accounts.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Costs**

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan sponsor. Fees related to the administration of notes receivable from participants are charged directly to the participants’ accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Note 3 – Information Prepared and Certified By the Plan’s Custodian**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company for Transamerica Retirement Solutions, LLC (Transamerica), the custodian of the plan has certified to the Plan administrator, as of and for the years ended September 30, 2024 and 2023 the following information is complete and accurate, which can be relied upon by the Plan administrator in preparation of the Plan’s financial statements and related supplemental schedule.

**Investments**

- The cost, fair value and/or contract value; and
- The purchase and sale activity, including gains and/or losses.

**Investment Income**

- The amount of interest and dividend income received;
- Net appreciation in the fair value of investments credited to the Plan, in total and by fund; and
- The amount of income from stable value accounts.

**Note 4 – Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 Fair Value Measurements and Disclosure provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Mutual Funds*

The fair value of mutual funds is based on the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts*

Pooled Separate Accounts (PSAs) – Transamerica Retirement Solutions, LLC (Transamerica), typically invests exclusively in one underlying mutual fund traded on an established market. As such, the PSAs begin with a price determined by Transamerica, and the number of units issued are calculated to match the current fair value of the underlying mutual fund holdings. Transamerica’s PSA choices are valued daily using publicly available quoted market prices, and the participants bear the investment risks.

Those PSAs investing in mutual funds or domestic equity securities are measured using quoted prices in active markets for identical assets (Level 1 input under ASC 820). Those PSAs directly investing in fixed maturity securities are measured based upon the pricing data provided by outside valuation service providers who, in turn, use the mean of the bid and ask prices, but may also use alternative observable pricing inputs for certain securities (Level 2 input under ASC 820)

**Note 5 – Group Annuity Contract with Transamerica Life Insurance Company**

In 2015, the Plan entered into a stable value investment choice with Transamerica that is fully benefit-responsive totaling \$469,912 and \$462,451 at September 30, 2024 and 2023, respectively. Transamerica maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Interest is credited based upon a stated rate for a six-month period, effective January 1, and July 1 based upon the daily balance at a rate that is the daily equivalent annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate.

The stable value investment option meets the fully benefit-responsive investments contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial termination or merger with another plan), (2) bankruptcy of the Plan Sponsor, (3) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (4) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

**Note 6 – Related Party Transactions and Party-in-interest Transactions**

Certain Plan investments are shares of a group annuity accounts managed by Transamerica Retirement Solutions, LLC. Reliance Trust Company is the custodian and the record-keeper of the Plan, and, therefore, these transactions qualify as party-in-interest.

**Note 7 – Tax Status**

The Plan has received a determination letter from the Internal Revenue Service, dated March 31, 2008, that the Plan is qualified, under the Internal Revenue Code (“IRC”), and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**Note 8 – Plan Terminations**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

**Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.


