**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the ERISK 401(K) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a multiple employer defined contribution plan. The Plan was established for eligible worksite employees of Employer's Risk Administrators, LLC and its affiliates: Accord Marketing and Management, Inc., Ken Block Consulting, Haight Construction Services, Inc., MedCon Benefit Systems Group, Inc., and Premier Health Solutions, Inc. (collectively, the Company). The Plan document includes a participation agreement (the Participation Agreement) for each Covered Entity, as defined by the Plan, that indicates which of certain varying provisions of the Plan, such as eligibility and employer contributions, apply to certain employees. In March 2023, the Company announced its sale to Employer Flexible HR Holdings, LLC. Plan participants were given the option to take a distribution of his or her balance from the Plan or transfer it to his or her balance at the Employer Flexible Inc. 401(K) Plan. During 2023 and 2024, Plan assets of approximately \$4,610,016 and \$5,839,334 were transferred to the Employer Flexible Inc. 401(K) Plan, respectively. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**PLAN TERMINATION**

Due to the Company's sale to Employer Flexible HR Holdings, LLC. in 2023, the Company ceased all contributions into the Plan, and management determined that termination of the plan was imminent and adopted the liquidation basis of accounting effective December 31, 2023. A formal resolution to terminate was made and the Plan completed its termination effective October 31, 2024. All assets of the Plan have been transferred or distributed out of the plan as of October 31, 2024.

**ELIGIBILITY**

Pursuant to the election set forth in each of the applicable Participation Agreements, certain worksite employees are eligible to participate in the Plan. There are 5 eligibility options offered in the Plan. The eligibility period applicable is based on the eligibility requirements of the employers. The eligibility options available are: 1) Age 21 with entry immediately upon eligibility; 2) Age 21 with 12 months of service (elapsed time) with entry immediately upon eligibility; 3) Age 21 and 12 months of service (elapsed time) with entry on January 1 or July 1 coinciding with or next following the date requirements are met; 4) Immediate enrollment upon employment with entry upon eligibility; and 5) 2 months of service with entry on the first day of the Plan quarter coinciding with or next following date requirements.

Effective December 31, 2023, the plan was not open to new participants.

**CONTRIBUTIONS**

Effective December 31, 2023, contributions were no longer allowed within the Plan. All participant and employer contributions accrued up to the freeze date were remitted to the Plan during the year ended December 31, 2023.

Prior to December 31, 2023, participants could elect to contribute a percentage of compensation as defined by the Plan with a limit as defined by ERISA. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified plans (rollovers). Participants are also permitted to make Roth 401(K) deferrals. Participants direct the investment of their contributions into various investment options offered by the Plan. Pursuant to the elections set forth in each of the applicable Participation Agreements, eligible employees may receive one or more of the following types of Company contributions: (a) safe harbor matching contributions of 100% of the first 3% of employee deferrals and 50% of the next 2% of deferrals, (b) safe harbor 3% nonelective contribution to each eligible participant in the Plan year, and (c) discretionary profit-sharing contributions. During the period January 1, 2024 through October 31, 2024, Company safe harbor and profit-sharing contributions totaled \$-.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contributions and the Company's contributions. Allocations of Plan earnings and administrative expenses are based on participant account balances as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants are immediately vested in their contributions and the Company's safe harbor contribution plus actual earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts plus actual earnings thereon is based on the applicable Participation Agreements. As of December 31, 2023, all participants were 100% vested in the plan due to plan termination.

Prior to December 31, 2023, the vesting options available were: 100% vesting or vesting based on years of continuous service as follows:

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow amounts from the Plan subject to the provisions of the Plan. The notes are secured by the balance in the participant's account and bear interest at an index of one percent (1%) over the prime interest rate at the time the note is granted. Principal and interest is paid ratably through payroll deductions. As of October 31, 2024, all note balances were either transferred or netted from account distribution.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability, normal retirement age, and other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Hardship distributions are permitted from elective deferrals. In-service distributions are permitted from vested accounts based on certain Plan provisions. Participants can elect to receive their distributions either in cash or as a direct rollover to another tax-qualified plan. As of October 31, 2024, all participants accounts were either distributed or transferred from the Plan.

**FORFEITED ACCOUNTS**

At October 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$10,829 respectively. Forfeitures may be used to pay administrative fees or reduce discretionary employer contributions. During the Plan period January 1, 2024 through October 31, 2024, no forfeitures were used to pay administrative fees or reduce employer contributions. The remaining forfeiture balance was transferred out of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

As discussed in Note 1, the financial statements of the Plan were prepared on the liquidation basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2024 and 2023.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant loans and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net investment appreciation (depreciation) on the statement of change in net assets in liquidation.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lower priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED**

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. As such, Slavic Integrated Administration, Inc., the third-party administrator is considered a party-in-interest. The Plan holds units of certain mutual funds managed by the custodian. Fees paid to the custodian and other service providers are party-in-interest transactions and are included in administrative expenses or net appreciation (depreciation) of fair value of investments in the statement of changes in net assets available for benefits. The Plan paid \$14,201 of administrative expenses to the custodian for the period January 1, 2024 through October 31, 2024. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 5 - PLAN TERMINATION**

Effective December 31, 2023, The Company discontinued its contributions and determined that liquidation was imminent. A formal resolution to terminate has been made and the Plan has been terminated effective October 31, 2024. All assets of the Plan have been transferred or distributed out of the plan as of October 31, 2024.

**NOTE 6 - TAX STATUS**

The Plan Sponsor has adopted a volume submitter multiple employer Plan which received a favorable opinion letter from the IRS that the form of the Plan is acceptable under Section 401(a) of the IRC.

The Plan Administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

**NOTE 6 - TAX STATUS - CONTINUED**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan's returns for the past three years are subject to examination by tax authorities and may change upon examination.

**NOTE 7 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through February 13, 2025, the date the financial statements were available to be issued.
