Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of May 16, 2024, December 31, 2023 and 2022, and for the period from January 1, 2024 to May 16, 2024 and year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified to by institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following is a summary of certain provisions of the Fasteners for Retail, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"). Participants should refer to the Plan document for more complete information.

General:

The Plan is a defined contribution plan covering certain employees of Fasteners for Retail, Inc. and subsidiaries (the "Company"), who meet the minimum age and service requirements. Employees become eligible to participate in the Plan after attaining age 18 and three months of service are attained. This eligibility becomes effective on the first day of each month of the Plan year immediately following or coincident with attaining these requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Company was acquired by a third party in September 2022. Employees continued to participate in the Plan until June 2023 at which time they began participating in a Pooled Employer Plan ("PEP") sponsored by the acquiring company. On June 29, 2023, \$36,022,970 was merged into the PEP which excluded the existing group annuity contract. On May 16, 2024, the Plan was liquidated by rolling the remaining group annuity contract balance of \$1,807,227 into the PEP.

Contributions:

Participants may make pre-tax or Roth 401(k) contributions of an amount up to 100% of their compensation, subject to certain limitations imposed by the Internal Revenue Service ("IRS"). The Plan also provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make catch-up contributions, subject to certain IRS limitations. The Plan has an automatic contribution arrangement in which employees are automatically enrolled when they become eligible. Unless otherwise directed by the participant, 6% of compensation is withheld and invested in the Plan in a qualified default investment alternative. The Company may make discretionary matching, safe harbor non-elective or discretionary non-elective contributions to all eligible participants. Discretionary matching contributions were at a rate of 50% of each participant's deferral up to 6%, with a maximum match of 3% in 2023. Safe harbor non-elective contributions were equal to 3% of participants' compensation. Employer matching contributions earned through June 30, 2023 were funded into participant accounts in the Plan. Safe harbor contributions related to 2023 but not earned until after June 30, 2023 were funded into participant accounts in the PEP. No discretionary non-elective contributions were made in 2023.

Rollovers:

Participants may also contribute amounts representing distributions from other qualified plans.

Participant Accounts:

Each participant's account is credited with the participant's contribution, Company contributions, and related earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note 1. Description of Plan (Continued)

Vesting:

Participants have a 100% non-forfeitable vested interest in their voluntary contributions, employer safe harbor contributions, and earnings thereon. Vesting in the Company's discretionary matching contribution and discretionary non-elective contribution portions of their accounts is based on years of continuous service. A participant is 100% vested after three years of service (0% in years one and two, 100% in year three), or in the event of death, disability, or attaining normal retirement age as defined by the Plan.

Payment of Benefits:

Upon termination of employment, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the participant's account balance is less than \$5,000, the plan administrator directs Empower Trust Company, LLC (the "Trustee") and Empower Annuity Insurance Company of America (the "Custodian") to make a lump-sum distribution. The Plan also provides for in-service distributions upon attaining age 59½, normal retirement age, disability, and hardship withdrawals, subject to certain limitations.

Forfeitures:

The Plan may utilize forfeitures to offset the Plan's administrative expenses or to reduce future Company contributions, at the Company's discretion. The Plan did not use forfeitures to offset Company contributions in 2023. At December 31, 2023 and 2022, \$478 and \$56,121, respectively, remained as unallocated forfeitures.

Notes Receivable From Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to the extent of one-half of their vested account balance under the Plan, not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate. Principal and interest is paid ratably through payroll deductions.

Note 2. Summary of Accounting Policies

- A. Basis of Presentation – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note 2. Summary of Accounting Policies (Continued)

B. Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the Trustee and Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the settlement-date basis. Interest and dividend income are recorded when received. There is no significant difference between the settlement-date and trade-date basis for the periods presented. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

C. Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document. A reserve for credit losses of \$41,811 was recorded at December 31, 2022.

D. Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

E. Payments of Benefits – Benefits are recorded when paid.

F. Administrative Expenses – Administrative expenses of the Plan are paid by the Company or the Plan at the option of the Company. Administrative expenses may be offset with funds made available by the Plan Trustee or Custodian from fees it received from investment fund managers. Participants who elect to receive a distribution or take a loan are charged a processing fee.

G. Subsequent Events – The Plan has evaluated subsequent events through February 20, 2025, the date the financial statements were available to be issued.

Note 3. Unaudited Information

Empower Trust Company, LLC and Empower Annuity Insurance Company of America hold the Plan's investment assets and execute transactions therein. The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America have certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the statements of net assets available for benefits at May 16, 2024, December 31, 2023 and 2022, the supplemental schedule at December 31, 2023, the related investment and loan interest activity reflected in the statements of changes in net assets available for benefits for the period from January 1, 2024 to May 16, 2024 and for the year ended December 31, 2023, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note 4. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodology used for plan assets measured at fair value:

- The fair value of registered investment companies is determined based on their quoted closing market prices in active markets for identical investments, and is classified as Level 1.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There were no changes in the methodology used from 2022 to 2024. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Group Annuity Contract

Investments in the Key Guaranteed Portfolio Fund meet the fully benefit-responsive investment contract criteria and are, therefore, reported at contract value as determined by the Key Guaranteed Portfolio Fund and certified by the Custodian.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on several factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula and are reset annually as determined by the Custodian. The crediting interest rate is guaranteed to be at least 1%.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note 6. Income Tax Status

The pre-approved document on which this Plan is based obtained an opinion letter, dated June 30, 2020, from the IRS, in which the IRS stated that the pre-approved document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since the pre-approved document was adopted, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, it believes that the Plan is qualified and the related trust is tax-exempt through the date of liquidation.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of May 16, 2024, there are no uncertain tax positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 7. Party-in-Interest Transactions

Certain Plan investments were held in a group annuity contract or registered investment companies of the Custodian or its affiliates. Also, administrative expenses were paid to the Trustee and Custodian during the year ended December 31, 2023. Empower Trust Company, LLC may also receive revenue sharing income from fund service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for administrative services to the Plan. Revenue sharing income totaling \$52,484 was received by the Plan during the year ended December 31, 2023 and is included in net appreciation in fair value of investments, net with expenses of \$19,780. The remaining \$32,704 was unallocated at December 31, 2023. These qualify as party-in-interest transactions.

Note 8. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
