1. PLAN DESCRIPTION:

The following description of the Dallas Theological Seminary Retirement Savings Plan (the Plan), formerly the Dallas Theological Seminary Profit Sharing Plan, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

GENERAL

The Plan was made effective July 1, 2003, and is a defined contribution plan. Prior to July 1, 2020, employees became eligible on the enrollment date (either January 1 or July 1) coinciding with or following the date they attain the age of 21 and have completed 1,000 hours in one year of service. Beginning July 1, 2020, employees are eligible if they are regularly scheduled to work more than 1,000 hours in a year and are age 21 and do not fall into the excludable categories.

CONTRIBUTIONS

Effective July 1, 2020, participants may contribute up to 75% of annual compensation, as defined in the Plan and subject to the annual limits of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Also effective July 1, 2020, the Plan auto-enrolls all eligible employees at 3% of eligible compensation, as defined in the plan document. The Plan auto-escalates the deferral percentage 1% annually at the beginning of the plan year until the deferral percentage reaches 6%. Dallas Theological Seminary (the employer), at its discretion, may make contributions to the Plan for amounts determined by the employer. Employer contributions are invested in a portfolio of investments, as directed by the employer.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and an allocation of (1) the employer's contribution and (2) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions and related earnings shall be vested in accordance with the following schedule based on completed years of service. A completed year of service for vesting purposes will be 1,000 hours of service during a plan year. The participant will always be 100% vested upon the normal retirement age.

1. PLAN DESCRIPTION, continued:

PAYMENT OF BENEFITS

The participants are entitled to 100% of their account balance in four ways: (1) distribution of benefits upon normal retirement age as defined in the Plan document; (2) distribution of benefits upon late retirement as defined in the Plan document; (3) distribution of benefits upon death as defined in the Plan document; or (4) distribution of benefits upon disability as defined in the Plan document. For termination of service for any other reasons, a participant is entitled to receive only the value of the vested interest in his or her account and the remainder non-vested interest is forfeited, in accordance with the applicable provisions of the Plan document.

FORFEITURES

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeited amounts may be used to reduce employer contributions to the Plan or to pay expenses of the Plan. Forfeitures in the amount of \$3,975 and \$19,334 were used to reduce employer contributions for the years ended June 30, 2024 and 2023, respectively. There were no unused forfeitures as of June 30, 2024 or 2023.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements, the changes in net assets available for benefits during the reported period and, when applicable, the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

BENEFIT PAYMENTS

Benefit payments are recorded in the period in which they are distributed. Required minimum distributions were adjusted in accordance with the SECURE Act effective January 1, 2020.

3. FAIR VALUE MEASUREMENTS:

ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs, other than the quoted prices in active markets, are observable either directly or indirectly, and Level 3 unobservable inputs in which there is little or no market data, which requires the Plan to develop its own assumptions. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Mutual funds in the Plan use Level 1 inputs for measurement. Mutual fund shares are primarily valued using market quotations or prices obtained from independent pricing sources. Certain domestic fixed income funds are valued using the market value of the underlying investments, which are publicly traded securities and investment contracts, and are considered Level 2 inputs.

5. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. FEDERAL INCOME TAX STATUS:

The Internal Revenue Service has determined and informed the Seminary by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

7. PARTY-IN-INTEREST TRANSACTIONS:

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, and party rendering services to the Plan, the employer, and certain others. As such, transactions conducted by the custodian qualify as party-in-interest transactions. The Plan Sponsor has absorbed the majority of the costs of all normal party-in-interest transactions. Direct fees paid to Mercer for investment advisory services were \$21,272 and \$20,587 for the years ended June 30, 2024 and 2023, respectively. Direct fees paid to Milliman for recordkeeping services were \$34,217 and \$68,427 for the years ended June 30, 2024 and 2023, respectively. Indirect fees are netted against appreciation on investments and range from .05% to .40%.

8. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their accounts.

9. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through January 31, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.

For the Plan Year beginning July 1, 2024, and ending June 30, 2025, the employer retroactively adopted a nonelective contribution safe harbor amendment. The employer will make a safe harbor nonelective contribution of 5% of a participant's compensation for the entire plan year. No additional matching contributions are made to the Plan. These contributions are fully vested to the participant. These amendments establish the Plan as a 401(k) plan (as described in Code §412(k)(12). Effective October 1, 2024, all nonparticipant-directed investments were transferred into each participant's participant-directed account balance. Participants have the right to direct the investment in any of the Plan's investment choices.
