## INDEPENDENT AUDITOR'S REPORT

**NOTE 1 - DESCRIPTION OF THE PLAN**

---

The following description of the Shelby Residential & Vocational Services, Inc. (the “Company”) 401(k) & Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**Plan Merger**

On November 1, 2023, an amendment was approved to merge the Plan into the Inperium & Family of Services 401(k) Plan. All participants in the Plan were credited for their years of service and followed vesting rules discussed in Note 1. Upon merger, all participants’ account balances transferred into the Inperium & Family of Services 401(k) Plan. The Plan received contributions through October 2023, and an aggregate \$1,439,537 transferred out of the Plan on November 1, 2023, which are included in the transfer to Inperium & Family of Services 401(k) Plan on the statement of changes in net assets available for benefits. The following provisions described in the description of the Plan were in effect prior to the Plan merger.

**General**

The Plan was a defined contribution plan covering all full-time employees of the Company, other than those specifically excluded, who had one year of service and were age twenty-one or older. Entry dates were the first day of the plan year quarter coinciding with or next following the date eligibility requirements were met. The Plan was subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Administrative Committee was responsible for oversight of the Plan, determined the appropriateness of the Plan’s investment offerings, and monitored investment performance.

**Contributions**

Each participant could elect to have compensation deferred by up to the annual maximum amount allowable by the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Company could make a discretionary matching contribution. The Plan’s discretionary matching contribution provisions were retroactively amended solely for the 2022 and 2023 plan years. The discretionary matching contribution for the 2022 and 2023 plan years was the greater of 50% of elective deferrals up to 3% of compensation each pay period, not to exceed \$1,500 in the aggregate for the plan year, or the actual matching contribution amount allocated under the Plan each pay period on behalf of such participant for the plan year. Additionally, the Company could make a discretionary profit-sharing contribution to the Plan. Discretionary profit-sharing contributions made by the Company for a plan year were allocated in the same ratio as each participant’s compensation bears to the total of such compensation of all participants. There was no discretionary profit-sharing contribution made as of November 1, 2023. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account was credited with the participant's contributions, the Company's discretionary matching contribution, the Company's discretionary profit-sharing contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Vesting**

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion to the participant's account was based on years of continuous service. A participant was 100% vested after three years of credited service. Participants became 100% vested in all amounts upon death, disability, or retirement.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account as set forth in the Plan. For termination of service for other reasons, a participant could receive the value of the vested interest in their account as a lump sum distribution.

**Forfeited Accounts**

At November 1, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$5, respectively. These amounts could have been used to reduce discretionary match contributions, discretionary profit-sharing contributions, or pay administrative fees. During the period ended November 1, 2023, \$519 of administrative fees were paid from forfeited accounts.

**Basis of Accounting**

The financial statements of the Plan were prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements, in accordance with accounting principles generally accepted in the United States of America, required management to make estimates and assumptions that affected the reported amounts of the assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determined the Plan's valuation policies utilizing information provided by the investment advisor and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the period.

**Contributions**

Contributions from Plan participants and the matching contributions from the Company were recorded in the period in which the employee contributions were withheld from compensation.

**Investment Concentrations**

The Plan held certain investments that represented 10% or more of the Plan's total investments at December 31, 2022:

**Payment of Benefits**

Benefits were recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company were excluded from these financial statements. Investment related expenses were included in net appreciation in fair value of investments.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through December 20, 2024, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 1, 2023 and December 31, 2022.

*Pooled separate accounts* - The fair value of the investment in this category has been estimated using the net asset value per share as a practical expedient. The net asset value ("NAV") of these accounts is based on the market value of its underlying investments. The NAV of these accounts is not a public-quoted price in an active market.

*Fixed income account* - unit value is reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

**Investment Strategies**

JP Morgan Smart Retirement Funds: Focuses on delivering a well-diversified portfolio with an appropriate asset allocation for participants who plan to retire the target retirement year and then withdraw their savings from the fund throughout retirement.

Franklin Conservative/Moderate/Growth Allocation Funds: These Funds are a "fund of funds" meaning that they seek to achieve their investment goal by investing their assets primarily in other funds (underlying funds), predominantly other Franklin affiliated mutual funds and exchange traded funds (ETFs). These funds are designed for investors seeking the highest level of long-term total return that is consistent with a level of risk. The funds may be most appropriate based on the investor's investment timelines.

Franklin Income A: Under normal market conditions, the fund invests in a diversified portfolio of debt and equity securities. The fund may shift its investments from one asset class to another based on the investment manager's analysis of the best opportunities for the fund's portfolio in a given market.

**NOTE 4 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

---

Expenses incurred by the Plan for investment management services were included in net appreciation in fair value of investments. Other transactions which could be considered related party or party-in-interest transactions related to normal plan management and administrative services.

**NOTE 5 - PLAN TERMINATION**

---

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. See Note 1 for discussion of the plan merger that resulted in the transfer of all plan assets in the Inperium & Family of Services 401(k) Plan on November 1, 2023.

**NOTE 6 - TAX STATUS**

---

The Company had adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Empower Retirement LLC. The pre-approved profit sharing plan received an opinion letter on November 14, 2022 that the pre-approved profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believed that the Plan was currently designed and was operated in compliance with the applicable requirements of the IRC, and therefore, believed that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America required plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions, however, there were no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

---

The Plan invested in various investment securities. Investment securities were previously exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least possible that changes in the value of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - CERTIFIED INVESTMENTS**

---

Certain information related to investments disclosed in the accompanying financial statements including investments held at November 1, 2023 and December 31, 2022, and net appreciation in fair value of investments and interest for the period January 1, 2023 through November 1, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan. The fair value of the fixed income account as of November 1, 2023 and December 31, 2022 was certified by Empower Annuity Insurance Company of America.

**NOTE 9 - OTHER EMPLOYER CONTRIBUTION RECEIVABLE**

---

During the year ended December 31, 2022, it was discovered that certain plan provisions were not properly applied in the operation of the Plan. The definition of compensation for participant and employer contributions as per the plan agreement was not properly applied when calculating contribution amounts for those participants that received holiday pay, vacation pay, sick pay, overtime compensation, and bonuses at various times throughout the plan year. The plan administrator determined the amount due to affected participants and a contribution receivable was recorded in the amount of \$5,719 at December 31, 2022. The Company deposited this amount to make the affected participants whole, plus lost earnings. The lost earnings related to the contributions receivable was not material to the financial statements.

**NOTE 10 - PROHIBITED TRANSACTIONS**

---

During the period ended November 1, 2023, the Company failed to remit timely to the Plan's trustee certain employee contributions totaling \$41,852. During the year ended December 31, 2022, the Company failed to remit timely to the Plan's trustee certain employee contributions totaling \$28,164. Delays in remitting payments to the trustee were due to administrative errors and the Company will make contributions to the affected participants' accounts through the Inperium & Family of Services 401(k) Plan to compensate those for lost earnings due to the delays. The lost earnings related to these contributions was not material to the financial statements.
