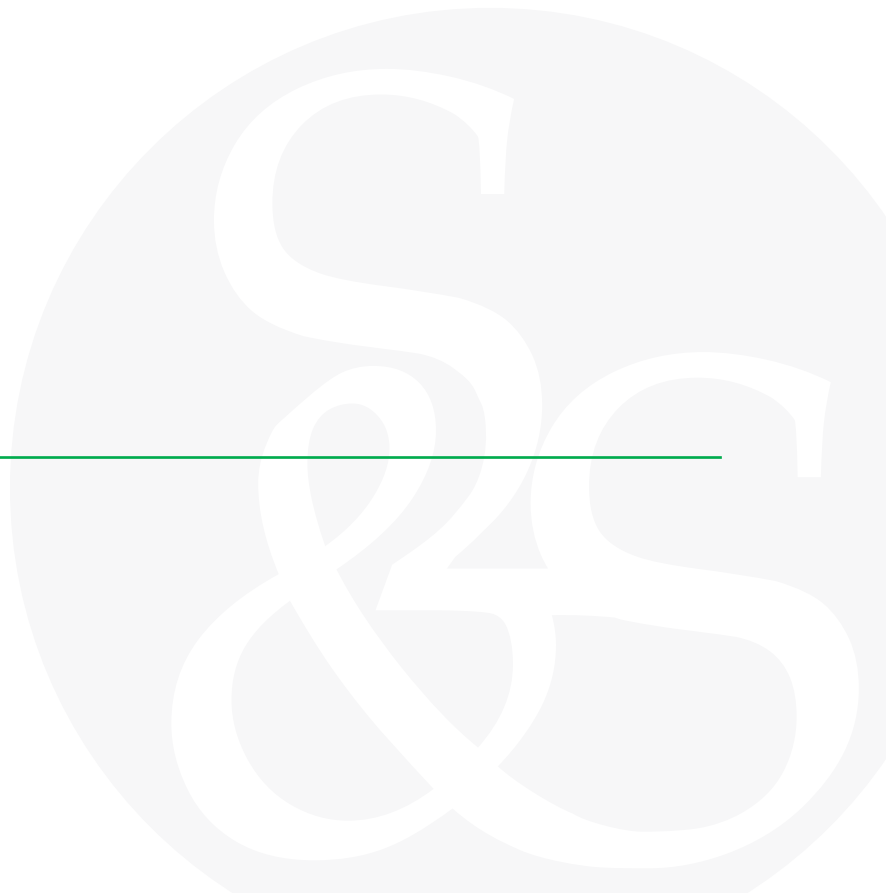

Their report also indicated that the form and content of the 2022 supplemental schedule, other than the information in the 2022 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2022 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Matheny Motor Truck Company (the “Company”) Employee Savings and Protection Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution Plan covering certain employees of the Company, who have completed 6 months of service and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was established effective January 1, 1988. The Plan was adopted under the provisions of Internal Revenue Code (IRC) Section 401(a), with a cash or deferred arrangement qualified under IRC Section 401(k) and was restated effective April 1, 2019.

Automatic Enrollment - Elective deferrals are automatically deducted from eligible employees who have not made an elective deferral election. The initial amount of the automatic enrollment is three percent of employee eligible compensation. This is unless the employee makes an election not to contribute or to contribute a different amount.

Contributions - Participants may elect to contribute any amount of pre-tax or after-tax compensation up to the maximum allowable dollar limit provided by the Internal Revenue Code (IRC). Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company may, at its sole discretion, make a matching contribution each year. For the 2023 Plan year, the matching formula was 35% of the first 5% of employee compensation and 25% of the next 1%. Additionally, at its sole discretion, the Company may choose to make profit sharing contributions subject to certain limitations. During the 2023 Plan year, the Company did not make a profit sharing contribution.

Participant Accounts - In addition to a participant’s contributions and employer contribution, each participant’s account is credited with an allocation of the participant’s account earnings and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their contributions, plus actual earnings thereupon. Vesting in employer matching and profit sharing contributions is based upon years of service as follows:

Participant Loans - Participants may borrow from their vested fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a commercially reasonable rate. Principal and interest is paid ratably through periodic payroll deductions. Participant loans are treated as notes receivable to the Plan. At December 31, 2023, outstanding loans bore interest at rates from 3.25% to 9.5%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - On termination of service due to death, disability, or retirement, the participant and/or a beneficiary may elect to receive a lump-sum payment, substantially equal installments, or partial payments equal to the value of the participant's vested interest in his or her account as soon as administratively feasible. For account balances not exceeding \$5,000, consent from the participant and/or beneficiary is not required. For account balances exceeding \$5,000, the participant and/or a beneficiary must consent to the distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, substantially equal installments, or partial payments.

Forfeited Accounts - Forfeited nonvested account can be used to reduce employer contributions or pay certain Plan expenses. During 2023, there were no uses of forfeited funds. At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$23,367 and \$15,419, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accounting records of the Plan are maintained on the modified cash basis of accounting, an accounting method permitted by the Department of Labor. This method includes recording of Plan assets at fair market value but excludes the recording of receivables for participant and employer contributions, interest and dividends on investments, interest receivable on notes receivable from participants, and accrued expenses. The effect of these items has not been determined. This practice differs in some respects from accounting principles generally accepted in the United States of America which require that the financial statements be prepared on an accrual basis. Accordingly, the accompanying financial statements are not intended present the financial position and changes in net assets available for benefits in conformity with accounting principles generally accepted in the United State of America.

Use of Estimates - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. The fair value of pooled separate accounts is determined using the observable net asset value (NAV) of the underlying investment. See Note 4 for a discussion of fair value measurements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Contract value is the relevant measurement for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5 for a discussion of investments measured at contract value.

Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance. Interest income on notes receivable is recorded when cash is received. The notes receivable have maturities through the year 2028 and are secured by the vested account balances of the borrowing participants. No allowance for credit losses was recorded as of December 31, 2023 and 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, a distribution to the participant is recorded and the loan balance is reduced.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Administrative expenses, including trustee, legal, auditing, and other fees, are paid by the Company and, as such, are not expenses of the Plan. The amount reported as administrative expenses of the Plan are transactional fees charged to participant accounts.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, except for comparing such information to information included in the Plan's financial statements and supplemental schedule. The information in the financial statements and supplemental schedule was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company, trustee.

NOTE 4 - INVESTMENTS AT FAIR VALUE

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2023 or 2022.

Pooled separate accounts - The fair value of pooled separate accounts is calculated daily based on the observable NAV of the underlying investments. The separate accounts invest in publicly quoted mutual funds in a structure similar to a mutual fund. Therefore, they do not meet the standard of NAV as a practical expedient and are reported at the appropriate level in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INVESTEMENTS AT CONTRACT VALUE

Guaranteed Investment Contract - The Fixed Account is a benefit-responsive group annuity contract issued by Massachusetts Mutual Life Insurance Company. The contract is backed by the full faith and creditworthiness of the issuer. Guarantees are based on the claims-paying ability of the issuer and not on the value of the securities within the insurer's general account. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contact value represents deposits made to the contract, plus earnings at guaranteed net crediting rates, less withdrawals. Contract value is the relevant measurement attribute for the Plan's investment in the contract, because contract value is the amount participants would receive if they were to initiate permitted transactions. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals. The contract value of the account at December 31, 2023 and 2022 was \$1,067,871 and \$912,960, respectively.

NOTE 5 - INVESTMENTS AT CONTRACT VALUE (Continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled separate accounts issued by MassMutual and managed by Empower. Fees paid by the Plan for contract administrative and investment management services to Empower amounted to \$9,228 for the year ended December 31, 2023, These transactions qualify as party-in interest transactions.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

NOTE 8 - TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code (IRC) Section 401. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (modified cash basis).

NOTE 10 - SUBSEQUENT EVENTS

Management evaluated events for the Plan through February 27, 2025, the date the financial statements were available to be issued.
