### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the financial statements of the Louisiana-Pacific Corporation Retirement Account Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). The financial statements comprise the statements of net assets available for benefits - liquidation basis as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits - liquidation basis for the years then ended, and the related notes to the financial statements (Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. As discussed in Note 1 to the Financial Statements, the governing body of the Plan approved a plan of liquidation on December 31, 2021, and management determined liquidation is imminent. As a result, the 2022 and 2023 financial statements of the Plan are prepared using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) Audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

## NOTES TO FINANCIAL STATEMENTS

### AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2023 AND 2022

#### 1. DESCRIPTION OF THE PLAN

The following description of the Louisiana-Pacific Corporation Retirement Account Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General** - The Plan is a non-contributory defined benefit pension plan covering all salaried and hourly employees of Louisiana-Pacific Corporation ("LP," "Plan Sponsor" or the "Company"), except employees that are covered by a collective bargaining agreement or who participate in another defined benefit plan sponsored by LP. The Plan is administered by an administrative committee (the "Plan Administrator"), comprised of four members appointed by LP. Principal Bank ("Principal") and several investment managers manage the Plan investments. The Plan Administrator has the authority to direct contributions to the Trust and plan distributions from the Plan. The Plan is designed to comply with applicable provisions of the Internal Revenue Code ("IRC") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Plan Amendments** - The Plan was amended to terminate the Plan effective December 31, 2021.

**Pension Benefits** - Participants with three years of continuous service, as defined by the Plan, are entitled to pension benefits upon retirement. Employees are eligible to begin their vesting period upon their first day of employment. If employees terminate before rendering three years of continuous service, they forfeit the right to receive pension benefits upon retirement. Benefits are determined based upon years of service and total earnings as an active participant. Benefits under the Plan are based on employees' compensation during the last five consecutive calendar years of service out of the last ten years preceding the valuation date that yield the highest monthly average. Participants can elect to receive their distributions, subject to certain plan provisions, in the form of an annuity or in a lump-sum payment (with spousal consent as applicable) as soon as practical after they qualify for commencement of benefit. If a participant with an accrued benefit dies before retirement, is eligible for retirement and has an eligible beneficiary, the participant's account shall become payable to the participant's eligible beneficiary, subject to the provisions of the Plan.

Participants that were actively employed on January 1, 1999 or were hired after January 1, 1999, are enrolled in the Cash Balance Plan feature of the Plan. Participants terminated prior to January 2, 1999, retain their traditional defined benefit plan feature. The Cash Balance Plan benefit is based upon accumulated amounts in the hypothetical account maintained for each participant. Amounts accumulate based on pay credits and interest credits. All active participant accounts were credited with a pay credit based on 5% of the participant's eligible compensation. Subsequent to December 31, 2008, the Plan was amended such that contribution pay credits will no longer be credited for compensation paid to participants after December 31, 2009. Interest is credited to the active participant accounts based upon prior year's November interest rate for the 30-year United States Treasury Bills Constant Maturities converted to a daily interest credit. The rates used for 2023 and 2022 were 3.80% and 1.78%, respectively.

Employees vest in these hypothetical account balances after three years of credited service. Upon termination of employment, the vested account balance can be paid out in the form of a lump sum (subject to spousal consent as applicable) or as a monthly annuity.

**Vesting** - Vesting occurs at any age after completion of three years of service or attainment of age 65. Additionally, the Plan was amended in 2009 to provide that the severance of employment of Plan participants, as a result of the sale, closure, or position elimination at specified LP locations occurring between January 1, 2007 and December 31, 2009, shall result in full vesting of accrued benefits under the Plan of affected participants as if there were a partial termination of the Plan with respect to such participants.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared on the liquidation basis in accordance with generally accepted accounting principles in the United States of America (U.S. GAAP).

**Actuarial present value of accumulated plan benefits** - Accumulated plan benefits are those future periodic payments, including lump-sum distributions, which are attributable under the Plan's provisions to the years of service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries.

Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included to the extent they are deemed attributable to employee service rendered to the valuation date.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Aon Hewitt Associates LLC (actuary).

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

**Use of Estimates** - The preparation of financial statements in conformity with U.S. GAAP requires management to make certain estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities and the actuarial present value of accumulated plan benefits at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from these estimates.

**Payment of Benefits** - Benefit payments are recorded when paid.

**Administrative Expenses** - Administrative expenses of the Plan are paid by the Plan, if not paid by LP, as provided in the Plan document. The Plan Sponsor provides accounting and other administrative services to the Plan at no charge.

**Risks and Uncertainties** - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

**Subsequent events** - The Plan has evaluated subsequent events through February 25, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2023, have been incorporated into these financial statements.

#### 3. FUNDING POLICY

Contributions to provide benefits under the Plan are made solely by the Company. The Company's funding policy is to make cash contributions to the Plan in amounts as determined by the Plan's independent actuary. The Company met the minimum funding requirements of ERISA for the years ended December 31, 2023 and 2022.

#### 4. INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN

Principal holds the Plan's investment assets and executes investment transactions. Management has determined that Principal is a qualified institution and the information prepared and certified by Principal meets the requirements of ERISA Section 103(a)(3)(C). Certain information related to investments disclosed in the financial statements and supplemental schedule, including investments held at December 31, 2022, dividends and interest and net depreciation for the years ended December 31, 2023 and 2022, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal.

#### 5. FAIR VALUE MEASUREMENTS

In accordance with U.S. GAAP, the Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

**Asset Valuation Techniques** - Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodology used for assets at fair value. There have been no changes in the methodology used at December 31, 2023 and 2022.

Money market funds are stated at cost, which approximates fair value due to the short-term nature of the investment and are categorized as Level 1.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. PLAN TERMINATION

The Plan Sponsor terminated the Plan effective December 31, 2021, subject to the provisions of ERISA. All remaining payouts of the Plan were completed by December 31, 2023.

Effective December 31, 2021, all participants became 100% vested. Due to the termination, the net assets of the Plan were allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a) Benefits attributable to employee contributions, if applicable, taking into account those paid out before termination.
- b) Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.

- c) Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
- d) All other vested benefits (that is, vested benefits not insured by the PBGC).
- e) All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC due to the Plan termination. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of Plan termination. However, a statutory ceiling exists, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees.

The Company had accrued \$670,954 of administrative fees and expenses as of December 31, 2022, related to plan termination that were paid during the year ended December 31, 2023. All remaining assets of \$2,086,047 were transferred to the Louisiana-Pacific 401(k) and Profit Sharing Plan on December 27, 2023.

#### 7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

As of December 31, 2023 and 2022, certain Plan investment transactions involve investment funds managed by Principal. Principal is the trustee for each year as defined by the Plan; therefore, these transactions qualified as party-in-interest transactions and were exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services were included in net appreciation (depreciation).

#### 8. FEDERAL INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated August 26, 2015, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
