## INDEPENDENT AUDITOR'S REPORT

Board of Trustees

### Qualified Opinion


We have audited the accompanying financial statements of the Beverage and Brewery Drivers Local Union No. 67 Pension Fund Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (in liquidation) as of July 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (in liquidation) for the years then ended, and the related notes to the financial statements.

In our opinion, except for the possible effects of the matters discussed in the Basis for Qualified Opinion section of our report, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of July 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Qualified Opinion

The Plan's financial statements do not disclose information regarding the change in the Plan's accumulated plan benefit obligation for the year ended July 31, 2023. In our opinion, presentation of this information is required in order for the financial statements to be in conformity with accounting principles generally accepted in the United States of America. As described in Note 1 to the financial statements, as a result of the Plan becoming insolvent, the Pension Benefit Guaranty Corporation (PBGC) is providing funds to cover funding deficiencies. The PBGC has advised the Board of Trustees that annual actuarial valuations are not required for insolvent multiemployer plans that are receiving financial assistance from the PBGC, unless requested. Since the PBGC will not fund the cost of such valuation, the Board of Trustees has not engaged plan actuaries to perform a valuation in the current year. Therefore, the Plan's financial statements do not present information regarding the Plan's accumulated plan benefits as of July 31, 2023, and the changes in accumulated plan benefits for the year then ended. In our opinion, presentation of that information is required to conform with accounting principles generally accepted in the United States of America. The Board of Trustees has not quantified the amount of, or changes in, the Plan's accumulated plan benefits and, in the absence of an actuarial determination, these amounts and their effect on the financial statements are not reasonably determinable.





We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

### **Emphasis of Matter**

As further discussed in Notes 1 and 2 to the financial statements, the Board of Trustees voted to terminate the Plan effective August 1, 2007. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the going concern basis to the liquidation basis. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards in the United States of America (GAAS) will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at end of year) on page 14 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.



In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **Other Supplemental Information**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The schedules of administrative expenses on page 13 are presented for purposes of additional analysis and are not a required part of the financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

YEARS ENDED JULY 31, 2024 AND 2023

**NOTE 1. DESCRIPTION OF THE PLAN**

The following description of the Beverage and Brewery Drivers Local Union No. 67 Pension Fund Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General** - The Plan became effective May 1, 1966 and was restated January 1, 1994. The Plan was the result of a merger on August 1, 1991, of the Beverage Drivers Local Union No. 67 and Soft Drink Association Pension Fund Retirement Plan and the Brewery Drivers Local Union No. 67 and Soft Drink Association Pension Fund Retirement Plan.

The Plan is a defined benefit pension plan covering employees of participating employers in the Brewery and Beverage Drivers, Inside Workers, Vending Machine Servicemen and Helpers, Local No. 67 (the Union) area who are subject to collective bargaining agreements with the Union. The Union has since been merged into the Drivers, Chauffeurs and Helpers Local Union #639 (Local 639). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Mass Withdrawal** - Effective August 1, 2007, all contributing employers to the Plan ceased making contributions. Under federal pension law, this mass withdrawal constituted a "termination" of the Plan. The Plan will continue until the Plan assets are distributed in full satisfaction of its obligations to pay vested benefits, until the Pension Benefit Guaranty Corporation (PBGC) (a U.S. Government Agency) determines that the Plan's assets (exclusive of withdrawal liability) are sufficient to satisfy this obligation or until the Plan becomes insolvent, at which time, the Plan would apply to the PBGC for assistance.

**Insolvency and the Pension Benefit Guaranty Corporation** - During June 2019, the Plan issued a notice of insolvency to the PBGC. In connection with this notice, the Plan submitted an application for financial assistance requesting the PBGC provide supplemental funding for payment of benefits and reasonable administrative expenses incurred by the Plan after the depletion of existing plan assets. Beginning June 2019, the PBGC began providing financial assistance to the Plan. At that time, benefits were reduced to PBGC levels. During the years ended July 31, 2024 and 2023, the Plan received \$659,300 and \$582,900, respectively, in assistance.

Amounts received from the PBGC are recognized as an addition to net assets in the period received. Funding provided by the PBGC is technically a loan, but due to the circumstances, repayment is considered unlikely and no liability has been recorded. The ability of the Plan to continue operations and pay benefits is dependent on the PBGC continuing to provide financial assistance.



## NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Contributions and Vesting** - Effective August 1, 2007, the Plan was frozen. The Plan will cease to receive additional contributions pursuant to a collective bargaining agreement and participants will not accrue additional benefits. The withdrawing employers, Canada Dry and Local No. 67, are still required to contribute to fund the Plan's unfunded vested benefits in the form of quarterly withdrawal liability payments. Canada Dry and Local No. 67 shall make quarterly payments in the amounts of \$54,938 and \$1,872, respectively. Because the Plan is frozen, it is not subject to the minimum funding standards.

The employer withdrawal liability owed by Canada Dry is \$8,285,945 and Local No. 67 is \$262,754. The total withdrawal liability receivable of \$8,548,700 has been offset with an allowance for credit losses, since the only amounts due are the quarterly withdrawal liability payments.

Effective December 31, 2014, Local Union No. 67 merged into Teamsters Local 730. Effective January 1, 2023, Teamsters Local 730 merged into the Drivers, Chauffeurs and Helpers Local Union #639 (Local 639). Local 639 is now responsible for the withdrawal liability payments.

**Pension, Death and Disability Benefits** - The Plan provides normal retirement age pensions, early reduced, termination, death and disability benefits for eligible participants and their beneficiaries. Participants are eligible for a normal retirement benefit at age 60 and 5 years of participation in the Plan.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting to the liquidation basis from the going concern basis. If the Plan were to hold operating assets, insurance and certain investment contracts or large blocks of stock or other assets that cannot be readily disposed of at their quoted market prices, they would be carried at the liquidation basis instead of market value. Assets and liabilities and revenues and expenses are recognized on the accrual basis of accounting.

**Investments Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are reported on a trade-date basis. Interest income is reported on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosures of contingent assets and liabilities and the actuarial present value of liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Administrative Expenses** - The Plan pays all administrative expenses.

**New Accounting Pronouncement Adopted** - During the year ended July 31, 2024, the Plan adopted the provisions of Accounting Standards Update (ASU) 2016-13, *Financial Instruments – Credit Losses* (Topic 326). This ASU replaced the incurred loss methodology with an expected loss methodology that is referred as the current expected credit loss (CECL) methodology. The ASU requires nonprofit entities to immediately recognize the estimated expected credit losses over the life of a financial instrument, including trade receivables and contributions receivable. The estimate of expected credit losses considers not only historical information, but also current and future economic conditions and events.

The Plan adopted the ASU effective August 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in additional disclosures.

## NOTE 3. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.



### NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at July 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 4. PLAN TERMINATION

Upon termination or partial termination of the Plan, the rights of each employee to the benefits accrued to date of such termination to the extent then funded, with the rights of each employee to the amounts credited to their account at such time, shall be non-forfeitable. In the event of termination of the Plan, the funds then in the possession of the Trustees - after payment of all reasonable expenses, taxes, or proper charges - shall be allocated in accordance with Section 4044 of ERISA.



## **NOTE 5. INCOME TAX STATUS**

The Internal Revenue Service (IRS) has determined by letter dated January 10, 2003, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however the Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the various states the Plan files returns. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the values of investment securities could be different at the reporting date and that such changes could materially affect the amounts reported in the statements of net assets available for benefits (in liquidation).

Plan contributions are made, and the actuarial present value of liabilities would be reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements, had an actuarial valuation been performed.

## **NOTE 7. CONCENTRATION OF RISK**

The Plan no longer has current employer contributions and only receives withdrawal liability assessments from Local 639 and Canada Dry. Economic changes to these employers may result in a financial impact to the Plan.

## **NOTE 8. EMPLOYEE CONTRIBUTIONS**

Participant accounts include contributions made, prior to the Plan being frozen, by employers and optional employee contributions. In an attempt to preserve those employee contributions, they have been segregated into a separate account. The Plan has provided notice to participants recommending withdrawal of their employee contributions.



## **NOTE 9. PARTY-IN-INTEREST TRANSACTIONS**

As disclosed in Note 2, the Plan pays certain expenses related to plan operations and investment activity to various service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules under ERISA.

## **NOTE 10. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through February 6, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no other material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.


