NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Wesco Turf, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution profit sharing plan covering substantially all employees of Wesco Turf, Inc. (the "Plan Sponsor") and the employees of ProPump and Controls, Inc., a participating employer, with the exception of independent contractors and residents of Puerto Rico, who have attained 20 years of age and met the service requirement as stated in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute a portion of their pretax annual compensation, as defined in the Plan and subject to certain limitations established by the Internal Revenue Service. Participants age 50 or older are permitted to defer "catch-up" contributions. Participants may also designate some or all of their deferral contribution as a Roth contribution at the time the deferral election is made. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan Sponsor may contribute a discretionary 401(k) match and additional discretionary amounts to the Plan. For the years ended September 30, 2024 and 2023, the Plan Sponsor matched 25 percent of each participant's deferrals limited to the first 6 percent of deferred compensation. Discretionary match contributions totaling \$234,637 and \$209,008 were paid for the 2024 and 2023 Plan year, respectively. Plan participants direct the investment of their contributions and employer matching contributions into various investment options offered by the Plan.

Employees are automatically enrolled into the Plan at a rate of 3 percent once age and service requirements are met unless the employee elects otherwise.

Participant Accounts: Each participant's account is credited with the participant's contribution, and an allocation of (a) the Plan Sponsor's matching contribution, (b) any additional contributions, and (c) Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options under the Plan.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on years of continuous service. Participants begin vesting 20 percent per year after two years of service and are 100 percent vested after six years of credited service.

Retirement, Death, and Disability: A participant is entitled to 100 percent of his or her account balance upon retirement, death, or disability.

Payment of Benefits: Upon retirement, death, disability or termination of service, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account, partial withdrawal of any portion of his or her vested balance or installment distributions paid in substantially equal amounts over a period of time, as defined by the Plan. If the participant's account balance is \$1,000 or less, the Plan administrator will direct the trustee to distribute the vested account balance in the form of a lump-sum payment without the participant's consent. If the participant's balance is greater than \$1,000 but less than or equal to \$5,000, the participant must choose to a form of payment. If the participant's balance is greater than \$5,000 the participant can choose a form of payment or remain in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59 ½.

Hardship Withdrawals: Subject to approval of the Plan administrator, participants may withdraw their employee pretax contributions and Roth deferral contributions, if any, to satisfy immediate and heavy financial need, as determined by the Plan Agreement. Effective August 13, 2024, hardship withdrawals are considered pre-approved by the Plan administrator.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates based on prime rate as reported by Thomson Reuters. The interest rate shall remain fixed throughout the duration of the note. Principal and interest are paid through payroll deductions over periods ranging up to 60 months or longer, i.e., mortgage, in which case the period cannot exceed 10 years.

Forfeitures: Participant forfeitures of discretionary employer matching contributions and additional employer contributions may first be used to pay Plan expenses. Any remaining forfeitures are used to offset future employer matching contributions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are generally received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, risks pertaining to a pandemic and overall market volatility. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions and earnings thereon.

NOTE 4 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 5 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 5 - FAIR VALUE MEASUREMENTS (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

Stable Value Collective Trust: The fair values of participation units in the stable value collective trust are based upon the net asset values of such fund as reported in the audited financial statements of the fund. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Plan Sponsor. The Plan invests in shares of mutual funds issued by Fidelity Investments, Inc. an affiliate of Fidelity Management Trust Company (FMTTC), the Plan trustee, and a stable value fund issued by FMTTC. Transactions in such investments and the Plan's payment of trustee fees, record keeping fees, and investment management fees to FMTTC and Fidelity Investments, Inc. qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 - INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the Fidelity Advisor 401(k) Volume Submitter Defined Contribution prototype document adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Plan management believes the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - SUBSEQUENT EVENTS

Effective October 15, 2024, the Plan was amended to automatically increase participant deferral rates annually on January 2nd by 1 percent each year until 6 percent deferral is attained, unless elected otherwise by individual plan participants.

Plan management has evaluated subsequent events for recognition and disclosure through March 4, 2025, which is the date the financial statements were available to be issued.

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Wesco Turf, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution profit sharing plan covering substantially all employees of Wesco Turf, Inc. (the "Plan Sponsor") and the employees of ProPump and Controls, Inc., a participating employer, with the exception of independent contractors and residents of Puerto Rico, who have attained 20 years of age and met the service requirement as stated in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute a portion of their pretax annual compensation, as defined in the Plan and subject to certain limitations established by the Internal Revenue Service. Participants age 50 or older are permitted to defer "catch-up" contributions. Participants may also designate some or all of their deferral contribution as a Roth contribution at the time the deferral election is made. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan Sponsor may contribute a discretionary 401(k) match and additional discretionary amounts to the Plan. For the years ended September 30, 2024 and 2023, the Plan Sponsor matched 25 percent of each participant's deferrals limited to the first 6 percent of deferred compensation. Discretionary match contributions totaling \$234,637 and \$209,008 were paid for the 2024 and 2023 Plan year, respectively. Plan participants direct the investment of their contributions and employer matching contributions into various investment options offered by the Plan.

Employees are automatically enrolled into the Plan at a rate of 3 percent once age and service requirements are met unless the employee elects otherwise.

Participant Accounts: Each participant's account is credited with the participant's contribution, and an allocation of (a) the Plan Sponsor's matching contribution, (b) any additional contributions, and (c) Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options under the Plan.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on years of continuous service. Participants begin vesting 20 percent per year after two years of service and are 100 percent vested after six years of credited service.

Retirement, Death, and Disability: A participant is entitled to 100 percent of his or her account balance upon retirement, death, or disability.

Payment of Benefits: Upon retirement, death, disability or termination of service, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account, partial withdrawal of any portion of his or her vested balance or installment distributions paid in substantially equal amounts over a period of time, as defined by the Plan. If the participant's account balance is \$1,000 or less, the Plan administrator will direct the trustee to distribute the vested account balance in the form of a lump-sum payment without the participant's consent. If the participant's balance is greater than \$1,000 but less than or equal to \$5,000, the participant must choose to a form of payment. If the participant's balance is greater than \$5,000 the participant can choose a form of payment or remain in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59 ½.

Hardship Withdrawals: Subject to approval of the Plan administrator, participants may withdraw their employee pretax contributions and Roth deferral contributions, if any, to satisfy immediate and heavy financial need, as determined by the Plan Agreement. Effective August 13, 2024, hardship withdrawals are considered pre-approved by the Plan administrator.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates based on prime rate as reported by Thomson Reuters. The interest rate shall remain fixed throughout the duration of the note. Principal and interest are paid through payroll deductions over periods ranging up to 60 months or longer, i.e., mortgage, in which case the period cannot exceed 10 years.

Forfeitures: Participant forfeitures of discretionary employer matching contributions and additional employer contributions may first be used to pay Plan expenses. Any remaining forfeitures are used to offset future employer matching contributions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are generally received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, risks pertaining to a pandemic and overall market volatility. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions and earnings thereon.

NOTE 4 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 5 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 5 - FAIR VALUE MEASUREMENTS (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

Stable Value Collective Trust: The fair values of participation units in the stable value collective trust are based upon the net asset values of such fund as reported in the audited financial statements of the fund. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Plan Sponsor. The Plan invests in shares of mutual funds issued by Fidelity Investments, Inc. an affiliate of Fidelity Management Trust Company (FMTC), the Plan trustee, and a stable value fund issued by FMTC. Transactions in such investments and the Plan's payment of trustee fees, record keeping fees, and investment management fees to FMTC and Fidelity Investments, Inc. qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 - INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the Fidelity Advisor 401(k) Volume Submitter Defined Contribution prototype document adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Plan management believes the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - SUBSEQUENT EVENTS

Effective October 15, 2024, the Plan was amended to automatically increase participant deferral rates annually on January 2nd by 1 percent each year until 6 percent deferral is attained, unless elected otherwise by individual plan participants.

Plan management has evaluated subsequent events for recognition and disclosure through March 4, 2025, which is the date the financial statements were available to be issued.
