Note 1: Description of Plan

The following description of the BayFirst Solutions 401k Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of BayFirst Solutions, LLC (the “Company”) who have reached 21 years of age and are not covered under a collective bargaining agreement (union employees). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Administrators are responsible for oversight of the Plan. The Plan Administrators determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

Contributions

Each year, participants may contribute an amount of pretax or after-tax annual compensation up to the limits of the Internal Revenue Code, as defined in the Plan. Participants may defer a maximum of 80% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a safe harbor matching contribution, and has the option to, at the discretion of the Company’s Board of Directors, make a non-elective profit-sharing contribution. The safe harbor matching contribution is equal to 100 percent of the first 4 percent of compensation that a participant contributes to the Plan. The Company’s contributions are invested in accordance with each participant’s investment choices. During the year ended December 31, 2021, the Company made a \$411,579 safe harbor matching contribution to the Plan. The Company did not make any profit-sharing contributions during the year ended December 31, 2021. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company safe harbor matching contributions, as well as allocations of the Company’s non-elective profit-sharing contribution, if any, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes to Financial Statements

Note 1: Description of Plan (continued)

Vesting

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Participants will vest 25% per year in employer non-elective profit-sharing contributions and will be fully vested after four years of continuous service.

Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest in the Plan. The notes are secured by the balance in the participant's account. The note interest rate is determined at the time the note is issued, and is set at 1% above the Prime Rate, as defined. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or termination of services for other reasons, a participant may elect to receive a lump-sum payment equal to the balance of the participant's vested interest in his or her account if the vested amount is below \$5,000. On termination of service due to disability, retirement or termination of services for other reasons, a participant with a vested balance exceeding \$5,000 may elect to receive a lump-sum amount equal to the vested amount, a partial withdrawal, or installments over a certain period. On termination of service due to death, a participant with a vested balance exceeding \$5,000 may elect to receive a lump-sum amount equal to the vested amount. An in-service distribution may be taken by any participant that has attained the age of 59 and ½. An involuntary distribution can be made at the Plan's discretion for participants that have terminated service and that have an account with a vested interest value of less than \$5,000.

Forfeited Accounts

As of December 31, 2021 and 2020, forfeited nonvested accounts totaled \$0 and \$1,811, respectively. These accounts can be used to reduce future employer contributions.

Plan Termination

On June 1, 2021, BayFirst Solutions, LLC was acquired by Versar, Inc. Effective December 31, 2021, the Company elected to transfer all of the Plan's assets and participants into the Versar Employee 401(k) Plan. Accordingly, all of the Plan's assets and participants were transferred to that plan on that date at which point all of the Plan's assets were transferred to the new Plan. Subsequent to this transfer, the Plan was terminated.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrators determine the Plan's valuation policies utilizing information provided by the trustee and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All Plan assets were transferred to the Versar, Inc. Employee 401(k) Plan before close of business on December 31, 2021.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2021 or 2020. If a participant ceases to make note repayments as a result of a distributable event and the Plan Administrators deem the participant note to be in default, the participant note balance is reduced and a deemed distribution is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Investment advisory fees are included in administrative expenses and are paid through revenue sharing recorded in other income on the Statement of Changes in Net Assets Available for Benefits. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

For the year ended December 31, 2021, the Plan Administrators have evaluated subsequent events for potential recognition and disclosure through December 11, 2024, the date the financial statements were available to be issued.

Note 3: Information Certified by Reliance Trust Company

The Plan Administrators have elected the method of compliance as permitted by 29 CFR § 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2021 and 2020. Accordingly, Reliance Trust Company, the trustee, has certified the completeness and accuracy of the investment activity for the years ended December 31, 2021 and 2020, including the information summarized in Notes 4 and 5. The information certified includes total investments of \$0 and \$10,824,188 at December 31, 2021 and December 31, 2020, respectively.

Note 4: Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 15 days notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 6: Tax Status

The IRS has opined and informed the Company by a letter dated July 16, 2014 that the Plan and related trust are designated in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrators believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Note 6: Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan may be subject to a routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: Related Party Transactions and Transactions with Parties-in-Interest

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2021, the Plan made direct payments of \$34,984 to certain parties-in interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
