Note 1 - Plan Description

The following description of VisionWeb 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of VisionWeb Holdings, LLC (the "Company"). The Plan provides participants the opportunity to save for future financial needs by setting aside a portion of their compensation through payroll deductions. Employees are eligible to participate in the Plan for the purpose of making salary deferral contributions and receiving employer safe harbor matching contributions after attaining 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100 percent of their pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limitations.

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Eligible employees not enrolling in the Plan after achieving eligibility are automatically enrolled in the Plan at a pretax contribution amount of 6 percent of eligible compensation. Employees who are automatically enrolled in the Plan will also have their pretax contribution amount automatically escalated by 1 percent each year until reaching 10 percent of eligible compensation.

The Plan provides for employer safe harbor employer matching contributions of 100 percent of the participant's contribution, not to exceed 4 percent of the employee's deferred compensation.

The Plan also allows for employer discretionary contributions. Participants who are active in the Plan at plan year end and who completed 1,000 service hours will be eligible to receive the employer discretionary contribution. The Company did not make any discretionary contributions during 2021.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. Company contributions are invested according to participant's directions. All participant, safe harbor, and company match contributions, if any, are invested directly into these elected funds.

Vesting

Participants are immediately 100 percent vested in employee salary, rollover, employer safe harbor matching, and employer discretionary contributions and any income or loss thereon.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess of the highest outstanding balance of loans from the Plan during the 1-year period ending on the day before the date on which such loan was made or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest based on local prevailing rates determined by the plan administrator. Principal and interest are paid ratably through payroll deductions over a period not to exceed 5 years, with the exception of mortgage loans, which may be repaid over 30 years.

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Party-in-interest Transactions

At December 31, 2021 and 2020, certain plan assets are in investment funds managed by American United Life Insurance Company, a OneAmerica company, and John Hancock Life Insurance Company, or their affiliates. American United Life Insurance Company and John Hancock Life Insurance Company are collectively the trustees of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for further discussion of fair value measurements.

The fully benefit-responsive unallocated investment contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Note 2 - Summary of Significant Accounting Policies (Continued)

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Administrative Expenses

Administrative costs of the Plan are paid by the Company and the Plan, as provided in the plan document.

Benefit Payments

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 5, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

In 2021, the Plan changed its trustee from John Hancock Life Insurance Company to American United Life Insurance Company (collectively, the "Trustees"). The Trustees of the Plan held the Plan's investments and participant notes receivable and executed all related transactions during the periods under audit. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustees.

Note 4 - Tax Status

During 2021, the Plan adopted a preapproved plan. Previously, the Plan, as adopted, used a volume submitter plan. There were no changes as a result of the adoption of the preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The volume submitter plan received a favorable notification letter from the IRS dated September 30, 2014. The Plan has not individually sought its own determination letter.

Note 5 - Investment Contract

The Plan has a benefit-responsive investment contract with American United Life Insurance Company (AUL). AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Note 5 - Investment Contract (Continued)

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 0 percent. When establishing interest crediting rates for this product, AUL considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

Note 6 - Fair Value Measurements

The following valuation methodologies have been used to value the Plan's investments:

Pooled Separate Accounts

The pooled separate accounts are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' net underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

Note 7 - Subsequent Events

Effective June 20, 2023, the Plan was merged into the EssilorLuxottica Retirement Savings Plan 1. Accordingly, all participants and their related account balances were transferred to the new plan in June 2023.
