## **Note 1. Description of the Plan**

### ***General***

The following description of D4D Technologies, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by D4D Technologies, LLC d/b/a E4D Technologies (Company) for the benefit of its employees who have at least one month of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee and custodian of the Plan.

Effective January 1, 2022, the Company entered into an agreement with Resourcing Edge (PEO) to provide professional services for the Company. As part of the agreement, the Plan would merge into the PEO plan that is administrated by Slavic Integrated Administration (SIA). See Note 6 for further discussion.

### ***Contributions***

The Plan permitted eligible employees through a salary deferral election to make annual contributions of up to 100% of eligible compensation. Employee rollover, Roth, and catch-up contributions are also permitted. Matching contributions made by the Company are discretionary. For the year ended December 31, 2021, the Company made matching contributions of 50% of employees' salary deferral amounts on the first 6% of employees' compensation contributed to the Plan. Contributions are subject to certain limitations.

The plan document included an automatic deferral feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise.

As part of the agreement with the PEO, there were no employee or employer contributions during the period ended May 13, 2022.

### ***Participant Investment Account Options***

Investment account options available include various funds. Participants had the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

### ***Participant Accounts***

Each participant's account was credited with the participant's contribution, the Company's contribution, plan earnings, and was charged with an allocation of administrative expenses. Forfeitures of terminated participants' nonvested accounts were treated as employer contributions into the plan. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants were immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon was based on years of continuous service. A participant was fully vested after four years of continuous service.

### ***Forfeited Accounts***

At December 31, 2021, forfeited nonvested accounts totaled \$447. Forfeitures may first be used to pay plan expenses and then used to reduce the Company's contributions. In 2021, employer contributions were reduced by \$9,000 from forfeited nonvested accounts.

***Payment of Benefits***

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of their vested account or a joint and survivor annuity. Participants who reach age 59½ and active participants requesting hardship withdrawals may withdraw their vested account balance subject to certain conditions and restrictions.

***Notes Receivable From Participants***

The plan document included provisions authorizing loans from the Plan to eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000, or 50%, of the participant's vested account balance. A participant may only have one loan outstanding at any given time. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments were reported at fair value. Quoted market prices, if available, were used to value investments. Mutual funds were valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interest in the common collective trust was valued based on information reported by the certified advisor using the audited financial statements of the collective trust at year end.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants may be reclassified as benefit payments based on the terms of the plan document.

***Payment of Benefits***

Benefit payments to participants were recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

### **Note 3. Certification of Plan Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of May 13, 2022 and December 31, 2021.
- Investment income (loss) and interest income from notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the period ended May 13, 2022 and year ended December 31, 2021.

The Plan's independent auditor did not perform auditing procedures with respect to this certified investment information except for comparing such certified investment information to the related investment information included in the financial statements.

### **Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons. The Company provides certain administrative services at no cost to the Plan.

Certain plan investments are shares of mutual funds managed by Fidelity, the trustee, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments.

### **Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

***Investments Measured Using the Net Asset Value per Share Practical Expedient***

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2021. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**Note 6. Transfer of Plan Assets**

On January 1, 2022, the Company entered into an agreement with a PEO and approved to merge the Plan into the PEO plan managed by SIA. All participants in the Plan were provided the option to have their account balance rolled into the PEO plan, IRA, or receive a lump-sum distribution. An aggregate of \$8,216,627 was rolled out of the Plan during the period ended May 13, 2022 and is included as a transfer out on the accompanying statements of changes in net assets available for benefits.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 8. Tax Status**

The Plan operated under an adoption agreement in connection with a volume submitter retirement plan and trust custodial document sponsored by Fidelity. This volume submitter plan document has been filed with the appropriate agency and has obtained a determination letter from the Internal Revenue Service stating that the volume submitter plan constitutes a qualified plan under Section 401 of the Internal Revenue Code and the related trust was tax-exempt as of the financial statement date.

**Note 9. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through February 28, 2025, which is the date the financial statements were available to be issued.
