Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PPRM 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Plan Description

The following description of the PPRM 401(k) Plan (the Plan), as amended, provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan was established effective July 1, 1992 and was amended and restated effective July 1, 2021. The Plan is a defined contribution 401(k) plan available to qualifying employees of Rocky Mountain Planned Parenthood, Inc. dba Planned Parenthood of the Rocky Mountains, Inc. (the Employer or PPRM). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Administration of the Plan

Empower Trust Company, LLC serves as the Plan custodian and recordkeeper and Empower Annuity Insurance Company of America (collectively, Empower) is the issuer of the fixed group annuity contract held by the Plan. Two officers of PPRM serve as the Plan's trustees. The Employer is the administrator of the Plan. Assets of the Plan are held in accordance with the provisions of the trust and custodial agreements and service provider contract with the Employer. The Employer and trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

An employee is eligible to become a participant of the Plan on the first day of the month coinciding with or following the completion of three months of service. For the purpose of the Employer's Safe Harbor non-elective contributions, eligible employees are those who are at least age 21 and have completed at least one year of service (1,000 hours), as defined. Participants will begin receiving the Employer's Safe Harbor non-elective contributions on the first day of the quarter coinciding with or following the date requirements are met. A discretionary non-elective employer contribution is allowable under the Plan. Participants must have reached age 21, completed one year of service and be employed on the last day of the year, and have 1,000 hours of service in the Plan year in order to receive the discretionary non-elective employer contribution. Leased employees are not eligible to participate in the Plan.

The Plan includes an automatic-enrollment provision whereby all employees that are hired or rehired are automatically enrolled in the Plan at a 3% pre-tax deferral rate, unless they affirmatively elect to defer a different amount or opt out of participation. Deferral amounts are automatically increased 1% per year, on January 15, up to a maximum of 10%, unless a participant affirmatively elects not to participate in the automatic increase.

Contributions

Participants may contribute, on a pre-tax or after-tax Roth basis, up to 90% of their qualifying annual compensation, as defined in the Plan document. Participant contributions are subject to certain Internal Revenue Code (IRC) limitations. The Plan also allows catch-up contributions for participants aged 50 or older subject to certain IRC limitations. Participants may change their contribution percentage, including ceasing contributions, as of each payroll period.

In addition, each Plan year, the Employer makes a Safe Harbor non-elective contribution to the account of each eligible participant in an amount equal to 3% of the participant's eligible compensation, as defined. The Employer may make an additional discretionary non-elective contribution. There was no discretionary non-elective employer contribution made for the Plan year ended June 30, 2024.

Rollover contributions from other qualified plans or individual retirement accounts (IRAs) may also be made to the Plan if certain criteria are met.

Participants' Accounts and Investment Options

Each participant's account is credited with the participant's pre-tax, after-tax Roth, and rollover contributions; the Employer's Safe Harbor non-elective and discretionary non-elective employer contributions; and an allocation of net investment earnings or losses, and debited with withdrawals and certain expenses. The investment earnings or losses are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. Participants may direct the investment of their account balance into various investment options offered by the Plan and may change their investment elections at any time. The Plan offers a fully benefit-responsive guaranteed investment contract and various mutual funds as investment options for participants.

Notes Receivable from Participants

A participant may, with the consent of the Plan administrator, borrow a minimum of \$1,000 up to the lesser of \$50,000 or ½ of their vested account balance. A participant may only have two notes outstanding at a time and the maximum note term is five years (unless for the purchase of a principal residence, which may be up to ten years). The note is considered to be defaulted if any scheduled loan repayment is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. The notes are secured by the participant's account balance and bear interest at a rate equal to 1% over the prime rate as published and is fixed for the term of the note. Principal and interest are paid ratably through bi-weekly payroll deductions.

Vesting

Participants are 100% vested in their salary deferral, rollover contributions, and the Employer's Safe Harbor non-elective contributions, plus the allocated earnings thereon. The discretionary non-elective employer contribution is subject to a three-year vesting period for all employees hired on July 1, 2018 or later. Participants are fully vested upon reaching normal retirement age (65), death, disability, or termination of the Plan.

Forfeitures

At June 30, 2024 and 2023, forfeited non-vested and unallocated accounts were insignificant. Forfeitures arise mainly due to excess of the Employer's Safe Harbor non-elective contributions. Forfeitures may be used to offset any employer non-elective contributions or to pay Plan expenses. For the year ended June 30, 2024, no forfeitures were used to fund the employer non-elective contributions or to pay Plan expenses.

Benefit Payments

Upon termination of service, due to death, disability, attaining retirement age, or separation of service, a participant may elect to receive a lump-sum cash distribution, installment payments, or may roll over the amount to another qualified retirement plan. Prior to August 8, 2023, if no affirmative election is made by the participant to receive a distribution, distribution of account balances not greater than \$5,000 will be rolled into an IRA for the benefit of the participant. Effective August 8, 2023, account balances not greater than \$7,000 will automatically be distributed. Hardship distributions and other in-service distributions at age 59½ are also allowed by the Plan if certain criteria are met.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will immediately become fully vested and non-forfeitable, to the extent not already vested.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments

Investments are reported at fair value (except for fully benefit-responsive guaranteed investment contracts, which are reported at contract value as further discussed in Investment Contracts with Insurance Company below). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Plan administrator determines the Plan's valuation policies utilizing information provided by an investment advisor and Empower.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income and capital gains are recorded on the ex-dividend date. The net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses (in the form of an expense ratio) charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and reflected as a reduction of investment return for such investments.

Investment Contracts with Insurance Company

The Plan entered into the Key Guaranteed Portfolio Fund (the Fund) with Empower, which is a fixed-rate group annuity contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to pay the principal and specified interest rates guaranteed. The effective annual interest rate can never be less than 0% and interest earned is compounded daily to the effective annual interest rate. The interest crediting rate is reset quarterly. The method for calculating the interest crediting rate is based on earnings of the underlying assets in the entire medium to long-term portfolio compared to the minimum crediting rate, as stated in the contract, and prevailing market conditions.

Certain events can limit the ability of the Plan to transact at contract value, including, but not limited to, premature termination of the contract by the Plan, layoffs, Plan termination, bankruptcy, mergers, and early retirement incentives. This could cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value; however, the Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value are probable of occurring.

The Plan's ability to receive amounts due in accordance with the contracts is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuers or otherwise.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions

Participant contributions, the Employer's Safe Harbor non-elective contributions, and discretionary non-elective employer contributions are recognized in the Plan year during which PPRM makes payroll deductions from the participants' compensation or in the period in which the contribution is deemed to be due to the Plan.

Benefit Payments

Benefits are recorded when paid.

Expenses of the Plan

Administrative expenses, net of revenue sharing, including loan, withdrawal fees, and Plan administrative fees, which totaled \$48,059, for the year ended June 30, 2024, were paid by the

Plan. Certain expenses, in the form of an expense ratio, are net against the earnings of the investments. All other expenses of the Plan for the year ended June 30, 2024 were paid by the Employer and are excluded from these financial statements.

3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, a qualified institution, has certified that the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as reported on the statements of net assets available for benefits as of June 30, 2024 and 2023.
- Interest and dividend income, net appreciation in fair value of investments, and interest income on notes receivable from participants as reported on the statement of changes in net assets available for benefits for the year ended June 30, 2024.
- Investment information included in the notes to financial statements and in Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of June 30, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, and reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party-in-Interest Transactions

The Plan invests in a fixed-rate group annuity contract issued by Empower and a mutual fund managed by Empower. Certain investment fees were paid to Empower and reflected within the net investment income for the year. Other fees paid directly by the Plan or Plan participants to Empower totaled \$48,059, net of revenue sharing, for the year ended June 30, 2024. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. Certain other fees in the form of an expense ratio charged to each investment option are paid by the Plan

and deducted from earnings on investments. Transactions with related parties qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. Income Tax Status

The Employer adopted a Volume Submitter Plan Document, which received an advisory letter from the Internal Revenue Service (IRS) dated June 30, 2020, indicating that the non-standardized prototype plan document and trust are designed in accordance with the applicable section of the IRC. The Plan administrator and PPRM management believe the Plan, as amended, is being operated in compliance with the applicable requirements of the IRC and the Plan and related trust were tax-exempt. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

7. Risks and Uncertainties

The Plan provides for various investment securities in mutual funds and a fixed-rate group annuity contract. Investment securities, in general, are exposed to various risks, such as interest rate, overall market volatility, and credit risks. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Subsequent Events

The Plan has evaluated subsequent events through February 10, 2025, the date the financial statements were available to be issued. There were no events or transactions discovered during this evaluation that require recognition or disclosure in the financial statements.
