Opinion

1. Description of the Trust:

The following description of the Culinary and Bartenders Tip Earners Legal Assistance Fund provides only general information. Participants should refer to the Trust agreement for a more complete description of the provisions.

General:

The Culinary Workers Union, Local No. 226, and the Bartenders Union, Local No. 165, entered into an agreement to form the Culinary and Bartenders Tip Earners Legal Assistance Fund (Trust). Under this agreement, the signatory associations, their member employers, and the unions are parties to collective bargaining agreements.

The Trust was formed to provide assistance of legal counsel to the employees of the employers in tipped classifications who are subjected to audits of their tip income by the Internal Revenue Service. The member employers make contributions to the Trust of \$0.015 for each hour worked by each employee.

2. Significant accounting policies:

Basis of accounting:

The accompanying financial statements have been prepared on the cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. The cash basis of accounting differs from generally accepted accounting principles primarily because revenues are recognized as income during the period they are received rather than when earned and amounts payable for operating expenses are recognized when paid rather than when the obligation is incurred.

3. Affiliations:

The Trust is affiliated with the Culinary Workers Union, Local 226, and the Bartenders Union, Local 165.

4. Concentration of credit risks:

The Trust maintains a cash balance at one financial institution. The Federal Deposit Insurance Corporation insures up to \$250,000 per depository institution. The cash balance exceeded the limit of \$250,000 on June 30, 2024, by \$1,152,427.

5. Concentration of income sources:

The Trust received 100% of its total contributions from employers' remittances.

6. Administrative expenses:

The Trust pays all administrative expenses. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses.

7. Income tax status:

The Trustee originally applied to be exempt from federal income taxes under current provisions of Internal Revenue Code Section 501(c)(9). After review by the Internal Revenue Service, it was determined that the Trust is exempt under Section 501(c)(5). The Plan's tax returns are open for review by the Internal Revenue Service and/or the Department of Labor for three years from the filing date.

8. Plan termination:

Although they have not expressed any intent to do so, the Plan trustees reserve the right to amend, modify or terminate the Plan, in whole or in part, at any time subject to the provisions of ERISA. If the Plan is terminated, the Plan trustees will determine the timing and nature of the disposition of assets.

9. Subsequent events:

Management has evaluated subsequent events through February 28, 2025, the date which the financial statements are available to be issued.
