Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Johnstone Supply of Detroit 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to May 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Johnstone Supply of Detroit 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 31, 2024 and December 31, 2023 and for the period from January 1, 2024 to May 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Emphasis of Matter – Plan Merge

As discussed in Note 7 to the financial statements, the Plan merged into the Johnstone Supply LLC Employee Retirement Plan, the surviving plan, effective January 1, 2024, and all assets transferred out of the Plan on May 31, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Johnstone Supply of Detroit 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE:

1. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Johnstone Supply of Detroit 401(k) Plan (the Plan) are prepared under the accrual method of accounting.

Investments – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023.

Contributions – Contributions from plan participants and the matching contributions and profit-sharing contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits – Benefits to participants are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses – Administrative expenses in the amount of \$15,923 are shown on the Statement of Changes in Net Assets Available for Benefits. This amount represents administrative costs paid to third-party service providers for financial advisory and recordkeeping services.

Subsequent Events – The Plan has evaluated events and transactions that occurred through February 27, 2025, which is the date the financial statements were available for issue.

2. Plan Description

The following description of the Johnstone Supply of Detroit 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – Effective January 1, 1999, Chester Limited, Inc. dba Johnstone Supply of Detroit (the Company) adopted the Plan. Chester Limited, Inc. converted into Chester Limited Midwest, LLC on June 3, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Effective January 1, 2024 (date of merger), the trustees of the Plan approved the merger and subsequent transfer of plan assets into the Johnstone Supply LLC Employee Retirement Plan, the surviving plan. See Note 7.

Eligibility – Employees of the Company who have completed two months of service are eligible to participate in the Plan.

Contributions – Contributions to participants' accounts may be made through voluntary reductions in their compensation, rollover contributions from other qualified plans, as well as discretionary employer matching contributions and an employer profit sharing contribution. Employees participating in the Plan may contribute up to 100% of their total pay up to the limit in effect for the year. Participants aged 50 or older may make an additional "catch-up" contribution. There were no participant or employer contributions for the period from January 1, 2024 to May 31, 2024.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of the (a) employer's contribution, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All contributions are invested based on participant-directed investment programs.

Investment Options – Participants' accounts are self-directed within a limited number of funds.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the portion of their accounts funded by employer's matching contributions and profit-sharing contributions plus earnings thereon is based on years of continuous service according to the following schedule:

Forfeitures – At December 31, 2023, forfeited non-vested amounts totaled \$25,603. During the period from January 1, 2024 to May 31, 2024, forfeitures in the amount of \$26,859 were used to fund the December 31, 2023 employer contribution. On May 31, 2024, the forfeiture balance of \$27,633 was transferred to the surviving plan and will be used to offset future employer contributions or to pay allowable costs of plan administration.

Payments of Benefits – Participants or their beneficiaries may receive distributions of their account balances in a lump sum upon the earlier of reaching age 59 1/2, disability, death, or termination of service, as defined in the Plan. Further, the trustee may permit a participant who experiences a qualified financial hardship, as defined by the Plan, to receive a distribution of all or a portion of the participant's elective account balance.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans to participants are treated as transfers from the investment fund to the loan fund. Loan terms range from 1-5 years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at one percent over prime. Principal and interest are paid ratably through payroll deductions on at least a quarterly basis.

3. Related Party and Party-In-Interest Transactions

Certain Plan investments are managed by Empower Trust Company, the trustee, and therefore, these transactions are considered to be party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Certain administrative costs incurred by the Plan are paid by the plan sponsor. The Plan uses the staff, resources, and facilities of the plan sponsor to perform certain administrative activities related to the Plan. These transactions qualify as party-in-interest transactions. Participant notes receivable are classified as both related party and party-in-interest transactions.

4. Tax Status

The underlying standardized volume submitter plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the document is acceptable under Section 401(a) of the Internal Revenue Code. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

5. Certification of Financial Information

The following information included in the accompanying financial statements as of May 31, 2024 and December 31, 2023 and for the period from January 1, 2024 to May 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company: investments at fair value, notes receivable from participants, interest and dividends, and net appreciation/depreciation in fair value of investments.

6. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable input (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

Collective trusts: The fair value of participation units held in collective trust funds are based upon their net asset values as reported by the managers of the collective trust funds and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are op-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed annuities: Values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

Variable annuities: Values for variable annuity investment options are calculated daily by the annuity provider according to the methods described in the annuity contract.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Plan Merge

In September 2023, Chester Limited Midwest, LLC dba Johnstone Supply of Detroit was acquired by Johnstone Supply, LLC. Effective January 1, 2024, the Plan was amended, restated, and merged with and into the Johnstone Supply, LLC Employee Retirement Plan, sponsored by Johnstone Supply, LLC.

Each participant of the Johnstone Supply of Detroit 401(k) Plan as of January 1, 2024 became a member of the Johnstone Supply LLC Employee Retirement Plan, if not already a member. There was no payroll through Johnstone Supply of Detroit in 2024, and a blackout period began on May 23, 2024 in preparation for the transfer of Plan assets. All assets transferred out of the Plan on May 31, 2024.
