Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rededi8 Holdings Corp. Retirement, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Remedi8 Holdings Corp. Retirement's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Remedi8 Holding Corp. Retirement's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Description of plan

Remedi8 Holdings Corp. Retirement (the “Company”) sponsors the (the “Plan”), which is a defined contribution plan. This plan is the result of the combination of the Barrier Technologies Retirement Savings Plan and the Prevent Life Safety Services Retirement Plan. This combination occurred in August 2022. Substantially all employees of the Company are eligible to participate in the Plan subject to the eligibility criteria discussed below.

The Company controls and manages the operation and administration of the Plan. The Plan enables qualified employees of the Company to voluntarily defer compensation to provide additional income for retirement in accordance with Internal Revenue Code (“IRC”) Section 401(k). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan provisions.

Eligibility and contributions

All employees are eligible to participate in the plan except for the following: any employee who is included in a unit of employees covered by a collective bargaining agreement, if retirement benefits were the subject of good faith bargaining, and if the collective bargaining agreement does not provide for participation in this Plan, any leased employee and any employee who is a non-resident alien who received no earned income which constitutes income from services performed within the United States. In addition, employees must be over the age of eighteen, and have completed sixty days of service.

Eligibility begins on the first day of each Plan quarter, coincident with or next following the date the employee completes two months of service, measured from your date of hire.

Participants may elect to defer up to 100% of their compensation on a pre-tax basis, or as Roth contributions on an after-tax basis. Federal law also limits the amount you may elect to defer under the Plan.

The Company makes a matching contribution on the participant’s behalf in an amount of 100% of the participant salary deferral that do not exceed 3% of participant compensation plus 50% of participant salary deferrals between 3% and 5% of participant compensation.

The Company may, in its sole discretion, make a profit-sharing contribution on the participant’s behalf in an amount determined by the Company. Such contribution, if made, will be allocated in an amount designated by the Company to be allocated to eligible participants.

Participant accounts

Participant accounts are credited with the participant’s contributions, and an allocation of the Company’s matching and or profit-sharing contributions, if any, and Plan earnings.

Investments

The Participant may direct the investment of all their accounts in one or more of the available investment funds. The Participant's elections will be subject to such rules and limitations as the Plan Administrator may prescribe. The Plan administrator may restrict investment transfers to the extent required to comply with applicable law. The Participant may change the investment direction of their account as of each business day, subject to applicable laws regarding market timing and/or requirement of the funding source. The Plan is intended to constitute a plan described in section 404(c) of ERISA. This means that the Plan fiduciaries may be relieved of liability for any of your losses that are a result of the Participant's investment elections.

Vesting

The Participant will have fully vested and nonforfeitable interest in their elective deferral account and rollover contribution account. The Company's matching and profit-sharing contributions will vest based on the Participant's years of vesting service according to a 1-4 year graded vesting schedule (25% per year starting with one year of vesting service).

Participant loans and in-service withdrawals

Participant loans are not permitted by the Plan. Participants may receive a distribution from their account under the following circumstances: termination of employment or death.

Forfeitures

Forfeitures from Participant's nonvested accounts may be used by the Company to reduce future Company matching contributions, or pay administrative fees. The Company had no forfeitures in 2022.

Note 2 – Summary of significant accounting policies

Basis of accounting

The accompanying financial statements have been prepared in accordance with generally accepted accounting principles ("GAAP") in the United States of America. The December 31, 2021 balances of the merged entities have been combined.

Investments valuation and income recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at quoted market prices that represent the net asset value of shares held by the Plan at year-end. See Note 5 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of benefits

Payment of benefits are recorded when paid.

Note 2 – Summary of significant accounting policies (continued)

Income tax status

The Internal Revenue Service has determined by a letter dated March 31, 2014, that the prototype plan and related trust adopted by the Company are designed in accordance with the applicable IRC requirements and, therefore, the related trust is not subject to tax under current tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its tax qualification. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, as a result, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2019.

Use of estimates

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risk and uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

Plan termination

Although it has not expressed any intention to do so, the Company has the right at any time to amend the Plan document to discontinue future matching and or profit-sharing contributions or to terminate the Plan, subject to the provisions of the ERISA. In the event that the Plan is terminated, participants would become 100% vested in all of their accounts.

Subsequent events

Management has evaluated all events and transactions that occurred after December 31, 2022 through the date these financial statements were available to be issued. Management is not aware of any additional subsequent events that require recognition or disclosure in the financial statements.

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability, and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.
