NOTE 1 – DESCRIPTION OF PLAN

The following description of the Gulf Coast Restaurant Group, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 2016, is a defined contribution 401(k) profit sharing plan covering eligible employees of Gulf Coast Restaurant Group, Inc. and its controlled subsidiary companies (the "Plan Sponsor" or "Company"). The eligible class of employees has changed since the Plan was established. The most recent Plan restatement as of January 1, 2020 includes all managers, general managers, corporate office salaried individuals, key employees, and restaurant hourly employees of the Company who have completed thirty days of service; with no age requirement; are not leased employees; are not employees covered by a collective bargaining agreement; or non-resident aliens who do not receive any earned income from the employer which constitutes U.S. source income. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions and Participants' Accounts

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not in excess of Internal Revenue Code Section 402(g) limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common and collective trust as investment options for participants. The Plan does not have automatic deferral amounts. Deferral of annual compensation is based upon the participant election if they choose to enroll. The Plan's qualified default investment alternative is one of Principal's LifeTime Hybrid Collective Investment Trust based on the normal retirement date. The Plan includes a discretionary match from the Plan Sponsor which has been equal to 50% of the first 8% of annual compensation that a participant contributes to the Plan since inception. The discretionary match applies to all eligible persons for the entire Plan year. The Plan also allows for qualified nonelective contributions from the Plan Sponsor for discretionary bottom-up contributions. These qualified nonelective contributions are allocated only to non-highly compensated employees who were active participants at any time during the Plan year. Contributions are subject to certain statutory limitations.

Each participant's account is credited with the participant's 401(k) contribution, the Company's contribution, and the participant's account earnings. Each participant's account is charged with withdrawals, the participant's account losses, and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Forfeitures

Forfeitures are only on nonvested Plan Sponsor contributions and may first be used to pay administrative expenses. Remaining forfeitures, if any, may then be used to reduce employer contributions or allocated to participant accounts as additional nonelective contributions. In 2021 and 2020, \$685 and \$20 of the forfeiture balance was applied as a reduction to the employer contribution, respectively. The forfeiture balance totals \$673 as of December 31, 2020. There was no remaining forfeiture balance as of December 31, 2021.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of service as follows:

Participants also become 100% vested upon termination of the Plan, upon reaching the normal retirement age of sixty-five years old, or upon disability or death.

Payment of Benefits

Hardship distributions are permitted from the participant's vested account balance of participant contributions, employer contributions, and rollover contributions. The qualifying events and conditions of a participant's heavy and immediate financial hardship are defined in the Plan agreement. Hardship distributions cannot exceed the amount of the participant's financial hardship and may not be repaid by the participant. Due to the Bipartisan Budget Act of 2018, a participant is no longer required to have contributions suspended for six months following a hardship distribution.

The Plan administrator may be required by law to recognize obligations the participant incurs as a result of court-ordered support or alimony payments. The Plan administrator must honor a qualified domestic relations order (QDRO). If a QDRO is received by the Plan administrator, all or a portion of the participant's account balance may be used to satisfy the obligation.

Payment of Benefits (Continued)

In-service withdrawals of all or a portion of a participant's vested account balance may only be made upon circumstances of financial hardship, upon reaching age 59 ½, or a deemed severance distribution, in accordance with provisions specified in the Plan. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

Upon retirement, disability or death, a participant or beneficiary may receive the value of the account through a single sum distribution or direct rollover into an individual retirement account or an annuity, or installment options. In general, if a participant's account balance, as defined in the Plan agreement, is greater than \$5,000 and employment is terminated other than due to retirement or death, the account may not be distributed before normal retirement age without the participant's consent. Participants' account balances less than \$5,000 will be distributed as of the earliest date of retirement, death, or severance from employment.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to IRS penalties, unless the distribution is transferred to another qualified plan or individual retirement account.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account, reduced by any outstanding loan balance, or \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The notes are secured by the balance in the participant's account and bear interest at rates that range between 5.25% and 6.50% for 2020 and 2021, respectively, determined by the financial institution and periodically re-evaluated by the Plan for reasonableness. Principal and interest is paid ratably through bi-weekly payroll deductions.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by its investment advisors and the trustee. See Note 3 for discussion of fair value measurements.

Investments in common/collective trust funds are stated at net asset value as determined by the issuer of the funds based on the underlying investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for certain investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, these management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits

Benefit payments are recorded when paid by the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2021 and 2020, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan including legal, accounting, and Plan administration. Administrative expenses paid by the Plan total \$9,118 and \$5,389 for the years ended December 31, 2021 and 2020, respectively.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

ERISA Section 103(a)(3)(C) Audit

In July 2019, the American Institute of Certified Public Accountants Auditing Standards Board issued Statement on Auditing Standards No. 136. This new standard prescribes certain new requirements and changes the form and content of the auditor's report. The December 31, 2021 and 2020 audits are considered ERISA Section 103(a)(3)(C) audits, as early implementation is allowed. In order to qualify, the Plan investments must be held by a qualifying institution and provide a certification under 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA that the investment information is complete and accurate. As of December 31, 2021 and 2020, the investment information is certified by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company) the custodian for the Plan's assets. The financial statement amounts certified by the Principal Trust Company include investment assets, transactions, and income.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2021 and 2020.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Common/collective investment trusts: Valued at the NAV of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Pooled separate accounts: Valued daily based on the market value of the underlying net assets in each separate account. The underlying net assets have observable quoted pricing inputs which are used to determine the unit value which is not publicly quoted.

The methods described in the previous paragraphs may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INCOME TAX STATUS

The Plan Sponsor entered into a non-standardized adoption agreement of the Principal Financial Group Prototype for Savings Plans (Prototype Plan). The Prototype Plan received a favorable opinion from the IRS on March 31, 2014. The Prototype Plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving its latest opinion letter and has not obtained an updated opinion letter. However, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and tax exempt as of December 31, 2021 and 2020, and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2021 and 2020, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan experienced certain operational issues. To ensure the Plan remains qualified, the Plan Sponsor is in the process of correcting these errors following an appropriate correction method. A retroactive amendment has also been requested with the IRS, the results are pending.

NOTE 5 – RELATED PARTIES AND PARTIES-IN-INTEREST

Principal Life Insurance Company is contracted by the Plan to provide retirement plan processing services, and Principal Trust Company provides directed trust and custodial services (collectively, Principal). Services provided for the Plan result in fees charged to the Plan. While the Plan pays most of the fees, a portion is paid by the Plan Sponsor. The Plan offers investments issued by affiliates of Principal. These affiliates receive fees related to the investment earnings or losses. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments on the statements of changes in net assets available for benefits. Party-in-interest transactions also include loans made to participants. Fees, other than new loan fees, paid to Principal total \$9,118 and \$5,389 for the years ended December 31, 2021 and 2020, respectively.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provision of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 6 – PLAN TERMINATION

Although it has expressed no intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 8 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant account balances and the amounts reported in the accompanying statements of net assets available for benefits.

NOTE 9 – OPERATIONAL FAILURES AND PROHIBITED TRANSACTIONS

The Plan has various operational failures for multiple plan years. Management is in the process of making necessary corrections. The Plan also has a pending request to retroactively amend the Plan's definition of compensation. An estimated receivable is included on the statements of net assets available for benefits due to an operational failure which includes missed employee deferrals, employer match, and participant lost earnings. The other employer contribution receivable totals \$233,162 and \$150,799 for the years ending December 31, 2021 and 2020, respectively.

During 2020, the Plan did not timely remit some contributions and loan remittances. These are detailed on the Schedule H, Line (a) – Schedule of Delinquent Participant Contributions. Of the \$60,249 reported on the schedule, lost earnings on \$6,180 were corrected during the 2023 Plan year.

NOTE 10 – RECONCILIATION WITH 5500

As of December 31, 2021 and 2020, there were differences between the financial statements and the 2021 and 2020 IRS Forms 5500 (5500). The differences are due to the financial statements being presented on the full accrual basis of accounting and the 5500 being prepared on the modified cash basis of accounting. NOTE 11 – SUBSEQUENT EVENTS

Management evaluated subsequent events through May 15, 2024, the date on which the financial statements were available to be issued.

The Plan was restated effective February 18, 2022 with a new IRS opinion letter as of June 30, 2020. The restatement was updated with required regulatory changes. This includes changes related to the Bipartisan Budget Act of 2018, final regulations relating to hardship distributions, and Tax Cuts and Jobs Act. The effects of the restatement are not reasonably estimated.

Subsequent to year end, the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0, passed in 2022, subsequent modifications and amendments are expected due to the changes.

On October 6, 2023, an application for Voluntary Correction Program (VCP) was filed requesting retroactive amendments to the Plan for exclusions from definition of compensation and to identify adopting employers as part of a controlled group.

In connection with that correction filing, the Plan was amended on October 5, 2023. The amendments mostly include changes to exclude bonus pay from the definition of compensation and to identify adopting employers as part of a controlled group.
