NOTE 1: DESCRIPTION OF PLAN

The following description of the Case Management 401k Savings Plan ("Plan"), sponsored by CMU provides only general information. Effective, July 1, 2021 the Plan was amended, restated, and adopted the provisions of the Pennsylvania Pension Planners, Inc.. Non-Standardized Defined Contribution Pre-Approved Plan ("Plan Document"). Participants should refer to this Plan agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering all employees of CMU who are age twenty-one or older and have attained 6 months of service. It is subject to the provisions of the Employee Retirement Income Securities Act (ERISA) of 1974.

B. Contributions

Each year, participants may contribute up to 100% of pretax annual compensation ("eligible compensation"), as defined in the Plan. Effective July 1, 2021, the Plan allows for participants to contribute to a Roth option. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan currently offers 25 investment options for participants. For all enrolled participants, CMU makes a discretionary contribution equal to 1.5% of the participant's eligible compensation. For each participant electing to contribute 2% or more of their eligible compensation, CMU makes a matching contribution equal to 1% of their eligible compensation. CMU's matching contributions are invested in a portfolio of investments as directed by the participant. Contributions are subject to certain limitations.

C. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of CMU's contribution and Plan earnings; and charged with disbursements made to the respective participant, an allocation of administrative expenses, and an allocation of investment losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are immediately vested in all contributions.

E. Payment of Benefits

For all terminations of service, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

F. Participant Loans

Participant Loans are not permitted under the Plan.

G. Plan Termination

Although it has not expressed any intent to do so, CMU has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

H. Related Party Transactions

All Plan investments are shares of mutual funds managed by the Turnbridge Group. The Turnbridge Group is the financial advisor to the Plan and, therefore, all transactions qualify as party-in-interest transactions. Reliance Trust Company is the custodian of the Plan, and therefore those transactions qualify as party-in-interest transactions exempt from prohibited transaction rules. Transamerica Retirement Services is the record-keeper of the Plan, and therefore those transactions qualify as party-in-interest transactions exempt from prohibited transaction rules. PA Pension Planners is the third party administrator of the Plan, and therefore those transactions qualify as party-in-interest transactions exempt from prohibited transaction rules.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan maintains its records and prepares its financial statements under the accrual method of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Payment of Benefits

Benefits are recorded when paid.

E. Subsequent Events

The Plan has evaluated subsequent events through March 4, 2025.

NOTE 3: PLAN ADMINISTRATION

The Plan is administered by CMU. CMU has entered into a Trust Agreement with the Trustees giving them the authority to manage Plan assets, which were maintained by Reliance Trust Company. The Plan is responsible for payment of all investment management fees, except for nominal quarterly fees charged to each participant's account. For the years ended June 30, 2024 and June 30, 2023, costs paid by the Plan for these fees were \$40,071 and \$35,013, respectively. All other administrative costs (i.e. payroll costs related to Trustees of the Plan) are paid by CMU and are not a deduction from Plan net assets.

NOTE 4: TAX STATUS

Effective July 1, 2021, the Plan amended, restated, and adopted the provisions of the Pennsylvania Pension Planners, Inc.. Non-Standardized Defined Contribution Pre-Approved Plan ("Plan Document"). The Internal Revenue Service has determined and informed Pennsylvania Pension Planners, Inc., by letter dated June 30, 2020, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has only elected options that are permitted under the terms of the approved Plan Document.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5: INVESTMENTS

During 2024 and 2023 the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$423,594 and \$359,833, respectively.

NOTE 6: CERTIFIED FINANCIAL INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at June 30, 2024 and 2023, net appreciation/(depreciation) in fair value of investments, and interest and dividends, from participants for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust (the trustee/custodian) of the Plan.

The following information certified by Reliance Trust was relied upon in the preparation of the 2024 and 2023 financial statements:

- Investment amounts included in the Statements of Net Assets Available for Benefits at June 30, 2024 and 2023.
- Interest and dividends income and net appreciation/(depreciation) in fair value of investments included in the Statements of Changes in Net Assets Available for Benefits for the years ended June 30, 2024 and 2023.

NOTE 7: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Registered Investment Companies: Primarily valued using market quotations or prices obtained from independent pricing sources (net asset value of shares held by the plan at year end). Money Market Fund holdings are valued at amortized cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9: GUARANTEED INVESTMENT CONTRACT WITH TRANSAMERICA

The Plan entered into a benefit-responsive guaranteed investment contract with Transamerica totaling \$454,141 and \$242,916 for 2024 and 2023, respectively. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value, which for the Plan approximates fair value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 9: GUARANTEED INVESTMENT CONTRACT WITH TRANSAMERICA (CONTINUED)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 10: SUBSEQUENT EVENT

In October 2024, CMU filed with the Pennsylvania Department of State to begin doing business as "Pathways Forward". CMU is still in the process of adopting this new name in regards to the Plan, and has not yet officially amended the Plan name as of March 4.
