We have performed audits of the financial statements of Revenir Energy Services LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 23, 2024 (In Liquidation) and December 31, 2023 (Ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through December 23, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 23, 2024 and December 31, 2023, and for the period from January 1, 2024 through December 23, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). As further discussed in Note 1 to the financial statements, the governing body of the Plan approved the termination of the Plan on July 19, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the In Liquidation of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. ## Notes to Financial Statements

### 1. Plan Description

The following description of the Revenir Energy Services LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan was a defined contribution plan established April 1, 2006, by Revenir Energy Services LLC (the Plan Sponsor, the Company, or Revenir) and was most recently restated on June 1, 2021. The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which included a qualified deferred income arrangement, as described in Section 401(k) of the IRC. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Plan Termination*

As the result of the sale of the Plan Sponsor, effective July 19, 2024, the Plan Sponsor terminated the Plan. Contributions to the Plan ceased on the effective date and all affected participants were 100% vested in their account balance to the extent not already fully vested.

#### *Administration of the Plan*

Empower Trust Company, LLC was the trustee of the Plan, Empower Annuity Insurance Company of America was the issuer of the insurance contract, and Empower Retirement was the recordkeeper (Empower). Pentec Pension Management Group, Inc. (Pentec) was the Plan's third-party plan administrator.

#### *Eligibility*

An employee of the Company was considered to be an eligible participant in the Plan if they attained the age of 18. Non-resident aliens and employees covered by a collective bargaining agreement were not eligible for the Plan.

#### *Contributions*

Each year participants could contribute up to 100% of their pre-tax annual compensation, as defined in the Plan Document, and had the option to designate either all or a portion of their contributions as after-tax Roth contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The Company provided Safe Harbor matching contributions equal to 100% of the participant's deferrals up to 8% of eligible compensation as defined by the Plan Document during 2024.

The Company was also allowed to make discretionary matching and profit-sharing contributions in an amount to be determined at Plan year-end by the Company. During 2024, there were no discretionary matching and profit-sharing contributions made to the Plan.

Participant and employer contributions were subject to certain limitations under the IRC.

Rollover contributions transferred from other qualified retirement plans or from Individual Retirement Accounts (IRA) were accepted as permitted by the Plan Document.

### ***Participants' Accounts and Investment Options***

Each participant's account was credited with the participant's elective deferral contributions (pre-tax and Roth), rollover contributions, Safe Harbor matching contributions, discretionary matching contributions, profit-sharing contributions, and an allocation of net Plan earnings or losses and debited with distributions and Plan expenses. The investment earnings or losses were allocated to each participant's account in the proportion that the balance of each participant's account bore to the total balance of all participants in each investment option.

Participants could direct the investment of their account balances into various investment options offered by the Plan. The Plan offered various mutual funds and a guaranteed investment contract. Participants could make investment option changes at any time. The benefit to which participants were entitled was the vested portion of their accounts.

### ***Vesting***

Participants were 100% vested in their elective deferral contributions, rollover contributions, Safe Harbor matching contributions, and the allocated earnings thereon. The discretionary matching contributions and profit-sharing contributions vested ratably 20% per each year of service and became fully vested at the end of a five-year service period.

Participants also became 100% vested at Plan termination, normal retirement (age 59½), or upon death or disability, as defined.

### ***Forfeitures***

Forfeitures occurred when a participant terminated employment before becoming 100% vested with respect to the Employer discretionary matching and profit-sharing contributions. Forfeiture allocations were used to pay administrative expenses of the Plan, and any remaining amounts were used to reduce employer contributions. Forfeited non-vested accounts were \$0 as of December 23, 2024 and \$13,459 as of December 31, 2023. During 2024, \$10,021 was used to fund employer contributions and \$27,477 was used to pay administrative expenses.

### ***Payment of Benefits***

A participant's entire interest in the Plan was payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant could elect to receive a lump-sum amount equal to the participant's vested balance or installments administered by Empower. Participant account balances of less than \$1,000 were distributed automatically upon termination. Balances greater than \$1,000 and up to \$5,000 were paid as a rollover into an IRA on behalf of the participant. These mandatory distributions apply only if the participant had not made an affirmative election for distribution. Hardship withdrawals were permitted in certain situations, as stipulated within the Plan Document, and could only be made from participant elective deferral amounts.

### ***Notes Receivable from Participants***

Participants were permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants could borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding note balance in their account during the prior 12-month period. Notes were secured by the participant's account and bore an interest rate commensurate with the market. The interest rate was fixed for the term of the note. The note was repaid ratably through payroll deductions over a period of five years or less, unless the note was for a primary residence. These notes were subject to certain restrictions, as defined by the Plan Document, and applicable restrictions under the IRC. A participant could not have more than one note outstanding at any time.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

Financial Accounting Standards Board (FASB) issued Accounting Standards Codification (ASC) 205-30, *Presentation of Financial Statements: In Liquidation of Accounting*, which requires an entity to prepare its financial statements using the In Liquidation of accounting when liquidation is imminent. The Plan implemented ASC 205-40 for the 2024 Plan year, as this is when liquidation was determined to be imminent. Therefore, the accompanying financial statements have been prepared on a liquidation basis of accounting in 2024. The adoption did not have a material impact on the financial statements.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments were reported at fair value (except for the guaranteed investment contract, which was reported at contract value) as further described in Note 4. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determined the Plan's valuation policies utilizing information provided by Empower.

Interest income was recorded when earned on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments represents realized and unrealized gains and losses on the investments, capital gains reinvested, as well as any investment fees charged within the registered investment companies. Purchases and sales were recorded on a trade-date basis.

### ***Contributions***

Participant deferral contributions and related employer contributions were recognized in the Plan year during which the Company made the respective payroll deduction from the participant's compensation.

### *Payment of Benefits*

Benefit payments to participants were recorded when paid.

### *Notes Receivable from Participants*

Notes receivable from participants were measured at their unpaid principal balance. Related fees were recorded as administrative expenses and were expensed when incurred. If a participant ceased to make loan repayments and the Plan Sponsor deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

### *Expenses of the Plan*

Plan expenses of \$97,197 were paid by the Plan during 2024. These expenses were related to participant requested transactions, such as loans and distributions, as well as fees for recordkeeping, investment advisory, legal, and audit fees. Certain fees in the form of an expense ratio were charged within the investments and were reflected in the net appreciation in fair value of investments. All other expenses of the Plan during 2024, if any, were paid by the Company and excluded from these financial statements.

## **3. Certified Investment Information**

The Plan Sponsor elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, qualified institutions, have certified that the following information included in the accompanying financial statements as complete and accurate:

- Investments and notes receivable from participants as reported in the statements of net assets available for benefits as of December 31, 2023 (Ongoing).
- Net investment income and interest earned on notes receivable from participants as reported on the statement of changes in net assets available for benefits for the period from January 1, 2024 through December 23, 2024 (In Liquidation).
- Investment amounts included in the notes to financial statements.

At the request of the Plan Sponsor, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

## **4. Fair Value Measurements and Disclosures**

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs are the highest priority and consist of unadjusted quoted prices in active markets for identical assets and liabilities. Level 2 inputs are inputs for quoted prices for similar assets or liabilities in active markets; inputs for quoted prices for identical or similar assets or liabilities in

inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are the lowest priority and are unobservable and significant to the fair value measurement of an asset or liability.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Registered Investment Companies (Mutual Funds)* - These assets are valued at the daily closing price as reported by each fund. Registered investment companies held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan were deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Guaranteed Investment Contract

The Plan entered into a benefit-responsive investment contract with Empower Annuity Insurance Company of America (formerly named Great-West Life & Annuity Insurance Company). Empower maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Guaranteed Investment Contract (GIC) issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates were reviewed on a semi-annual basis for resetting.

The GIC was valued at contract value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Since the participants transacted at contract value, contract value was determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, the Plan Sponsor's Investment Committee evaluated a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs were assessed through review of contract terms (for example, duration or payout date), while others were substantiated utilizing available market data (for example, swap curve rate). Upon termination of the Plan, there was no adjustment to the contract value.

### 6. Income Tax Status

The Plan adopted a non-standardized pre-approved plan document sponsored by Pentec, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the plan document, as designed, was in compliance with the applicable requirements of the IRC including amendments to comply with recent legislation. The Plan Sponsor believes that the Plan, as designed and amended, operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Related Party and Party-in-Interest Transactions

The Plan invested in various investments managed by Empower. Empower was the Plan's investment trustee and issuer of the insurance contract and provides record keeper services to the Plan; therefore, certain transactions qualified as party-in-interest transactions. In addition, Empower provided certain administrative services to the Plan's investment providers and received revenue from such services. If the revenue received by Empower from such investment service providers exceeds the amount owed under the service agreement, Empower remitted the excess agreed upon share of the revenue into the Plan's plan expenses account within the trust. Such amounts would have been applied to pay administrative expenses of the Plan. During the period ended December 31, 2024, there were excess amounts of approximately \$30,000 remitted to the Plan and utilized to offset expenses from various service providers, including audit fees, which are considered party-in-interest transactions.

Notes receivable from participants also qualified as parties-in-interest transactions. Fees paid by the Plan to Empower, investment advisors, and the auditor amounted to \$97,197 during 2024.

These transactions are exempt from the prohibited transaction rules.

### 8. Subsequent Events

Plan management has evaluated subsequent events through March 4, 2025, which is the date the financial statements were available to be issued. There were no events or transactions discovered during this evaluation that require recognition or disclosure in the financial statements.
