INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
403(b) Thrift Plan for People, Incorporated:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 403(b) Thrift Plan for People, Incorporated (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of June 30, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

1. Description of the Plan

The following description of the 403(b) Thrift Plan for People, Incorporated (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan that contains a salary deferral arrangement as described under Internal Revenue Code (IRC) Section 403(b). All employees of People, Incorporated (the Employer) are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the Plan Administrator. As Plan Administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Mutual of America Life Insurance Company (Mutual of America) is the appointed custodian of the Plan and acts at the direction of the Plan's administrator.

Contributions

Participants may elect to contribute a percentage of their eligible compensation, as defined in the Plan documents, not to exceed annual limitations as provided by the IRC. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Effective October 1, 2022, the Plan was amended to allow participants to designate all or a portion of their elective deferrals as Roth deferrals. In addition, participants may contribute amounts representing distributions from other qualified plans (rollovers).

The Plan provides for Employer matching and discretionary contributions. Effective October 1, 2022, matching contributions are equal to 100% of the participant's contribution limited to 4% of eligible compensation, as defined in the Plan document, with a maximum contribution of \$1,000 per participant per year. Prior to October 1, 2022, matching contributions were equal to 100% of participant contributions limited to 2% of eligible compensation with a maximum contribution of \$500 per participant per year. During the year ended June 30, 2024, the Employer made matching contributions equal to \$157,273. There were no discretionary contributions made during the year ended June 30, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's contribution, and their allocation of the Plan's earnings and expenses incurred. Allocations are based on compensation or individual participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Plan Loans

Participants may request a Plan loan from the custodian up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Mutual of America issues and administers the loans to participants on behalf of the Employer, and as such, loans are not Plan receivables or directed investments in the Plan. In accordance with the agreement between Mutual of America and the participant, Plan loans are secured by the balance of the participant's account, which must be held in the insurance company general account investment option as collateral. The maximum loan term is 5 years, except for the purchase of a primary residence for which the maximum loan is 10 years. Loans bear a reasonable rate of interest that may not exceed the legal limit, which is commensurate with local prevailing rates as determined periodically by Mutual of America (5.85% and 4.60%) at June 30, 2024 and 2023, respectively). Principal and interest are paid ratably through payroll deductions. Participant loans outstanding with Mutual of America at June 30, 2024 and 2023 were \$105,780 and \$49,093, respectively.

Vesting

Participants are immediately vested in their contributions and Employer contributions plus actual earnings thereon.

Payment of Benefits

On termination of service, death, disability or retirement, a participant may elect to receive a lump-sum amount, installment payments (if the participant is at least age 55) equal to the value of the participant's account, or a qualified joint and survivor annuity. Participants who have attained age 59½ may elect to withdraw amounts in their employee deferral account while still employed by the Employer. Participants, by written request to the Plan's administrator, may request a financial hardship withdrawal from their employee deferral accounts, subject to the limitations imposed by the IRC. Upon termination, if a participant's vested balance is less than \$5,000, the participant will receive an immediate cash-out of their account balance.

Effective January 1, 2023, the Plan adopted a provision of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE) Act 2.0, which increased the age of the required minimum distributions (RMD) to begin from 72 to 73.

Effective January 1, 2024, the Plan adopted certain provisions of the SECURE Act 2.0, which permits spousal beneficiaries of deceased participants to elect to have the RMD rules applied as if the surviving spouse were the deceased participant and participants with Roth contribution sources will be exempt from pre-death RMD requirements.

Investment Options

Participants may direct their contributions in percentage increments into a series of fund options offered by Mutual of America to be held in the Plan's separate accounts. Alternatively, participants may invest their funds in the interest accumulation account, which provides a stated rate of return as the invested funds are held in Mutual of America's general account. Participants may change their investment options at any time.

Plan Termination

The Plan Administrator expects to continue the Plan indefinitely. However, the Plan Administrator reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for the purpose other than for the exclusive benefit of the Plan participants and any Plan terminations would be subject to the provisions of ERISA. In the event of Plan termination, the participants are entitled to receive all amounts credited to their accounts.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

Investments in the insurance company general account are held in an interest accumulation account in accordance with the contract and are stated at contract value (Note 4). Investments in the insurance company separate accounts are valued at net asset value (NAV) as the practical expedient that approximates fair value (Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by investment advisors and the custodian.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participant and Employer contributions are recorded when the Employer remits the contributions for investment into the funds. Participant and Employer matching contributions are remitted bi-weekly. Employer discretionary contributions, if applicable, are remitted annually.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

Expenses incurred in the administration of the Plan are paid by the Employer unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant maintenance fees are paid directly by the participants through a reduction in their account and are included in the administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single custodian. The Plan's exposure to credit risk is associated with the custodian's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value on a recurring basis.

Insurance Company Separate Accounts: Valued using the NAV provided by the administrator of the fund based on the fair value of the underlying investments. Participant transactions (purchases and sales) may occur daily. There is no redemption notice period for these investments, though a redemption, once requested, may take up to 7 days to process.

As of June 30, 2024 and 2023, the Plan did not have investments that would be included in the fair value hierarchy as noted above. However, the Plan's investments in insurance company separate accounts are reported at NAV per share (or its equivalent) and in accordance with Accounting Standards Codification Subtopic 820-10, would be presented outside the fair value hierarchy as a reconciling item.

4. Investment Contract with Insurance Company

The Plan has entered into an investment contract with Mutual of America. Amounts held in connection with this contract may be held in Mutual of America's general account or separate accounts which invest in mutual funds advised by Mutual of America, mutual funds sub-advised by third parties, mutual funds managed by external mutual fund companies or invested directly in securities. Contributions allocated to the interest accumulation account are invested in the general account of, and are guaranteed by, Mutual of America. All other contributions allocated to any investment fund become part of separate accounts and are maintained separately from the general assets of Mutual of America. The value of the general account investments included in the financial statements is reported at contract value, as reported to the Plan by Mutual of America. Contract value is equal to the sum of contributions made plus earnings, less participant withdrawals and administrative expenses.

The insurance company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum crediting rate under the contract is 3.00%. Participant transactions may occur daily. Certain redemption restrictions exist if the Plan were to liquidate the entire holding of the general account investment.

The guarantee of values provided for the investment made with Mutual of America under the Plan's investment contract is based on the financial strength and claims-paying ability of Mutual of America.

5. Income Tax Status

Final regulations under Section 403(b) were published by the Internal Revenue Service (IRS) on July 26, 2007. Under the regulations, a 403(b) plan sponsor by December 31, 2009 must have adopted a written plan intended to satisfy the requirements of Section 403(b) and the regulations effective as of January 1, 2009. The Employer adopted a written plan effective January 1, 2009, which it believes satisfies the written plan requirement. While the IRS does not intend to establish a determination letter program for individually designed 403(b) plans, the Employer believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

8. Related Party Transactions

Plan investments are held and managed by Mutual of America, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payment to Mutual of America for administrative services in the amount of \$2,034 for the year ended June 30, 2024.

9. Subsequent Events

Effective January 1, 2025, the Plan adopted a provision of the SECURE Act 2.0, which increased the catch-up contribution limit for participants between the ages of 60 and 63 to the greater of \$10,000 or 150% of the regular catch-up contribution.

Management has evaluated subsequent events through March 4, 2025, which is the date these financial statements were available to be issued.
