We have performed an audit of the financial statements of the Modern Campus USA, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of September 30, 2022, and the related statement of changes in net assets available for benefits for the for the period from January 1, 2022 through September 30, 2022, and the related notes to the financial statements ("2022 financial statements").



NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2022 AND DECEMBER 31, 2021 (UNAUDITED)

1. DESCRIPTION OF THE PLAN

The following description of the Modern Campus USA, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. The Plan was originally established January 1, 2011.

General – The Plan is a defined contribution plan that covers substantially all employees of Modern Campus USA, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Reliance Trust Company serves as the trustee and custodian for the Plan. ADP Retirement Plan Services (“ADP”) serves as the third-party administrator (“TPA”).

Effective June 1, 2021, the Plan’s name changed from Omni Update Inc. 401(k) Plan to Modern Campus USA, Inc. 401(k) Plan. The Plan adopted the Third Cycle Restatement effective July 1, 2021. Additional provisions of the Plan have changed as discussed below.

The Company acquired Presence on June 24, 2021, and eligible employees joined the Plan effective January 1, 2022.

Plan Merger – The Plan participants merged into the Safewise Pooled Employer Plan effective September 30, 2022. The Company remitted its last contribution to the Plan effective September 27, 2022.

Eligibility – An employee is eligible to defer a portion of his or her salary to the Plan upon reaching the age of 18 and one full calendar month of service. Effective July 1, 2021, the service requirement changed to three months of service with entry on the first day of the month coinciding with or next following the satisfaction of the eligibility requirements. The Plan excludes employees classified as leased, union, non-resident aliens, residents of Puerto Rico, and interns.

Contributions – Participants may contribute up to 90% of their annual compensation, subject to certain Internal Revenue Code (“IRC”) limitations. Participants over age 50 are permitted to make catch-up contributions. Upon reaching the eligibility conditions, a participant will automatically be enrolled in the Plan to defer 4% of compensation, unless another amount is elected in writing.

Additionally, for those employees who are automatically enrolled in the Plan, each participant’s deferral amount will automatically increase by 1% each anniversary date, up to a maximum amount of 10%, unless the participant elects in writing some other deferral amount.

Effective July 1, 2021, the Company makes a matching contribution of 50% of deferrals up to 4% of eligible compensation. These contributions are calculated and paid into the Plan every payroll. No employer contribution was in effect prior to July 1, 2021.

Participant Accounts – Each participant’s account is credited with the participant’s contribution, employer contributions, and allocations of Plan earnings, and is charged with the participant’s withdrawals and distributions, and share of Plan expenses, if any. The Plan is valued daily, and Plan earnings are allocated to the participants’ accounts based on the value of shares held by the participants in each of the respective funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – The Plan offers various mutual funds and common collective trust funds as investment options for participants.

Vesting – Participants' contributions are fully vested at all times. Company contributions become fully vested after 1 year of service. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested.

Forfeitures – Forfeitures occur upon termination of a participant whose account is not fully vested. Forfeiture amounts are used to pay any administrative expenses and to reduce employer contributions. During the period from January 1, 2022 to September 30, 2022, \$872 in forfeitures was used to pay Plan expenses. There are \$0 in forfeitures available at September 30, 2022 and December 31, 2021.

Payment of Benefits – Upon termination of service, a participant may elect to receive a distribution of all or any portion of their vested account balance in a single lump sum payment or a rollover into an IRA or other eligible retirement plan, as defined by the Plan document. For distributions greater than \$1,000 but not exceeding \$5,000, the account balance will be distributed to the participant or rolled over into an individual retirement account, unless otherwise directed by the participant.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment.

- Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals have a \$500 minimum and are limited to active employees and accounts that are 100% vested.
- Participants who have obtained the age of 59 ½ are allowed to receive a distribution of all or any portion of their fully vested contribution accounts, with a \$500 minimum, as defined by the Plan.
- Participants may withdraw accounts that are designated as rollover contributions at any time.

Administrative Expenses – Administrative expenses incurred by the Plan may be paid by the Plan or by the Company. During 2022, the Plan paid administrative expenses of \$899.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' accounts would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Employee and employer contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds and common collective trust funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management's Review – Subsequent events have been evaluated through March 11, 2025, which is the date the financial statements were available to be issued, and there were no subsequent events to disclose.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2022 and December 31, 2021.

Mutual Funds – Valued at the net asset value of shares held by the Plan at year end.

Common Collective Trusts – The investment manager calculates a unit value (similar to a net asset value "NAV"), which is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All investments in the Plan have merged with the new Plan; therefore, there are no investments at September 30, 2022. The Plan's investments are reported at fair value as follows at December 31, 2021:

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan's assets, has certified that the following data included in the accompanying financial statements are complete and accurate with respect to investments as of September 30, 2022 and December 31, 2021, and for the period January 1, 2022 to September 30, 2022:

- Investments, at fair value
- Notes receivable from participants and related interest
- Interest and dividend income
- Net depreciation in fair value of investments

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain fees are paid to the TPA, and these are party-in-interest transactions.

7. TAX STATUS

The Company has adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with CODA which received a favorable opinion letter from the Internal Revenue Service on October 6, 2020, stating that the prototype plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
