Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Stanford University Post-Retirement and Post-Employment Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Stanford University Post-Retirement and Post-Employment Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stanford University Post-Retirement and Post-Employment Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Stanford University Post-Retirement and Post-Employment Benefit Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Stanford University Post-Retirement and Post-Employment Benefit Plan's internal control. Accordingly, no such opinion is expressed.

- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Stanford University Post-Retirement and Post-Employment Benefit Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

NOTE 1 – DESCRIPTION OF THE PLAN

General – The following description of the Stanford University Post-Retirement and Post-Employment Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

The Plan is a health and welfare plan that was established on January 1, 1995, by the sponsor of the Plan, the Board of Trustees of the Leland Stanford Junior University (the University). The University has appointed a plan administrator to manage the operation and administration of the Plan. The University has established a Voluntary Employee Beneficiary Association (VEBA) trust account, which holds the Plan's investments, and has contracted with Vanguard Fiduciary Trust Company (Vanguard) to act as the trustee, custodian, and investment manager of this trust. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan provides post-retirement medical, prescription drug, mental health and substance abuse, vision, and dental benefits (in excess of Medicare coverage) to retired employees of the University and their eligible dependents, as defined in the Plan. The Plan also provides post-employment medical, prescription drug, mental health and substance abuse, and life insurance benefits to terminated employees who had been receiving long-term disability benefits prior to their termination, and the same benefits excluding life insurance for their eligible dependents, as defined in the Plan.

Eligible participants – Employees of the University who retire with at least 10 years of benefits-eligible service will be eligible for retiree benefits under the Plan if they satisfy the following criteria:

1. were hired before January 1, 1992, and are at least age 55 at retirement, or
2. whose age plus years of benefits-eligible service with the University equal at least 75.

Employees of the University whose employment terminated while receiving benefits under the University's long-term disability program and who continue to receive benefits under this program are eligible for post-employment benefits under the Plan.

Contributions – The University and participants share in the cost of benefits provided by the Plan. Depending on the type of coverage selected by the participants, contributions may include HMO premiums, self-insured claims, and administrative service fees. The participant’s and the University’s share of costs for each calendar year are determined and published annually in the open enrollment literature. For retired employees that were hired after December 31, 2005 (cardinal retiree), the University subsidizes a portion of their medical coverage; any costs over the subsidy level will be borne by the participant. The University’s annual contribution rates for 2024 and 2023 are as follows:

The University’s contribution strategy operates on a calendar year basis even though the Plan has a year end of August 31. In addition, if the actuarial estimate of the benefit cost for employees retiring during the next year exceeds the University’s pay-as-you-go cost for those benefits, the University contributes an amount to the VEBA trust account, which holds the Plan’s investments.

Payment of administrative expenses – Trustee and investment manager fees to Vanguard are paid out of plan assets. Administrative and claims processing fees paid to insurance companies and other related expenses are paid through the general assets of the University and recorded as expenses of the trust and employer contributions to the extent the amounts are not reimbursed by the VEBA trust. Auditing, actuarial, and all other plan expenses are paid by the University.

Plan termination – While the University expects to continue the Plan, the Plan may be amended or terminated at any time. If the Plan terminates, plan assets will be used to pay all eligible claims to the extent available.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and use of estimates – These financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). These principles require the plan administrator to make estimates and assumptions that affect the reported amounts of assets and benefit obligations, and the disclosures of contingent assets and benefit obligations at the date of the financial statements and the reported amounts of changes in benefit obligations and net assets available for benefits during the report period. Actual results could differ from those estimates.

Risks and uncertainties – Plan assets are invested in investment securities offered by Vanguard based on a policy statement approved by the Retirement Program Investment Committee (RPIC). Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the risks associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions, post-retirement benefit obligations, and post-employment benefit obligations are prepared based on certain assumptions pertaining to interest rates, discount rates, inflation rates, and employee demographics, all of which are subject to change. It is at least reasonably possible that near-term changes in estimates and assumptions used in preparation of the financial statements would be material to the financial statements.

Medicare subsidy – The Plan's post-retirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003 because the Plan is not directly entitled to the Medicare subsidy. The University has included the effects of the Medicare subsidy in measuring its post-retirement benefit obligation; therefore, the Plan's post-retirement benefit obligation differs from the amounts reflected in the Annual Report of that of the University.

Investment valuation – The investments are stated at fair value. The Plan's custodian, Vanguard, certifies the fair value of all investments. If available, quoted market prices are used to value investments.

The policy of Vanguard and the VEBA trust is to value securities at the last quoted market price on the last business day of the year or, where no quoted market price is available, at estimated fair value.

Income recognition – Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation of those investments.

NOTE 3 – INVESTMENTS

The valuation methodology, investment categories, and fair value hierarchy of the investments held by the Plan are discussed below.

Valuation methodology – To the extent available, the Plan's investments are recorded at fair value based on quoted prices in active markets. The Plan's investments that are listed on any U.S. or non-U.S. recognized exchanges are valued based on readily available market quotations. When such inputs do not exist, fair value measurements are based on the best available information and usually require a degree of judgment.

Stanford University Post-Retirement and Post-Employment Benefit Plan Notes to Financial Statements

These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan sponsor believes its valuation methods for the Plan's investments are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The RPIC exercises due diligence in assessing the policies, procedures, and controls implemented by Vanguard. Such due diligence procedures include, but are not limited to, ongoing communication and review of information from Vanguard as well as a quarterly investment performance review.

Fair value hierarchy – U.S. GAAP defines fair value as the price received upon sale of an asset or paid upon a transfer of a liability in an orderly transaction between market participants. Current guidance establishes a hierarchy of valuation inputs based on the extent to which the inputs are observable in the marketplace. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data or correlation or other means. If the asset or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 4 – BENEFIT OBLIGATIONS

Post-employment benefit plan obligation – The post-employment benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to date. Post-employment benefits include future benefits expected to be paid to currently terminated employees and their dependents who had been receiving long-term disability benefits prior to their termination.

The actuarial present value of the expected post-employment benefit obligations are determined by the Plan's actuary based on actuarial assumptions and participant data. The calculations are also adjusted for the time value of money (through discounts for interest), the probability of payments (with means of decrements such as those for death, disability, or withdrawal) between the valuation date and the expected date of payment, and the expected premiums to be received from participants.

To determine the accumulated post-employment obligation at August 31, 2024, a medical trend of 6.92% in calendar year 2024 grading down to 4.00% in 2050 is assumed.

To determine the accumulated post-employment obligation at August 31, 2023, a medical trend of 6.96% in calendar year 2023 grading down to 4.00% in 2048 is assumed.

The discount rate used for August 31, 2024 and 2023, was 4.48% and 5.22%, respectively.

For 2024 and 2023, a change in medical and life insurance liabilities (for claims incurred but not reported) of (\$63,000) and \$38,000, respectively, has been included in the benefit obligation to cover disabled employees who may have been disabled prior to August 31, 2024 and 2023, but who may not appear in the University census data because they are still within the six-month elimination period. This liability was calculated based on the average liability for a new entrant, multiplied by the expected number of new entrants in a twelve-month time period.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan was to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the post-employment benefit obligation.

Post-retirement benefit obligation – The post-retirement benefit obligations represent the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to date. Post-retirement benefits include future benefits expected to be paid to:

1. currently retired employees and their covered beneficiaries; and
2. active employees and their covered beneficiaries after retirement from service with the university.

The actuarial present value of the expected post-retirement benefit obligations are determined by the Plan's actuary based on actuarial assumptions and participant data. The calculations are also adjusted for the time value of money (through discounts for interest), the probability of payments (with means of decrements such as those for death, disability, or withdrawal) between the valuation date and the expected date of payment, and the expected premiums to be received from participants.

For the years ended August 31, 2024 and 2023, for legacy retirees (participants hired prior to December 31, 2005, as defined in the Plan), the Plan assumed that 87% of active participants with current medical coverage would elect medical coverage upon retirement, that 10% would postpone coverage until age 65, and that 3% would waive coverage indefinitely. For the year ended August 31, 2024, for cardinal retirees, the Plan assumed that 50% of active participants with current medical coverage would elect medical coverage upon retirement, that 30% would postpone coverage until age 65, and that 20% would waive coverage indefinitely. Assumptions are reviewed periodically by the actuaries and the University.

Health care cost trend rate assumptions have a significant effect on the amounts reported for health care plans. To determine the accumulated post-retirement obligation at August 31, 2024 and 2023, a medical trend of 7.80% and 8.90% in calendar year 2024 and 2023, respectively, grading down to 4.00% in 2049 and 2048, respectively, is assumed. Increasing the health care cost trend rate by 1% in each future year would increase the obligation by \$102,618,000 and \$86,550,000 at August 31, 2024 and 2023, respectively. Decreasing the health care cost trend rate by 1% in each future year would decrease the obligation by \$82,167,000 and \$69,645,000 at August 31, 2024 and 2023, respectively.

Retirement rate	Various rates ranging from 1.5% to 20% between ages 50 to 79 and 100% at age 80 for fiscal 2024 and 2023.
Mortality	For the years ended August 31, 2024 and 2023, mortality is assumed to follow the PRI-2012 white collar table. Future mortality improvement will follow information provided by the Social Security Administration as reflected in the MSS-2024 and MSS-2023 improvement scale developed by Mercer for fiscal 2024 and 2023, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the post-retirement benefit obligations.

Claims incurred but not reported – Plan obligations at August 31, for claims incurred but not reported are estimated by the Plan’s actuary in accordance with accepted actuarial principles based on claims data provided by the Plan’s third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

NOTE 6 – TAX STATUS

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (the IRS) dated October 31, 1996, stating that the trust is tax-exempt under the provisions of Section 501(a) of the Code. Accordingly, there is no provision for federal or state income taxes.

In addition, the Plan and the VEBA trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the related VEBA trust is tax exempt.

U.S. GAAP requires the plan sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. No uncertain positions have been identified that would require recognition of a liability (or asset) or disclosure in the financial statements as of August 31, 2024 and 2023.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RELATED-PARTY TRANSACTIONS

Certain plan investments are managed by a wholly-owned subsidiary of Vanguard. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Custodian and trustee fees paid by the Plan amounted to approximately \$164,000 and \$149,000 for the years ended August 31, 2024 and 2023, respectively.

NOTE 9 – SUBSEQUENT EVENT

The Plan has evaluated subsequent events for the period from August 31, 2024, through March 10, 2025, the date the financial statements were available to be issued and determined that there were no other subsequent events to disclose.
