### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the JRL Coal, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the JRL Coal, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete descriptions of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of JRL Coal, Inc. (the Company or Plan Sponsor). The Plan was amended and restated on January 1, 2022. The Plan provides eligible employees a means of regular and systematic savings with several investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company is the Plan sponsor and Apex Pension Strategies is the Plan recordkeeper (Recordkeeper). Assets of the Plan are held by Empower, trustee of the Plan (Trustee).

Eligibility

Employees are eligible to participate in the Plan upon completing one hour of employment. Employees are eligible to enter the plan and receive employer contributions on the first day of the quarter following the eligibility date.

Contributions

Each year, participants may contribute pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Contributions are subject to certain Internal Revenue Service (IRS) limitations. For the year ended December 31, 2023, the maximum contribution allowed by an employee under 50 years of age is \$22,500. For an employee at or over 50 years of age, the maximum contribution allowed is \$30,000. Roth contributions are also permitted by the Plan.

The Company will make matching contributions at an amount equal to the sum of 100% of the first 3% and 50% of the next 2% of eligible compensation that a participant contributes to the Plan, without exceeding 5% of the participant's Plan compensation. Additionally, the Company may make a discretionary profit sharing contribution. Employees are eligible for Company discretionary contributions if the employee is employed on the last day of the plan year and has at least 1,000 hours of service during the Plan year. The matching Company contribution is invested as directed by the participant.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution, employer matching contributions, any employer discretionary profit sharing contributions and allocation of Plan earnings (losses) reduced by administrative expenses which are allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Each participant is 100% vested at all times in his or her salary reduction contributions, employer-matching contributions, and the employer profit-sharing contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of the vested portion of their account balance. Individual loans are secured by the balance in the participant's account and bear interest at a fixed rate with consideration to rates on similar commercial loans, as of December 31, 2023. Principal and interest may be paid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, if the vested account is \$1,000 or less, the vested account will be paid in a lump-sum. Such distributions for account balances \$1,000 or less need not be approved for distribution by the participant. The Plan allows participants to acquire a hardship withdrawal to satisfy an immediate and heavy financial need. Participants may withdraw funds in case of a hardship distribution from their elective deferrals. In addition, the Plan allows in-service withdrawals for participants, upon attainment of age 59 ½, of all vested account balances.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions which affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Administrative expenses of the Plan are the responsibility of the Plan, but may be paid by the Company. These expenses include, but are not limited to, legal, accounting and recordkeeping fees, and investment expenses. For administrative expenses not paid by the Company, a proportionate share of the expenses paid by the Plan is charged to each participant's account. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Agreement. As of December 31, 2023, outstanding notes receivable from participants hold interest rates ranging from 4.25% to 9.50% and have maturity dates ranging from 2024 to 2028.

Payment of Benefits

Benefits are recorded when paid.

**NOTE 3 – CERTIFIED INVESTMENT INFORMATION**

Certain information related to investments from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments from participants and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest, and dividends, for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower (previously known as Massachusetts Mutual Life Insurance Company), the Trustee of the Plan. This information has not been audited by the Plan's independent auditors.

**NOTE 4 – FAIR VALUE MEASUREMENT**

The Plan utilizes Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*. ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have highest priority, Level 2 inputs consist of quoted prices for similar assets or identical assets that are not active, and Level 3 inputs are unobservable and have lowest priority. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include: a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices which are observable for the asset or liability; and d) inputs derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input which is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2023 and 2022:

*Mutual Funds:* Shares held in mutual funds are listed on national security exchanges and are valued at quoted market prices which represent the net asset value (NAV) held by the Plan at year-end. It is not probable the shares of registered investment companies will be sold at amounts which differ materially from the NAV of shares held, therefore, mutual funds are classified as Level 1 Investments.

**NOTE 5 – TAX STATUS**

The Plan sponsor adopted a simplified ERISA volume submitter 401(k) Plan which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan’s qualified status.

**NOTE 6 – PARTY-IN-INTEREST**

The Plan pays certain administrative fees to the Recordkeeper. These fees are considered exempt party-in-interest transactions. Other administrative expenses of the Plan are paid by the Plan sponsor; therefore, those expenses are not reflected in these statements.

Certain Plan investments are managed by the Trustee, and therefore, transactions involving the Trustee’s funds qualify as exempt party-in-interest transactions. Additionally, notes receivable from participants are defined by ERISA as party-in-interest.


