Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the NET100 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of March 1, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through March 1, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to the Financial Statements

1. Description of the Plan

The following description of the NET100 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan established July 1, 1995, pursuant to the provisions of section 401(k) of the Internal Revenue Code (IRC) covering all employees of NET100, Ltd. (the Company or the Plan Sponsor). The plan was most recently restated effective May 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act, as amended (ERISA).

On September 11, 2023, Net100, Ltd., the Plan Sponsor, was acquired by Kane Infrastructure Services Holdings, LLC. Effective March 1, 2024, the Plan merged into the Kane 401(k) Profit Sharing Plan (the Kane Plan). The net assets of the Plan totaling \$7,676,781, including notes receivable from participants totaling \$257,415, were transferred. Eligible Net100, Ltd. employees were able to begin contributing to the Kane Plan effective January 1, 2024.

Administration of the Plan

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company (on behalf of Principal Global Investors Trust Company) (collectively, Principal) were the trustee, custodian and recordkeeper of the Plan. The administrator of the Plan was the Company. Principal Life Insurance Company was the issuer of the insurance products. Principal held all assets of the Plan in accordance with the provisions of the service provider contract with the Company. The Kane Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees of the Company who were at least 19 years of age were considered eligible for participation. Eligible participants were able to enter the Plan one month after their hire date.

Contributions

Effective January 1, 2024, employees became eligible to contribute to the Kane Plan. As such, no additional contributions or allocations were made to the Plan during the period from January 1, 2024 through March 1, 2024, and no additional participants were admitted to the Plan.

Participant accounts

Prior to January 1, 2024, each participant's account was credited with the participant's contribution, including amounts rolled over from other qualified plans, and allocations of the Company's matching contributions, if any, and Plan earnings, less any charges, if applicable. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Notes to the Financial Statements

Vesting

Participants were immediately vested in their voluntary contributions and rollover contributions, plus actual earnings thereon. Vesting in the employer contributions was based on years of continuous service. Participants vested ratably over six years of credited service, beginning with the second year of credited service or in the event of death or total and permanent disability.

Notes receivable from participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000, reduced by the highest outstanding balance of any prior loans from the Plan during the prior one-year period, or (ii) the greater of 50% of their vested account balance or \$50,000, reduced by any outstanding loan balance on the date the new loan was made. The notes were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates as determined by the Plan Administrator at the time the loans were made. Principal and interest were paid ratably through monthly payroll deductions. Each participant could not have more than 2 loans outstanding at any time. These loans were subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

2. Summary of Significant Accounting Policies

Basis of accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimated amounts.

Investment valuation and income recognition

As of December 31, 2023, the Plan's investments are reported at fair value. There were no assets at fair value as of March 1, 2024, as a result of the Plan's merger with the Kane 401(k) Profit Sharing Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Kane Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and insurance company. See Note 4 for additional information related to fair value measurements.

The Plan's shares of mutual funds were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds were required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds previously held by the Plan were deemed to be actively traded.

Notes to the Financial Statements

The investment in the collective trust was valued at the NAV of units of the collective trust fund. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient was not used when it was determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) could occur daily. As the Plan merged effective March 1, 2024, and the Plan initiated a full redemption of the collective trust, the investment advisor observed the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations would be carried out in an orderly business manner. The redemption has a 12-month notice period. The investment was a direct filing entity and there were no unfunded commitments.

Pooled separate accounts were valued based on the publicly quoted pricing input which was used in determining the net asset value of the pooled separate account, which was not publicly quoted. The value of each pooled separate account was determined at the close of each business day based on fair value of the underlying assets, which consisted of a single mutual fund or multiple securities. The NAV, was provided by the issuer, and was used as the practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. These investments were direct filing entities and there were no unfunded commitments.

The Plan's investment in the Principal Pension Builder, a fixed-annuity guaranteed investment contract, was not fully benefit-responsive and was reported at fair value. Fair value was determined using a discounted cash flow model. This investment option allowed participants to purchase deferred income annuities. These assets could still be transferred in the future to other investment options within the plan or surrendered and thus were considered unallocated assets from the perspective of the plan. These annuities could not be sold, transferred, or assigned externally. The fixed annuity contract was subject to certain restrictions.

The preceding methods described above could produce a fair value calculation which might not have been indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

Purchases and sales of securities are generally recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions receivable

As of December 31, 2023, participant contributions and any related discretionary employer matching contributions were recognized in the period during which the Company made the respective payroll deduction from the participant's compensation.

Notes receivable from participants

As of December 31, 2023, notes receivable from participants were measured at the unpaid principal balance plus any accrued but unpaid interest. There were no notes receivable from participants as of March 1, 2024, as a result of the merger with the Kane Plan. If a participant ceased to make loan repayments and the Plan Administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Benefit payments

Benefits were recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to participant-initiated transactions were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation in fair value of investments.

3. Certified Investment information

Certain information disclosed in the accompanying financial statements related to investments held at March 1, 2024 and December 31, 2023, and net appreciation in fair value of investments, and interest and dividends for the period from January 1, 2024 through March 1, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

Notes receivable from participants in the amount of \$0 and \$284,936, as of March 1, 2024 and December 31, 2023, respectively, and the related interest income from notes receivable from participants totaling \$1,752 for the period from January 1, 2024 through March 1, 2024, are not certified.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at March 1, 2024 or December 31, 2023.

There were no assets at fair value at March 1, 2024, as a result of the Plan's merger with the Kane Plan.

5. Related Party Transactions and Party-In-Interest Transactions

Certain Plan investments were in funds and accounts that were managed by Principal or their subsidiaries and affiliates. Participant loan and distribution processing fees were paid to Principal by participants. The Plan also issued loans to participants which were secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to Principal. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Income Tax Status

Effective May 1, 2022, the Plan adopted the Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) established by Principal. The IRS ruled on June 30, 2020, that the Pre-Approved Plan, including related amendments, as designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes the Plan is currently designed and is being operated in accordance with the IRC.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Prohibited Transactions

During the year ended December 31, 2019, the Company failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) from its assets within the required time period as specified by the United States Department of Labor (DOL) Reg. 2510.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Company remitted these contributions to the Plan shortly after the required time frame. The Company has fully corrected these late remittances by remitting lost earnings in December 2024.

8. Risks and Uncertainties

The Plan held various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

9. Subsequent Events

The Plan Administrator has evaluated subsequent events through February 20, 2025, the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
